That in compliance of the above mentioned letter, the Hon'ble Peshawar High Court, Peshawar vide No. 6454-206/Admin: letter bearing 23/04/2020 addressed to all District & Session Civil Judges/Senior Judges of Khyber Pakhtunkhwa to take disciplinary action against those Govt. servants himself or through spouse received Income Support from BISP. (Copy of dated 23/04/2020 is attached Annexure-A)
- 4. That in compliance of the same, a show cause notice was issued on 13/05/2020 to the appellant which was commented/replied by the appellant. (Copy of show cause notice and reply are attached as Annexure-B)
- 5. That the respondent No.1/competent authority after hearing the appellant and without conducting inquiry passed the impugned order dated 16/07/2020 against the against the appellant which are as under:
 - i. "HE HAS AWARDED PENALTY OF
 WITHHOLDING INCREMENTS FOR
 THREE YEARS WITH NON-

ACCUMULATIVE EFFECT UNDER RULE (4)(1)(A)(II) OF THE IBID RULES"

ii. "RECOVERY OF RS. 1,15,874/- BE MADE
FROM APPELLANT AND BE DEPOSITED
IN GOVERNMENT TREASURY UNDER
RULE 4(1)(A)(III) OF THE IBID RULES"

With reference to show cause notice No. 342-43/ Respected Sir, SCJ/AlQ(SH) dated 13.05.2020 served to me with the allegations that my spouse was beneficiary of Benazir Income Support Program. My reply to the show cause notice is as under:-

That in the year 2010, a survey team of BISP visited our village and asked the women folk of our village for their CNICs by saying that government through BISP program is paying income support to women of the rural areas throughout Pakistan. On this like other women of the village, my wife may have given them her own CNIC. At that time I was not present at home.

That we never applied BISP for income support in fact they themselves enrolled my wife in BISP.

That neither I nor my wife was in knowledge that government employees and their families are not eligible for BISP grant, nor the BISP ever asked about this fact and nor there was anything in black in white in the shape of clear policy or rules in this




d. In fact this condition was implicated in the cabinet meeting held December 2019 and 0.8 million people including government olowees were excluded from BISP. Before this no such conditions were implicated and there is no such policy or rule that government servants or their families were not entitled. While at the time of survey in 2010, BISP had fixed a ratio of poverty in which the people who came in score of 16-17 or less were included in their program and at that time, there were no prohibitions for government employees and the score was fixed on social poverty status. But now the government changed its policy and government employees who came under score of poverty during the survey could not be plamed for misconduct etc. Besides this, no government employee can hide his personal information or data from any other government department because his personal information or data can easily be accessed from NADRA and this fact is evident from the act taken by government by getting personal information of people and removing them from BISP.

That according to report of BISP, each and every record was processed through a highly transparent mechanism by
