APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 READ WITH ALL ENABLING LAWS & RULES AGAINST THE IMPUGNED TRANSFER ORDER DATED 26/05/2023 WHEREBY THE APPELLANT HAS PRE-MATURE BEEN TRANSFER FROM HQ DIR TO MULKHOW/TOKHOW AND AGAINST APPELLATE ORDER DATED 31/05/2023 WHEREBY THE DEPARTMENTAL APPEAL DATED 26/05/2023 OF THE APPELLANT ON NO GOOD GROUND.

#### PRAYER:

That on acceptance of this appeal the impugned transfer order dated 26-05-2023 & appellate order dated 31-05-2023 may very kindly be set aside to the extent of the appellant and the appellant be retained as Tehsildar at HQ Dir to complete his normal tenure on the post. Any other remedy which this August Tribunal deems fit that may also be awarded in favor of the appellant.

Respectfully Sheweth:,

#### FACTS:

Brief facts giving raise to the instant appeal are as under:

- 1. That appellant is a regular employee of the respondent Department and is performing his duty as a regular Tehsildar at Malakand Division quite efficiently whole heartedly and as such the appellant has an unblemished service record of approximately 18 Years.
- 2. That the appellant while waiting for posting as Tehildar transfer & posted as Tehsildar Dir HQ Dir Upper vide Respondent No. 1 order dated 24-03-2023. The appellant took over the charge of the post at HQ Dir Upper 02/04/2023 and started performing duties in Dir Upper.

3. That the appellant performed duty at HQ Dir Upper for just 54 days that the appellant was pre-maturely been transferred from Hard area of Dir Upper to another hard area of Mulkhow/Torkhow Upper Chitral vide the impugned premature transfer order dated 26-05-2023 without any cogent or plausible reason.

Copy of Impugned Order dated 26.05:2023 is attached as **Annexure** ... **B.** 

4. That feeling aggrieved from the impugned pre-mature transfer order dated 26-05-2023 the appellant preferred Departmental Appeal dated 26-05-2023 before the Respondent no. 1, but the same was regretted on no good ground vide order dated 31-05-2023.

5. That the appellant feeling highly aggrieved and is left with no other remedy but to file the instant service appeal before this Tribunal on the following grounds:

#### **GROUNDS:**

- A-That the impugned pre-mature transfer order dated 26-05-2023 & appellate order dated 31-05-2023 passed by the respondents against the appellant is against the law, rules, facts, void ab initio, Norms of Natural Justice and materials available on the recordhencenot tenable in the eye of Law and is liable to be set aside to the extent of the appellant.
- **B-** That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above

and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

C-That as per various judgments passed by the Superior Courts as "that when the ordinary tenure posting and transfer has been specified in the Law or Rules made thereunder, such tenure must be respected and cannot be varied except for compelling reasons, which should be recorded in writing and are judicially reviewable".

And in the instant case the respondent has completely ignore such aspect and issued the impugned pre-mature transfer order dated 26-05-2023.

- D- That the respondents acted in an arbitrary and malafide manner by issuing the impugned pre-mature transfer order dated 26-05-2023 & appellate order dated 31-05-2023.
- **E-** That the impugned pre-mature transfer order dated 26-05-2023 & appellate order dated 31-05-2023 passed by the respondents is against Article 38 (e) of the Constitution of Pakistan, 1973 which is as:

"state is bound to reduce disparity in the income and earning of the individuals including persons in the various services of Pakistan.

- **F-** That the impugned pre-mature transfer order dated 26-05-2023 & appellate order dated 31-05-2023 passed by the respondents is a clear violation of Article-37 of the Constitution of Islamic Republic of Pakistan which is regarding the eradication of social evils in the society and promotion of social justice.
- G-That the impugned pre-mature transfer order dated 26-05-2023 & appellate order dated 31-05-2023 passed by the respondents is a clear violation of the Fundamental Rights as enshrines the Constitution of Pakistan&also against various judgments passed by the Apex Supreme Court of Pakistan.
- H-That appellant has been transfer from one place to another in such a short span of about 54 days vide the impugned premature transfer order dated 26-05-2023 & appellate order dated 31-05-2023 and hence the same is against the norm of Natural Justice.
- I- That act & omission on the part of the respondents while issuing the impugned pre-mature transfer order dated 26-05-2023 & appellate order dated 31-05-2023 is against Clause-IV of the Posting and Transfer Policy of the Provincial Government.

- J- That such pre-mature transfer is nothing but just to harass the appellant on one way or the other and to accommodate their blue eyed person.
- **K-** That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

# GOVERNMENT OF NWFP ESTABLISHMENT & ADMINISTRATION DEPARTMENT (Regulation Wing)

### POSTING / TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT.

- All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
- vi) While making postings/transfer from settled areas to FATA and vice-versa, specific approval of Governor, NWFP needs to be obtained
  - <sup>2</sup>While making postings/transfers of officers/officials up to BS-17, from settled areas to FATA and vice-versa approval of the Chief Secretary NWFP needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor NWFP shall be obtained.
- vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for atleast eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.
- officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and DPOs/Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thanna) of his area/residence is situated.
- viii) No posting/transfers of the officer's/officials on detailment basis shall be made...
- ix). Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public
- x) All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.

Para-1(v) regarding months of March and July for posting/transfer and authorities for relaxation of ban deleted vide letter No. SOR-VI (E&AD) 1-4/2008/Vol-VI, dated 3-6-2008.

Consequently authorities competent under the NWFP Government Rules of Business, 1985, District Government Rules of Business 2001, Posting/Transfer Policy and other rules for the time being in force, allowed to make posting/transfer subject to observance of the policy and rules.

Added vide Urdu circular letter No. SOR-VIEWARD 1999









xi) Officers/officials except DCOs and DPOs/SPs who are due to retire within one year may be posted on their option on posts in the Districts of their domicile and be allowed to serve there till the retirement

DCOs and DPOs who are due to retire in the near future may also be posted in the District of their domicile subject to the condition that such posting would be against non-administrative posts of equivalent scales;

xii) In terms of Rule-17(1) and (2) read with Schedule-III of the NWFP Government Rules of Business 1985, transfer of officers shown in column 1 of the following table shall be made by the authorities shown against each officer in column2 thereof.




- While considering posting/transfer proposals all the concerned authorities shall keep in mind the following:
  - To ensure the posting of proper persons on proper posts, the Performance Evaluation Report/annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned off CONSTRUCTION OF CONSTRU
    - b) Tenure on present post shall also be taken into consideration and the posting transfers shall be in the best public interest.

- Government servants including District Govi, employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.
  - i) Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.
  - ii) Serious and grave personal (humanitarian) grounds.
- 2. To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under:-

- 3. As per Rule 25(2) of the Rules mentioned above the District Coordination Department shall consult the Government if it is proposed to:
  - a) Transfer the holder of a tenure post before the completion of his tenure or extend the period of his tenure.
  - b) Require an officer to hold charge of more than one post for a period exceeding two months.

4. I am further directed to request that the above noted policy may be strictly observed /implemented.

All concerned are requested to ensure that tenures of the concerned officers/officials are invariably mentioned in summaries submitted to the Competent Authorities for Posting/Transfer.
