APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 IMPUGNED ACTION OF THE RESPONDENTS OF NOT PROMOTING THE APPELLANT FROM THE RANK OF INSPECTOR (BPS-16) TO THE RANK OF DEPUTY SUPERINTENDENT OF POLICE BPS-17 AND AGAINST THE REJECTION ORDER DATED 08.05.2023, WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT FOR PROMOTION TO THE RANK OF DEPUTY SUPERINTENDENT OF POLICE (BPS-17) HAS BEEN REJECTED FOR NO GOOD GROUNDS.

PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL, THE REJECTION ORDER DATED 08.05.2023 MAY KINDLY BE SET ASIDE AND RESPONDENTS MAY KINDLY BE FURTHER DIRECTED TO CONSIDER THE APPELLANT FOR NOTIONAL PROMOTION TO THE RANK OF

DEPUTY SUPERINTENDENT OF POLICE (BPS-17)
FROM THE DATE OF HIS RETIREMENT WITH ALL
BACK BENEFITS. ANY OTHER REMEDY, WHICH THIS
AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE
THAT, MAY ALSO, BE AWARDED IN FAVOUR OF
APPELLANT.

**RESPECTFULLY SHEWTH:
FACTS:**

1. That the appellant joined the police department in the year 1981 as Constable and since his appointed the appellant has performed his duty with devotion and honesty, whatsoever assigned to him and no complaint has been filed regarding his performance by his superiors.
2. That with passage of time the appellant was promoted to the rank of ASI in the year 2005, SI in the year 2008 and Inspector in the year 2014 after completing mandatory course/training and excellent performance.
3. That the appellant was at Sr. No. 13 of the seniority list of Inspector (BPS-16) issued on 02.09.2022 and many posts of DSP were vacant in the respondent department and in this respect Additional Inspector General of Police Hqrs: Khyber Pakhtunkhwa Peshawar through a memo dated 31.08.2022 intimated to respondent No.2 and all RPOs Khyber Pakhtunkhwa to provide information regarding promotion of Inspector to the rank of DSP on the prescribed proforma within a week time positively which was forwarded by respondent No.2 to respondent No.3 and in response of that memo dated 31.08.2022, the respondent No.3 provide information of the appellant along with other inspectors on the given format to the respondent No.2 through letter dated 05.09.2022. (Copies of seniority list, memo dated 31.08.2022, 05.09.2022 and proforma/format are attached as Annexure-A,B,C&D)
4. That as the information of the appellant along with other officials regarding promotion of Inspectors to the rank of DSP was provided to responded No.2 and the appellant would also be retired on 14.11.2022 on attaining the age of superannuation, therefore, he filed an application to respondent No.2 to promote him to the rank of DSP on regular before his retirement as many posts of DSP are vacant and he is most senior inspector in the department and all eligible for promotion to the rank of DSP in all aspects which was further forwarded to the Assistant Inspector General of Police, Establishment, Khyber Pakhtunkhwa Peshawar for consideration for promotion of the appellant to the rank of DSP (BPS-17) on regular

through letter dated 12.10.2022. (Copies of application and letter dated 12.10.2022 are attached as Annexure-E&F)

5. That the appellant was senior most Inspector in the department and also eligible for promotion to the post of DSP (BPS-17) in all aspects, but the respondent department did not conduct the DPC in time and in meanwhile the appellant was retired from service w.e.f 14.11.2022 on attaining the age of superannuation vide order dated 24.11.2022 and just after 24 days of the retirement of the appellant, the respondent department conducted DPC on 08.12.2022, where juniors to the appellant were promoted to the rank of DSP (BPS-17) vide notification dated 01.03.2023. (Copies of order dated 24.11.2022 and notification dated 01.03.2023 are attached as Annexure-G&H)
6. That as many posts of DSP (BPS-17) were vacant and the appellant was senior most inspector in the department and also eligible for promotion to the post of DSP (BPS-17) in all aspects and his information regarding promotion of Inspector to the rank of DSP was also provided to concerned authorities, but the respondent department did not conduct the DPC in time and in meanwhile the appellant was retired from service on attaining the age of superannuation on 14.11.2022, due to which he was deprived from his legal right of promotion to the rank of DSP, therefore, he filed departmental appeal on 28.03.2023 for promotion to the rank of DSP (BPS-17), which was rejected on 08.05.2023 for no good ground. (Copies of departmental appeal and rejection order dated 08.05.2023 are attached as Annexure-I&J)
7. That the appellant has no other remedy except to file the instant appeal in this Honorable Tribunal for redressal of his grievance on the following grounds amongst others.

GROUND:

- A) That rejection order dated 08.05.2023 and not promoting the appellant to the rank of DSP (BPS-17) by not conducting the DPC in time by the department are against the law, rules, fact, norms of justice and material on record, therefore, not tenable and the order dated 08.05.2023 is liable to be set aside and the appellant is entitled to be promoted to the rank of DSP (BPS-17) on notional basis from the date of his retirement.
- B) That many posts of DSP (BPS-17) were vacant and appellant was senior most inspector (BPS-16) and was eligible for promotion to the rank of DSP in all aspects and his information regarding promotion of

Inspector to the rank of DSP was also provided to concerned authorities two months before his retirement, but due to the lethargy of the department of not conducting DPC in time the appellant was retired from service on attaining the age of superannuation on 14.11.2022 just after 24 days before conducting DPC on 08.12.2022 in which juniors to the appellant were promoted to the rank of DSP on 01.03.2023, which shows that the appellant was deprived from his legal right of promotion to the rank of DSP (BPS-17) for the lethargy of the department of not conducting DPC in time.

- C) That the appellant was at Sr. No. 13 of the seniority list of Inspector (BPS-16) and many posts of DSP were vacant and in this respect Additional Inspector General of Police Hqrs: Khyber Pakhtunkhwa Peshawar through a memo dated 31.08.2022 intimated to respondent No.2 and all RPOs Khyber Pakhtunkhwa to provide information regarding promotion of Inspector to the rank of DSP within a week time positively which was forwarded by respondent No.2 to respondent No.3 and in response of that memo dated 31.08.2022, the respondent No.3 provide information of the appellant along with other inspectors to the respondent No.2 through letter dated 05.09.2022 two months before the retirement of the appellant, but the respondent department did not conduct DPC in time and in meanwhile the appellant was retired from service on 14.11.2022 just 24 days before conducting DPC on 08.12.2022 in which his junior were promoted to the rank of DSPs (BPS-17) on 03.01.2023 and the appellant was deprived from promotion to the rank of DSP for the fault of the respondent department of not conducting DPC in time and as such the appellant is entitle for notional promotion to rank of DSP (BPS-17) from the date of his retirement as the appellant has retired from service on attaining the age of superannuation on 14.11.2022.
- D) That the appellant was at Sr. No. 13 of the seniority list of Inspector and was also eligible for promotion the rank of DSP and posts of DSP were also available, therefore depriving the appellant from his legal right of promotion before his retirement shows arbitrariness on the part of the respondents.
- E) That the case of the appellant is also covered by Supreme Court judgments and the appellant being similarly placed person also entitle for the same relief under the principle of consistency.
- F) That the appellant has legitimate expectancy of promotion to the rank of DSP and not promoting him due to not conducting DPC in time is the violation of principle of legitimate expectancy.
- G) That depriving the appellant from his legal right of promotion to the rank of DSP will cause irreparable loss to the appellant in the shape of pension and other monetary benefits for no fault on his part.

- H) That the appellant has not treated in accordance with law and rules and has been deprived from his legal right of promotion to the rank of DSP (BPS-17) for the fault of the department of not conducting DPC in time.
- 1) That the appellant seeks permission of this Honorable Tribunal to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.



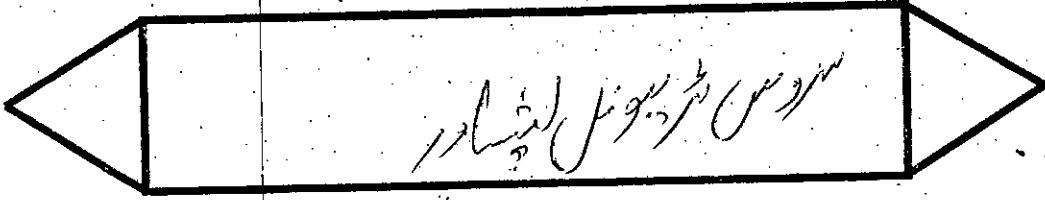
