FACTS:-

1. That appellant is serving in police department as
DSP/DFU Abbottabad, CTD, Hazara region.

2. That the appellant was promoted as Inspector on 19/07/2007 vide notification no 16568. **(Copy of the Notification is Annexed as annexure "A")**
3. That the appellant was confirmed as Inspector vide notification no 4178 dated 11/02/2014 along with his other colleagues with effect from 28/01/2010. **(Copy of the Notification is annexed as Annexure "B")**
4. That the respondent no 5 issued impugned seniority list of DSsP (BPS.17) of KPK, Police dated 19/03/2019, wherein the appellant has been placed at serial number 82 instead of serial number 45 along with his colleagues as per notification dated 11/02/2014. **(Copy of the Seniority List is annexed as Annexure "C")**
5. That, the appellant feeling aggrieved filed departmental appeal before the respondent number 2 with the prayer that appellant be placed at serial No. 45 of the seniority list as name of the appellant is wrongly placed at serial No. 82. **(Copy of the appeal is annexed as Annexure "D")**
6. That the respondent No. 3 on behalf of respondent No. 2 turned down the appeal filed by appellant vide order dated 21/10/2019. **(Copy of the**

Impugned Order NO.E-I/CPO/1232 Dated 21/10/2019 is annexed As Annexure "E")

7. That, feeling aggrieved from the impugned Order NO.E-I/CPO/1232 DATED 21/10/2019 the appellant approaches this honorable tribunal for redressal of his grievances inter alia on the following grounds.

GROUND:-

- a. That the Impugned Order/Notification of respondent No.2 is against the law, perverse, discriminatory and the seniority list dated 19/03/2019 is liable to be rectified after placing name of the appellant at serial No.45 instead of at serial No.82. The said seniority list is to be issued keeping in view the notification dated 11/02/2014.
- b. That, as may be seen, the conformation of the appellant on the post of DSP was given effect from 28/01/2010, and therefore the respondent authority fell in grave error in not calculating the stated length of seven years of unblemished and meritorious service of the appellant and thus justified his relegation from Serial No.45 of the Seniority List to a much, much lower position creating a precise difference of 37 members, which

indeed is an irreparable loss to the appellant most specially when his remaining length of service is kept in view. The appellant shall suffer tremendously and unjustly due to the irrational and illegal order impugned herein.

- c. That, impugned order is against the law and facts hence, liable to be set-aside.
- d. That the Impugned order dated 21/10/2019 is illegal, void ab-initio having no legal effects hence, liable to be set aside.
- e. That the petitioner is duly qualified as per his actual due seniority as well as professional skills to have been placed at serial number 45 of the seniority list and to be promoted along with other colleagues from the date of his confirmation i.e. 28/01/2010.
- f. That, while placing the name of appellant at serial number 82, the respondent no 4 ignored the effect of notification dated 11/02/2014 which is gross negligence on the part of said respondent and violation of fundamental right of the appellant.
- g. That, other grounds shall be agitated during the course of arguments with the kind permission of this Honorable Court.

PRAYER:- ON ACCEPTANCE OF THE INSTANT APPEAL, IMPUGNED REJECTION ORDER NO.E-I/CPO/1232 DATED 21/10/2019 ISSUED BY RESPONDENT NO.3, MAY GRACIOUSLY BE DECLARED NULL AND VOID AND RESPONDENTS MAY BE DIRECTED TO PLACE THE NAME OF THE APPELLANT AT SERIAL NO 45 INSTEAD OF AT SERIAL NO 82 IN SENIORITY LIST DATED 19/03/2019 IN THE LIGHT OF NOTIFICATION NO 4178 DATED 11/02/2014 ISSUED BY RESPONDENT NO 4.
