JOINT PARAWISE COMMENTS ON BEHALF OF RESPONDENTS No: 1,3 & 4.

Respectfully Sheweth:-

The Respondents submit as under: -

Preliminary Objections.

- 1 That the Appellant has got no cause of action/locus standi to file the titled appeal against the Respondent Department.
- 2 That the instant appeal is badly time barred.
- 3 That the appellant has concealed the following material facts from this Honorable Court in the titled appeal deliberately and intentionally on mala-fide basis:
 - A. First, the appellant got appointed as ADO BS-16 (re-designated as ADEO/ASDEO) on the recommendation of KPPSC, whereas, he has shown himself appointed as SDEO (BS-17) on the recommendation of KPPSC. (Copy of Notification dated 05-05-2011 is attached as Annx-A)
 - B. Second, the appellant got promoted to the next higher post/SDEO (BS-17) vide Notification dated 26-09-2018 on the basis of inter se-seniority of ADO BS-16 (re-designated as ADEO/ASDEO). issued by the KPPSC. (Copy of Notification Dated 26-09-2018 is attached as Annx-B)
 - C. Third, the appellant has shown himself as a permanent resident of Suit No.2 Al Haj Tower Khyber Super Market Peshawar on mala fide intention & has thus found guilty of concealment of martial facts regarding his original District of residence of District Karak.
- 4 That the instant Appeal is based on mala-fide intentions for gaining illegal & even unlawful service benefits against the SDEO (M) (BS-17) Management Cadre in violation of the prescribed Rules & policy.

- 5 That the appellant is not entitled for the relief he has sought through the instant appeal under the regulation of 29 (K) of the Khyber Pakhtunkhwa Public Service Commission regulations 2003 in violation of the already established legal & constitutional right of the Respondent No. 5 to 26 in terms of Section-8 of Civil Servants Act 1973.

ON FACTS.

- 1 Para-1 pertains to the appointment of appellant as the PST (BPS-7) in the Respondent Department, hence needs no comments.
- 2 Para-2 is incorrect & denied on the martial ground that as per available record in the custody of the Respondent No.4 the appellant applied for the appointment against the ASDEO (BS-16) MC post under the prescribed criteria in pursuance to the advertisement No.05/2009 (at S.No. 07) floated by the KPPSC, whereas, the appellant has shown himself appointed as SDEO (BS-17) on the recommendation of KPPSC, hence, the appellant has concealed this material fact from this learned Tribunal intentionally and deliberately.
- 3 That Para-3 is also incorrect & mis-leading on the grounds that the appellant did not qualify for the post of SDEO (BS-17), rather he got appointed as Assistant District Officer/ADO BS-16 (re-designated as ADEO/ASDEO) in the Respondent Department on recommendation of KPPSC. Thereafter, the KPPSC forwarded the inter-se-seniority of ADOs BS-16 to the Department, whereupon, the Respondent No.4, being competent authority, issued the said seniority Assistant District Officer/ADO (BS-16) in term of Section-8 of Civil Servants Act 1973 read with Rule-17 of KP Civil Servants (APT) Rules, 1989 on the basis of his academic & professional qualification. However, it is imperative to mention here that appellant did not file any objection/grievances against the said seniority to the Department and availed the benefits of promotion to the post of SDEO (BS-17) vide Notification dated 26-09-2018 (falling at S.No.42) on the basis of the present/impugned inter-se-seniority. Moreover, the appellant has agitated a time barred issue pertaining to the award of two additional marks on account of his academic and professional qualification. If such kind of time barred issue is accepted, it would tantamount to opening a floodgate for all other similarly placed persons and would enhance the burden of future litigation for the Department as well as for this Honorable Tribunal.
- 4 *That* Para-4 is also incorrect & denied with the submission that the statement of the appellant is misleading to the extent of the recommendation through the KPPSC as SDEO (BS-17) rather he was recommended as Assistant District Officer/ADO BS-16 (re-designated as ADEO/ASDEO) by the KPPSC instead of SDEO (BS-17) in terms of the Notification dated 05-05-2011, hence, the claim of the appellant is baseless & liable to be rejected.

- 5 That Para-5 is incorrect as the act of the Department with regard to the Notification dated 19-08-2022 is within legal sphere & liable to be maintained as the appellant has been correctly placed in the final seniority list pertaining to the SDEOs in BS-17 in view of the formal structure relating to the management Cadre in the Department. Furthermore, no Departmental appeal against the final seniority list has been filed by the appellant to the appellate authority till date, hence, got finality under the law of land. (Copy of the Notification dated 19-8-2022 Annexure-C).
- 6 That Para-6 is also incorrect & denied as the appellant has been treated as per law & rules by the department with regard to his merit position in the inter-se-seniority of ASDEOs (BS-16) as well as SDEOs (BS-17) of Management Cadre. Moreover, the merit/seniority in question was not impugned by the appellant prior to his promotion to the post of SDEO (BS-17) & now after availing/enjoying the benefits of promotion, he has impugned the said seniority before this Honorable court on mala-fide basis, hence, got finality under the law. Therefore, the appeal in hand is liable to be dismissed on the following grounds.

ON GROUNDS.

- A **Incorrect & not admitted.** The appellant has been treated as per law, rules & policy in terms of Section-8 of the Civil Servants Act, 1973 read with Rules-17 of the Khyber Pakhtunkhwa (APT) Rules, 1989 by the Department & is not entitled for the grant of additional marks as prayed by the appellant in the heading of the titled case, hence, the stand of the appellant is baseless & liable to be rejected.
- B **Incorrect & not admitted.** The act of the Department is within legal sphere & even in accordance with the provisions of section-8 of Civil Servants Act-1973 read with Rules-17 of APT Rules of 1989 & even in compliance of Articles 4 & 25 of the constitution of 1973.
- C **Incorrect & not admitted.** The statement of the appellant is without any cogent reason & legal justification; hence, the stand of the appellant is baseless & liable to be rejected.
- D **Incorrect & not admitted.** The appellant has not been discriminated by the Department in the titled case with regard to the non-grant of additional marks on his M.A & M.Ed by the Respondent No.3, hence, the plea of the appellant is without justification & liable to be rejected in favor of the Department
- E **Incorrect & not admitted.** The act of the Department with regard to the final seniority list of SDEOs is in accordance with the provision of Article-38 (e) of the constitution of 1973.
- F **Incorrect & not admitted,** The act of the Department is within legal sphere & even in accordance with the provisions of section-8 of civil servants Act-1973 read with Rules-17 of APT Rules of 1989 & even in compliance of Articles 4 & 25 of the constitution of 1973.

- G Incorrect & not admitted. The act of the Department with regard to the final seniority list of SDEOs is in accordance with the provision of Article-38 (e) of the constitution of 1973.
- H Legal. However, the Respondents also seek leave of this Honorable Tribunal to submit additional grounds, record & case law at the time of arguments on the date fixed.


PRAYER:

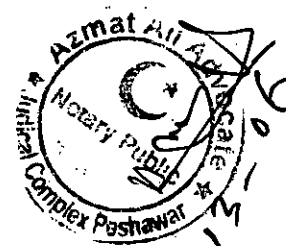


