APPEAL UNDER SECTION 4 OF THE **KHYBER** PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 READ WITH OTHER RELEVANT PROVISIONS AGAINST THE IMPUGNED ORDER DATED 03.06.2021 **ISSUED** RESPONDENT NO.2 ON BEHALF OF RESPONDENT NO.1, WHEREBY THE DEPARTMENTAL APPEAL/REPRESENTATION FILED BY THE APPELLANT DATED 16.02.2021 HAS BEEN REJECTED ILLEGALLY, UNLAWFULLY AND UNCONSTITUTIONALLY.



JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN: According to the memorandum and grounds of appeal, the appellant was serving as Assistant Grade Clerk in the office of District Police Officer, Dir Upper; that on 16.02.2021, respondent No.4 District Police Officer, Dir Upper communicated ACR for the period 20.08.2019 to 31.12.2019 with adverse remarks to the appellant vide letter No. 79-80/AS, dated appellant submitted 20.01.2021; date, the that the appeal/representation/application for expunging the adverse remarks to respondent No.1 through proper channel vide letter No. 1131/EC, dated 16.12.2021 issued by respondent No.4; that the same appeal/representation/application had been rejected vide order dated 03.06.2021 by respondent No.1, hence, the instant service appeal.

- 2. On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defence setup was a total denial of the claim of the appellant.
- 3. We have heard learned counsel for the appellant and learned Additional Advocate General for the respondents.
- 4. The Learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Additional Advocate General controverted the same by supporting the impugned order(s).
- 5. The record reflects that admittedly there is no adverse entry in the entire service record of the appellant except for this small period of just few months of the

year whereas the entries of the same year prior to the impugned entries were stated to be good. When in a year majority portion of the report is good this short period of adverse report will not be justified and that too without supporting material in the shape of advice, counseling, explanation or for that matter from any corner against the appellant regarding the allegation against him in presence of unblemished long service record of the appellant. Therefore, while allowing this appeal, we set aside the impugned order dated 03.06.2021 and the adverse remarks against the appellant for the period 20.08.2019 to 31.12.2019 is expunged. Costs shall follow the events. Consign.
