<u>Prayer</u>

That on acceptance of this Service Appeal the impugned clarification order FDSO (SR-II) 2-4 /2022/PENSION dated 21.07.2022 may kindly be modified/rectified to the extent that the increasement of 2011 of 15% and 2015 7.5% be excluded from the ceasement/merger and be awarded to the appellant who retired after dated 01.07.2022. Any other remedy which this august tribunal deems fit that may also be awarded in favor of the appellant.

Respectfully Sheweth:

ON FACTS

That the appellant was employ of E&SE Department and was retired on 04.04.2023 as Princiapl GSAS Government High School No. 1 Thana District Malakand vide order dated No. AO/E&SE/6-22/LPR/Malakand dated 04.04.2023 retirement order is attached as Annexure-A.

That the Government of KPK Finance Department 2issued a clarification order No. FDSO (SR-II) 2-4 /2022/PENSION dated 21.07.2022 whereby excessive ceasments/mergers of the adhoc relief in pension of 15% of 2011 and 7.5% of 2015 was made in sheer dis regard, violation and derogation of the Federal Government Finance Department clarification memorandum No. F.4 (1)/Registration.6/2022-486 dated 01.07.2022 Islamabad, the impugned order of the KPK Finance Department and Department Federal Government Finance the clarification memorandum are attached as Annexure-B and C.

That the Government of Punjab and Baluchistan followed the Federal Government and issued the same clarification orders which are attached as Annexure

D & E).

- That while the Government of Sindh increased the pension by 63.5% and made ceasements/mergers of all increasment from 2011 to 2021. (Copy of notification is attached as Annexure-

- That appellant approached the respondents through Departmental appeal for the modification/rectification of the KPK Government Finance Department order but still in vain. (Copy of Departmental Appeal is attached as Annexure- G).

6- That by the said clarification order of the Khyber Pakhtunkhwa Finance Department the pension of the appellant was reduced substantially.

7- That feeling aggrieved and having no other remedy the appellant filed the instant Service Appeal on the following grounds amongst the others:-

GROUNDS:

A) That the impugned clarification order of the KPK
Finance Department mention above to the extent of including ceasments/mergers of 15% of 2011 and 7.5% of the year 2015 is illegal, against the law, facts, hence not tenable and liable to be modified/rectified for excluding the above increasment of 2011 and 2015 from ceasments/mergers.

- **B**) -

That the impugned order regarding ceasments/mergers of all the increasments as clear violation of the Article 38 (e) are the Constitution and such violation of the 27 of Constitution which produced a sharp disparity That pension is a right acquired in consideration of past service guaranteed by constitution and law therefore under the law it is not a bounty or payable on the sweet well and pleasure of the Government and the right to receive it is a property, a vested right with legitimate expectation which could not be arbitrarily abridged and reduced.

That the Petitioner has not been treated in accordance with law and rules by the respondent on the subject noted above and as such respondent violated Article 4 and 25 of the Constitutional of Islamic Republic of Pakistan 1973.

That the appellant has been discriminated on the subject noted above and as such the respondent violated the principal of natural justice.

That the appellant seeks permission to advance other grounds improve at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may kindly be accepted and the partial impugned order of the KPK Finance Department may kindly be modified and rectified as prayed for.



GRANT OF INCREASE IN PENSION TO THE CIVIL PENSIONERS OF THE GOVERNMENT OF SINDH

The Government of Sindh has been pleased to sanction an increase until further orders to all civil pensioners of the Sindh Government at the following rates:

(a) @ 5% of pension to the existing civil pensioners who retired on or before 30.06.2022 with effect from 01.07.2022 and;

(b) @ 63.5% of net pension to pensioners who will retire on or after 01.07.2022, ceasing all previous increases in pension i.e., 2011, 2015, 2016, 2017, 2018, 2019, 2020 and 2021 with effect from 01.07.2022.

2. The previous eight (8) increased in pension i.e. 15% of 2011, 10% of 2015, 10% of 2016, 15% of 2017, 10% of 2018, 15% of 2019, 10% of 2020 and 10% of 2021 shall cease to exist for pensioners who will retire on or after 01^{st} July, 2022.

3. For the purpose of admissibility of increase in pension sanctioned in this Department's O.M. the term "Net Pension" means "Pension being drawn".

4. The increase will also be admissible on family pension granted under the Pension-com-Gratuity Scheme, 1954, Liberalized Pension Rules, 1977, on pension sanctioned under the Central Civil Services (Extra Ordinary Pension) Rules as well as on the Compassionate Aflowance under CSR-353.

5. If the gross pension sanctioned by the Sindh Government is shared with any Government in accordance with the rules laid down in Part-IV of Appendix III to the Accounts Code, Volume-1, the amount of the increase in pension will be apportioned between the Federal Government and the other Government concerned on proportionate basis.

6. The increase in pension sanctioned in this O.M. will not be admissible on Special Additional Pension allowed in lieu of pre-retirement orderly allowance.

7. The benefit of increase in pension sanctioned in this O.M. will also be admissible to those Civil Pensioners of the Sindh Government who are residing abroad (other than those residing in India and Bangladesh) who retired on or after 15.08.1947 and are not entitled to or are not in receipt of pension increase under the British Government's Pension (increase) Acts. The payment will be made at the applicable rate of exchange.

F/4(1)-Reg 6/2022-486 dated 01-07-2022, was made for the employees who will retired are after 01-07-2022.

That the Federal Government under the said office memorandum No. F.4(1)-Registration.6/2022-486 dated 01/07/2022 made casements/mergers of the Adhoc reliefs of 10% of 2016, 10% of 2017, 10% of 2018, 10% of 2019, & 10% of 2021 while sanctioned 15% increase for the employees who will retired on are after 01-07-2022.

The government of Punjab through its clarification Notification FDS/SRIII-4-160/2021 of Government of Punjab Finance dated 21-07-2022, the Federal following Department Government Office Memorandum No. 486 made ceasements / mergers of the Adhoc ceasements/mergers of 2016 to 2019 and 2021 and increased 15% of net pension for the employees to the retired on are after 01-07-2022, excluding 15% increase of 2011 respectively from 2015 increase 7.5 of and of casement/mergers.

The Government of Balochistan through its Notification No. FD(R-1)II-29/2022/856-976, Quetta. Dated 18-07-2022, also made ceasements and mergers of the Adhoc Relief from 2016 to 2021, and excluding 15% of 2011 and increasment of 7.5% of the year 2015 was excluded from ceasements/merger like Federal Government, however the Government of Sindh Office Memorandum No. FD(SR-III)3-230/2022 Karachi Dated 13-07-2022, made ceasements/ mergers of all Adhac Reliefs from 2011, 2015, and from 2016 to 2021, and give its employees more increasement/relief to its those employees who will retired on or after 01-07-2022. But astonishingly the Government of Khyber Pakhutnkhwa through its Notification No. FDSO(SR-

II)2-4/2022 dated Peshawar 21-07-2022, made ceasements/mergers of all the Adhac reliefs of 2011, from 2015 to 2021, while increasing 15% pension of its employees who will retired on 01-07-2022 by including the Adhac reliefs 15% of 2011 and 7.5 2015 excessively and in sheer violation of the Federal Government Office Memorandum No. 486 dated 01/07/2022 Notification No. 486 of the Federal Government. (All notifications are attached).

This Action and inaction of Govt of Khyber Pakhtunkhwa is illegal and against the law rules, facts and constitution and therefore infective upon the rights of the appellant and not tenable and liable to be corrected/rectified by excluding ceasments/mergers of the adhac reliefs of 2011 and 2015.

This Notification of the Govt of Khyber Pakhtunkhwa is not tenable in law and liable to be corrected / rectified according to the Federal Government Notification No. 486, dated 01-07-2022.

It is therefore kindly submitted that the above mention correction/rectification be made in the Clarification Notification of the Government of KP.
