Subject: **PROGRESS REPORT IN COMPLIANCE OF JUDGMENT**  
**08.07.2021**

The facts pertaining to compliance report are as under:-

1. That, the appellant had filed Service Appeal No. 1458/2018, with the following prayers:-

*"On acceptance of instant appeal, the appellant may kindly be confirmed as Sub Inspector w.e.f 10.10.2012 i.e. from the date when his colleagues/ junior to him were confirmed as Sub Inspector with due seniority in list 'F' with all back benefits".*

2. That, this Hon'ble Tribunal vide Judgment dated 08.07.2021 accepted the Service Appeal. The operating Para is reproduced as under:-


*"In view of the foregoing discussion, we are of the considered opinion that case of the appellant is similar in nature with the cases already decided by this Tribunal as well as by the apex court, as referred to by counsel of the appellant. For the reasons, we are inclined to accept the present appeal with directions to the respondents to confirm the appellant as SI from the date when his other colleagues were confirmed, as well as place him in due place in the seniority list. The appellant is also entitled to all consequential benefits, if any".*

3. That, CCP, Peshawar revised his SI confirmation vide Order No. 6222-25/EC-I, dated 28.03.2022 w.e.f 01.01.2012.
4. That, similarly seniority at CPO Level has also been revised w.e.f his date of his SI Confirmation i.e. 01.01.2012 vide Notification No. 307/E-II/Seniority, dated 02.09.2022.
5. That, the appellant was deficient of period in terms of 13.16A of Amended Police Rules, 2017 due to which his further promotion and placement with colleagues is due.
6. That, the appellant has been sent to Advance Course to fulfill the above deficiency in order to promote and place him with batch mates in next DPC.

7. That, the seniority list dated 29.03.2023 has been stayed by the Hon'ble High Court in Writ Petition No. 1092-P/ 2023 & 1093-P/ 2023 vide Order dated 04.04.2023.

PRAYERS

Therefore, keeping in view the above facts and circumstances, Department is determined to comply with Hon'ble Tribunal orders in true letter and spirit. The seniority of appellant has partially been revised whereas further promotion and placement with batchmates is due. For the time being DSP Seniority list has been stayed while appellant is undergoing his Advance Course therefore, the appellant shall be considered to the rank of DSsP on his turn. The respondent department may kindly be given sufficient time for the needful, please.



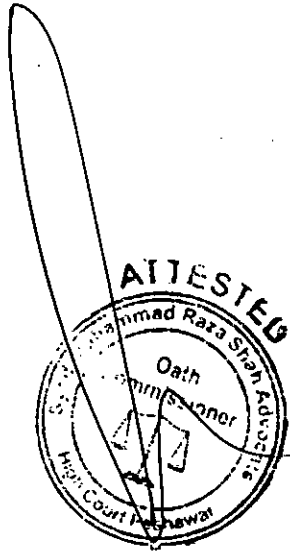
