

- 5. That the appellant was Law fully transferred from S&EO Peshawar to Food Directorate vide Notification No. SOG/Food/1-2/2023/vol-VII/1287 dated 15.03.2023. After arrival of his successor the appellant submitted numerous medical leave applications to justify his non-compliance of Government orders (i.e. transfer from the post of AFC S&EO Peshawar to Directorate of Food and after that transfer to the post of AFC S&EO Azakhel). The appellant also concealed facts from this honorable court regarding non relinquishing charge. The appellant also filed an appeal in the Civil Judge Court X Peshawar which was withdrawn on 15.05.2023. Afterwards filed writ petition in Peshawar High Court Peshawar vide No. WP No. 1519-P/2023 which was disposed of with the direction that Respondent No. 2 (Secretary to Government of Khyber Pakhtunkhwa) may decidethe fate of the departmental appeal of the petitioner within a fortnight(Annexure-B).





Learned counsel for the appellant submits that the appellant was prematurely transferred besides the Food Grain Inspector (BPS-09) was posted against the BS-16 post replacing the appellant a BS-16 officer, and was directed to report to Directorate. Admitted to full hearing subject to all just and legal objections by the other side. Appellant is directed to deposit security fee within 10 days. Respondents shall be summonsed through TCS the expenses of which be deposited within 3 days. Adjourned. To come up for written reply/comments on 09.06.2023 before S.B. P.P given to the appellant.
- 3. As to the application for suspension of operation of impugned transfer order dated 15.03.2023, it is directed that impugned order shall stand suspended to the extent of appellant, if not already acted upon: In case the appellant failed to deposit the expenses of TCS, within three days, the suspension order will have no effect.
