GROUND

A- یہ کہ رسپانڈنٹس کا اپیلانٹ کو ایک Pre-Mature increment اور اُسکے بقایا جات نہ ادا کرنا نہ صرف سراسر غلط، خلاف قانون بلکہ اپیلانٹ کے بنیادی حقوق کو غصب کرنے کے مترادف ہے رسپانڈنٹس کا مذکورہ بالا فعل سراسر غلط، خلاف قانون، خلاف واقعات اور اپیلانٹ کے حقوق پر بے اثر ہے۔

B- یہ کہ رسپانڈنٹس کا رویہ آئین پاکستان 1973ء کی سیکشن 25 کے صریحاً خلاف ہے۔

C- یہ کہ نوٹیفیکیشن مورخہ 30-05-2014 جاری کردہ محکمہ فنانس پشاور ایک Pre-Mature increment کی ادائیگی پر بالکل واضح ہے اور رسپانڈنٹس کا رویہ ہمراہ اپیلانٹ مذکورہ نوٹیفیکیشن کی روشنی میں صریحاً خلاف قانون ہے۔



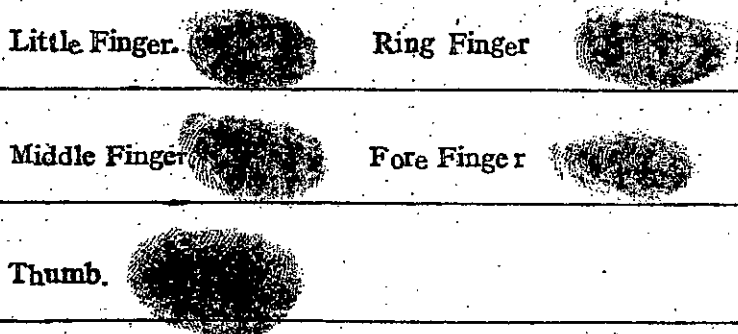
