Prayer in Appeal;

On acceptance of this appeal respondents may be directed to release TA\DA arrears of the appellant w.e.f 23.12.2014 to 31.12.2016 along with miscellaneous expenses.

Respectfully Sheweth;

1. That presently appellant is serving as Subject Specialist BPS-18 in Elementary and Secondary Education Department Govt. of KPK and is posted at GHSS karak.
2. That while posted as Subject Specialist, GHSS, Jandri, Karak, the appellant on approval by respondent no.3, was appointed through notification having Endst: No.3722-28, dated 23.12.2014 as representative to pursue, handle and deal with court cases pertaining to the office of respondent no.6. Copy of the notification is attached as annexure-A.
3. That appellant in the light of notification was vigorously pursuing court cases from 23.12.2014 to 31.05.2016 in different courts of law. List of cases in which the appellant appeared, court attendance certificate, TA bills and the expenses incurred in preparing of written reply is attached as annexure-B, C, D & E respectively.
4. That respondent no.6 through letter dated 31.05.2016 requested respondent no.3 for release of TA\DA of the appellant but over leaf the said letter respondent no.3





passed order for taking the case with respondent no.4 but no action has been taken by respondent no.4 so far. Copy of the letter is attached as annexure-F.

5. That the appellant thereafter filed civil suit which was returned vide order dated 31.01.2017 for presentation before proper forum however the appellant filed appeal against the same which was dismissed vide order dated 18.07.2017. Copy of the civil suit, order dated 31.01.2017, grounds of appeal and order dated 18.07.2018 is attached as annexure-G, H, I and J respectively.

5. That appellant as a last resort addressed departmental appeal dated 28.01.2018 to respondent no.1 which was received in his office on 06.02.2018 having dairy no.1265 W.E but the same has been returned in original to the appellant vide letter dated 16.04.2018 which was received to the appellant on 27.04.2018 (Copy of departmental appeal and letter dated 16.04.2018 is attached as annexure-K&L) hence the present appeal inter alia on the following grounds;

Grounds

A. That the respondents have not treated the appellant in accordance with law and rules on the subject and acted in violation of article-4 and 25 of the constitution of Islamic republic of Pakistan, 1973 and unlawfully are not releasing TADA arrears of the appellant w.e.f 23.12.2014 to 31.12.2016 along with miscellaneous expenses although he has worked in the interest of dept. with zeal.

B. That according to Article-11 of the Constitution of Islamic Republic of Pakistan slavery is non-existent and forbidden and no law shall permit or facilitate its introduction into Pakistan in any form and all forced labour is prohibited but the respondents are bent upon to introduce it because the appellant has worked hard as per directions of the respondents but he is not being paid for the TADA arrears of w.e.f 23.12.2014 to 31.12.2016 along with miscellaneous expenses.



C. That the fundamental rights of the appellant have been violated by not paying what is due to the appellant by the respondents which is also against the principles of natural justice.

D. That the appellant may be allowed to raise additional grounds at the time of arguments.

recovery of the TA/ DA to the tune of Rs. 900,125/- from the defendants.

The record on file would show that plaintiff is a government servant i.e. Subject Specialist in the Education department working in BPS-18. As such the jurisdiction of the Civil Court would be barred.

Section 02 (b) of the NWFP Civil Servants Act, 1973 provides the definition of the Civil servant:

*Civil servant "means a person who is a member of a Civil service of the province or who holds civil post in connection with the affairs of the province."*

A civil servant is regulated by the terms and conditions of the service and jurisdiction of any aggrieved civil servant regarding his terms and conditions of the service lies with the service tribunal particularly established for this purpose.

Section 04 of the NWFP Service Tribunal Act, 1974 clearly provides that any Civil servant aggrieved by departmental authority in respect of any of the term and condition of his service will approach to the Service tribunal against the order of the said authority. The matter regarding the TA/ DA is ancillary to the "pay matters" of the civil servants which is a part of terms and conditions of the civil servant.

As per Section 02 (e) of NWFP Civil Servant Act, 1973 the pay is defined as:

"Pay" means the amount drawn monthly by a civil servant as pay, and includes special pay, personal pay and any other emoluments declared by the prescribed authority.


The above definition of the pay makes it clear that the TA/DA of a civil servant would come within the purview of the definition of pay/ emoluments and as such would come within the ambit of terms and conditions of a civil servant.

The above discussion has led me to conclude that plaintiff being civil servant has to approach to the Service Tribunal for his grievance in respect of the recovery of TA/ DA. The jurisdiction of Civil Court is barred in such matters therefore, the instant Court lacks jurisdiction to entertain the present plaint.

Resultantly, the instant plaint be returned in original under Order 07 Rule 10 CPC, 1908 to the plaintiff to be presented/ filed at the proper forum/Service Tribunal. Copy of the plaint be retained on the file. No order as to cost.

3. I have heard the arguments and gone through the record.

4. Admittedly appellant is a Civil Servant being subject specialist in BPS-18 in the Education Department and he sought entitlement of T.A/D.A under Travelling Allowance Rules, 1980. The T.A/D.A are included in emoluments of a civil servants. The relief sought by the appellant is included in the terms and condition of service of a civil servant while section 3 of the Khyber Pakhtunkhwa (K.P.K) Civil Servants Act, 1973 lays down that,

6. Thus the jurisdiction of the Civil Court is specifically ousted with regard to the terms and conditions of service of a civil servant and the learned trial Court

**Preliminary Objections .**

1. That the appellant has got no cause of action to file the instant appeal.
2. That the appellant is not competent to file the instant appeal against the respondents.
3. That the appellant has not come to this honourable court with clean hands.
4. That the appeal of appellant is badly time barred.
5. That the appeal of the appellant is not maintainable and entertainable in the present form.
6. That the appellant is estopped to file the appeal by his own conduct.
7. That the honourable Tribunal has no jurisdiction to adjudicate the matter.

**Factual Objections.**

1. Para No.1 of the instant service appeal pertains to record of the appellant.
2. Para No.2 of the instant appeal is correct to the extent that the appellant was deputed to follow up the courts cases by the District Education Officer (Female), Karak vide Notification No. 3722 dated 23-12-2014 but it was noted in the said notification that TA/DA will be paid in the school concerned. 3. Para No.3 of the instant appeal pertains to record, however, it is stated that the respondents are not liable to pay TA/DA to the appellant as the appellant has accepted the terms and conditions mentioned in authorization notification dated 23-12-2014.
4. Para No. 4 of the instant appeal is incorrect and wrong. The respondent No. 6 is not agree the letter issued by the Ex District Education Officer (Female), Karak because the District Education Officer (Female), Karak has engaged his services for court cases but the appellant was agreed to be claimed TA/DA from his school concerned where he was performing his duty. The TA/DA is not come under the domain of respondent No. 6 to pay the appellant.
5. Para No. 5 of the instant appeal also pertain to judicial record hence need no comments.
6. Reply of Para No. 6 is that when the appellant was agreed to attend the courts cases on behalf of respondents vide notification dated 23-12-2014 then appellant is not liable to claim TA/DA from the respondent No. 6.

**Objections on Grounds.**

- a. Ground-A of the instant appeal is incorrect and wrong hence denied.
- b. Ground-B is incorrect and wrong. The appellant has been treated as per law.
- c. Grounds-C is incorrect and wrong. No fundamental rights have been violated of the appellant rather the appellant has been treated in accordance with law.
- d. Ground-D needs no comments.




