APPEAL UNDER SECTION- 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 FOR INCLUSION OF THE NAME OF THE APPELLANT IN THE COMBINED SENIORITY LIST OF SET'S ISSUED VIDE NOTIFICATION DATED 30.6.2010 IN THE LIGHT OF HONORABLE HIGH COURT JUDGMENT DATED 5/3/2010 IN WRIT PETITION NO. 870/2010 AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITH IN STATUTORY PERIOD

Prayer:

That on acceptance of this appeal the respondents may very kindly be directed to include/ enlisted the name of appellant at the right place in the combined seniority list of SET's issued vide Notification dated 30.6.2010 in the light of the Hon'ble High Court Judgment dated 5-3-2010 in writ petition No. 870/2010. Any other remedy deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

- 1- That appellant joined the respondent Department as SET (BPS-16) vide order dated 15.12.1990. That since then appellant has served the respondent department for more than 25 years as SET (Technical) quite efficiently and up to the entire satisfaction of his superior.

- 2- That vide order dated 13-2-2013 the appellant was promoted to the post of Head master (BPS-17) in his own pay and scale and was posted at GHS Bushera Kurram Agency. That it is very pertinent mention that appellant has also avail the benefit of selection grade (BPS-17) vide order dated 16-5-2009. (Copies of the posting order and selection grade order are attached as Annexure A & B).
- 3- That before the merging of SET Technical, general and Science the seniority list prepared for the SET technical the name of the appellant was at serial No. 79 which was issued vide order dated 30-6-2007. (Copy of the seniority list is attached as Annexure C).
- 4- That because of different seniority lists of SET Science, Technical & General those SET's who belongs to general & science cadre have been promoted to BPS-17 Head Master post on regular basis while the SET's who belongs to technical cadre were lift out in those promotions. That feeling aggrieved appellant colleagues who belongs to SET (Technical) knocked the door of the Hon'ble Peshawar High Court Peshawar for the murgering and combined seniority list of SET's Technical, Science and General. That the same was accepted in favor of the appellant colleagues. (Copies of the Judgment and COC are attached as Annexure D & E).
- 5- That in consequence the respondent department issued combined seniority list of SET's Technical, General, Science and Commerce vide order dated 30-6-2010. That in the said seniority list the name of appellant was totally ignored without any plausible reason. Though he should have deserved to be placed above at serial No.17 of the said seniority list. That on the basis of the said seniority list many of appellant colleagues and junior colleagues were promoted on different orders one of which is vide order dated 26-2-2013. (Copies of the seniority and promotion orders are attached as Annexure F & G).
- 6- That feeling aggrieved appellant filed departmental appeal but no reply has been received so for hence the present appeal on the following grounds amongst the others. (Copy of the departmental appeal is attached as AnnexureH).

GROUND:

- A- That not including/ enlisting the name of appellant in the combined seniority list of SET's issued on 30.6.2010 is against the law and norms of natural justice.

- B- That the appellant has not been treated in accordance with law and rules on the subject noted above and as such the respondent violated article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That in spite of senior most employee of the respondent department and having more than 25 years service in the respondent department the appellant name is ignored in the combined seniority list of SET's.
- D- That the respondent department acted and arbitrary and malafide manner by not including the name of appellant in the combined seniority list of SET's.
- E- That many colleagues and junior colleagues of appellant have been regularly promoted on the post of Head Master BPS-17 but the appellant has been ignored in those promotions despite of senior most employee of the respondent department only on the pretext that his name has not been enlisted in the combined seniority list.
- F- That appellant seeks permission to advance other grounds and approves at the time of hearing.

It is therefore humbly prayed that the appeal of the appellant may be accepted as prayed for.

Education, vide its letter bearing No.3894-F No.A-88/SL/B-16/Appeal, dated 5.6.2009 addressed to secretary, Govt. of NWFP (Elementary and secondary Education Department, proposed allocation of 5% share to SET (Technical) for promotion to the posts of Head Masters in B-17 (Regular). Government of NWFP, Elementary and Secondary Education Department, responded to the same, vide its number SO (PE)9-4/SET-Tech/Gen/07/court cases, dated Peshawar the 31-7-2009 and paras-2 and 3 of the same are reproduced hereunder:-

3. The Directorate is advised to implement the above decisions in letter and spirit and send compliance report."

4. Thereafter, the Directorate of Elementary and Secondary Education, Peshawar, vide its letter dated 25.9.2009, addressed to all Executive District Officers (E&SE) in NWFP, directed that a written undertaking be obtained from the SETs (Tech)/ SET (Commerce) (on judicial Stamp Paper) as under:-

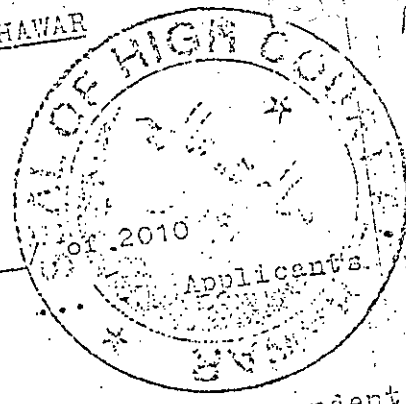

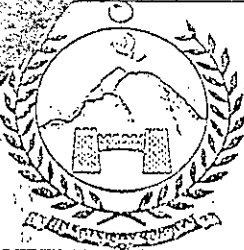

- 1- That appellant joined the respondent Department as SET (BPS-16) vide order dated 8-6-1982. That since then appellant has served the respondent department for more than 25 years as SET (Technical) quite efficiently and up to the entire satisfaction of his superior

- 2- That vide order dated 13-2-2013 the appellant was promoted to the post of Head master (BPS-17) in his own pay and scale and was posted at GHS Bushera Kurram Agency. That it is very pertinent mention that appellant has also avail the benefit of selection grade (BPS-17) vide order dated 16-5-2009. (Copies of the posting order and selection grade order are attached as Annexure A & B).
- 3- That before the merging of SET Technical, general and Science the seniority list prepared for the SET technical the name of the appellant was at serial No. 73 which was issued vide order dated 30-6-2007. (Copy of the seniority list is attached as Annexure C).

That in the said seniority list the name of appellant was totally ignored without any plausible reason. Though he should have deserved to be placed above at serial No.17 of the said seniority list. That on the basis of the said seniority list many of appellant colleagues and junior colleagues were promoted on different orders one of which is vide order dated 26-2-2013. (Copies of the seniority and promotion orders are attached as Annexure F & G).
- 6- That feeling aggrieved appellant filed departmental appeal but no reply has been received so for hence the present appeal on the following grounds amongst the others. (Copy of the departmental appeal is attached as AnnexureH).


GROUND:

- A- That not granting/allowing regular promotion to the post of Head Master BPS-17 to appellant by the respondent Department is against the law and norms of natural justice

- B- That the appellant has not been treated in accordance with law and rules on the subject noted above and as such the respondent violated article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That in spite of senior most employee of the respondent department and having more than 25 years service in the respondent department the appellant is entitled to be promoted on regular basis to the post of Head Master BPS-17.
- D- That the respondent department acted in arbitrary and mala fide manner by not including the name of appellant in the combined seniority list of SET's.
- E- That many colleagues and junior colleagues of appellant have been regularly promoted on the post of Head Master BPS-17 but the appellant has been ignored in those promotions despite of senior most employee of the respondent department.
- F- That appellant seeks permission to advance other grounds and approves at the time of hearing.

It is therefore humbly prayed that the appeal of the appellant may be accepted as prayed for.

Education, vide its letter bearing No.3894-F. No.A-88/SL/B-16/Appeal, dated 5.6.2009, addressed to secretary, Govt: of NWFP (Elementary and secondary Education) Department, proposed allocation of 5% share to SET (Technical) for promotion to the posts of Head Masters in B-17 (Regular). Government of NWFP, Elementary and Secondary Education Department, responded to the same, vide its number SO (PE)9-4/SET-Tech/Gen/07/court cases, dated Peshawar the 31-7-2009 and paras-2 and 3 of the same are reproduced hereunder:-

- "2. In the light of the foregoing it is proposed that:
- i. The SET (Tech) and SET (Commerce) may be included in the seniority list of SET (General/Science) with the condition that this inclusion will only be for the purpose of promotion to the post of Headmaster (B-17) in light of the service rules for the posts of Headmaster duly notified vide Notification No.SOG/ S&LD/ 1-28/2003/VOL.II dated 9.04.2004 and these SETs (Technical and Commerce) will not claim any other benefits which will accrue of their inclusion in the seniority list that would affect the SET (General/Science).
 - ii. A written undertaking will be obtained from all SET (Tech) and SET (Commerce) regarding the condition mentioned in para-1 above which will also discourage further litigation. This condition will be reflected in the revised seniority list of all SETs.
 - iii. This inclusion in the seniority list will be compulsory and any teacher who does not furnish the relevant undertaking mentioned in para-ii above will be kept on static list and he/she will not claim any service benefits which his other colleagues will enjoy.

3. The Directorate is advised to implement the above decisions in letter and spirit and send compliance report."

4. Thereafter, the Directorate of Elementary and Secondary Education, Peshawar, vide its letter dated 25.9.2009, addressed to all Executive District Officers (E&SE) in NWFP, directed that a written undertaking be obtained from the SETs (Tech)/ SET (Commerce) (on judicial Stamp Paper) as under:-

"I am agreed for including my name in the General seniority list of SETs and I will not claim any other benefits which will accrue of my inclusion in the general seniority list. This condition will be reflected in the revised seniority list of all SETs. I will also not make further litigation."

5. After hearing the learned counsel for the petitioner at some length, whose main grievance was that inspite of the aforesaid decision as contained in the letter dated 31.7.2009, respondents are not implementing the said decision in letter and spirit, resulting into non-issuance of a joint seniority list and making promotion strictly in accordance with the said decision. Respectfully Sheweth :-

The Respondent submit as under:-

PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action / locus standi .
- 2 That the instant Service Appeal is badly time barred.
- 3 That the Appellant has concealed material facts from this Honorable Tribunal in the instant service appeal.
- 4 That the instant service appeal is based on malafide intentions.
- 5 That the Appellant has not come to this Honorable Tribunal with clean hands.
- 6 That the Appellant is not entitled for the relief has been sought from this Honorable Tribunal .
- 7 That the instant Service Appeal is against the prevailing law & rules.
- 8 That the instant Appeal is based on malafide intentions just to put extra pressure on the Respondents for gaining illegal service benefits against the post of SET(Tech:).
- 9 That the Appellant has been treated as per law rules & up-gradation policy.
- 10 That the Appeal is not maintainable in its present form.
- 11 That the Appeal is bad for mis joinder & non joinder of the necessary parties.
- 12 That the instant Service Appeal is barred by law
- 13 That the Appellant is not competent to file the instant Appeal against the respondents.
- 14 That the seniority list & Notification dated 30-06-2010 & 26-2-2013 are legally competent & is liable to be maintained.

FACTS


- 1 That Para-1 needs no comments being pertains to the service record of the appellant.

- 2 That Para-2 is incorrect & misleading on the grounds that the appellant has been working against the SET(Tech:) & was adjusted against an In-charge Headmaster post at GHS Mali Killi (Kurram Agency) vide Notification dated 13-02-2013 in his own pay & scale of BPS-16 & not against the Headmaster post in BPS-17. Therefore, the plea of the appellant regarding his promotion & adjustment / working against the Headmaster post in BPS-17(Regular) is against the facts & Notification dated 13-2-2013. (Copy of the same as Annexure-A).
- 3 That Para-3 is correct to the extent that the Respondent Department has prepared & maintained the seniority list of the SETs(Tech:) working in the Respondent Department.
- 4 That Para-4 is incorrect & denied on the grounds that the cadre of the appellant is basically SET(Tech:). Therefore, the Respondent Department has prepared a separate seniority list for the said cadre, hence being a stranger & out cadre candidate, the appellant cannot be included in the seniority list pertaining to the SETs(General) & Science, hence he has been rejected for the grant of BPS-17 (Regular) against the Headmaster post by the Respondents. Whereas rest of the para pertains to the court record , hence needs no comments.
- 5 That Para-5 is correct to the extent that a combined seniority list has been issued by the Respondent Department vide Notification dated 30-06-2010, wherein the name of the appellant could not be included due to the non regularization of his service against the SET(Tec:) post on the grounds that seniority against a post is normally granted from the date of passing of professional qualification of B. Ed / service regularization against the post in question. Therefore, the impugned Notification dated 30-6-2010 is legally competent & liable to be maintained in the interest of justice. (Copy of the said Notification as Annexure-B).
- 6 That Paara-6 is incorrect & denied. No departmental appeal has been filed by the appellant against the impugned Notification to the appellant authority. However the Respondents further submit on the following grounds inter alia :-


GRONDS

- A Incorrect not admitted. The impugned Notification dated 30-06-2010 is in accordance with law, rules & policy. Hence liable to be maintained.
- B Incorrect & not admitted .The statement of the appellant is baseless & is liable to be dismissed on the grounds that the appellant has been treated as per law, rules & seniority policy vide Notification dated 30-06-2010. Therefore, the plea of the appellant is liable to be dismissed in terms of the above made submissions mentioned in the foregoing Paras.
- C Incorrect & denied. The statement of the appellant is against the law, facts & circumstances of the case on the grounds as are agitated in the foregoing Paras.
- D Incorrect and not admitted. The department has acted as per law, rules & policy vide Notification dated 30-06-2010 in the instant case. Hence the plea of the appellant is liable to be dismissed in favour of the Respondents.
- E Incorrect & denied. The stand of the appellant in this para is against the prevailing policy & criteria for the grant of seniority against the post, he holds in the Respondent Department , hence liable to be dismissed.
- F Legal, however, the Respondents seek leave of this Honorable Tribunal submit additional grounds & record at the time of arguments.

In view of the above made submissions, it is requested that this Honorable Tribunal may very graciously be pleased to dismiss the instant service appeal with cost in favor of the Respondent Department.
