Appeal U/S 4 of the Khyber Pakhtunkhwa Services Tribunal Act, 1974 Against The Final impugned Seniority List of Junior Clerk (BPS-11) vide letter no.337/DSJ 08-04-2023 Maintained by the Learned District and Session judge, District Khyber Whereby The Appellant was declared junior in the impugned seniority list, and his Departmental Appeal of the appellant was regretted in a Classical and a Whimsical Manner.

Respectfully Sheweth:-

- 1. That the appellant is a law abiding citizen of Islamic republic of Pakistan, hail from a respectable family and now serving as junior clerk (BPS-11) since 05-03-2020
- 2. That after going through the mandatorily required criteria and after being envisaged with the ordeals and inquisitions of selection process the appellant scored highest in merit list and then the appellant recommended on dated 9-12-2019 and finally appointed as junior clerk (BPS-11) in the prestigious respondent department on dated 05-03-2020.
- 3. That after being inducted into service & coming onto the strength of respondent department, the appellant has ever remained a hardworking, dutiful & devoted fellow, who never left any stone unturned in performance of his duties and because of the same there is no soot or sootage of any sort on his career.
- 4. That in respect of promotions to the post of senior clerk the respondent No.02 issued a tentative seniority list of junior clerks(BPS-11), wherein the appellant was placed 0 of the said list.
- 5. That thereafter the appellant being highly aggrieved from the said list maintained by respondent No.02 moved appeal before competent form

but unfortunately the same was regretted because of list is not final yet. (Departmental appeal and regretted order is annexed as annexure "A & B)

- 6. That after some days finally the respondent No.02 issued a final seniority list of junior clerks (BPS-11) whereby again the appellant was placed at serial No.04, hence the appellant preferred a second departmental appeal but deuce fate of the appellant prevailed and the same was turndown without any cogent reason. (Copy of impugned final Seniority list, Departmental appeal and order of the respondent department is annexed as annexure "C, D & E"
- That interestingly far away juniors from the appellant was also placed seniors at seniority list which is against the prevailing rules mentioned in judicial Esta code 2021. (Copy of relevant rules are annexed as annexure "F")
- 8. That now frustrated from every angle the appellant approaches to this Hon'ble tribunal for acknowledgment, recognition and enforcement of his basic rights, upon the following grounds inter alia

GROUNDS:-

ł

- A. That from every angle the appellant has a right to is entitled to be placed at Serial No 01 of the final seniority list.
- B. That the appellant has not been dealt with in accordance with law and equity and by doing so the appellant has been deprived of his valuable rights of promotion at his due place.
- C. That the appellant has been serving in respondent department with great zeal and zest and persistent efforts and no adverse remarks whatsoever has been recorded in his all career.
- D. That the respondent department recommended the appellant along with other colleagues on dated 19-12-2019 and were accordingly issued appointment orders. Now the appellant has topped the merit and as per law bin vogue is entitled to be placed at his due place in Seniority List as well, but in order to appease the blue eyed one the appellant has been deprived of his due placement in the Seniority List.
- E. That interestingly the appellant along with other colleagues were recommended on dated 23-12-2019, while the respondent department mistakenly issued different date of appointment of those recommended

candidate who were initially recommended on same date, meaning thereby the appellant appointed on 05-03-2020 while other colleagues were appointed on 04-03-2020, which is against prevailing law and rules. (Copy of recommendation is annexed as Annexure "G")

F. That it is a cherished principle of law, that where a law requires a thing to be done in a particular manner, then the same is to be done in a particular manner not otherwise.

G. That any other ground not raised here may very graciously be extended in favor of the appellants.

It is therefore most humbly prayed that on acceptance of the instant service appeal, the appellant may very graciously be placed at his due place in the seniority list at serial No.01 at District judiciary Khyber.

Any other relief not specifically for asked may also graciously be extended in favor of the appellant in circumstances of the case.

PRAYER:

By allowing this appeal and setting aside the impugned inal seniority list of Junior Clerk (BPS-11) Employees of District Judit iary Khyber circulated vide letter No. 337/DSJ dated 08-04-2023 and plaising the appellant at serial No. 01 of the impugned seniority list.

Asif Samad, Junior Clerk, In the Court of District and Session Judge, Khyber the appellant submits most respectfully the following for your kind consideration and favor of acceptance.

- 1. Being qualified and eligible, the appellant was selected and appointed as Junior liferk (BPS-11) at District Judiciary Khyber on 05-03-2020. Since his appointment, he has ; sen serving the department honestly and diligently to the utmost satisfaction of his super ors.
- 2. That the appellant assumed the charge of his duties on 05-03-2020 and the entries in respect of the same has been duly incorporated in his monthly salary state; ent accordingly.
- 3. That a tentative seniority list of Junior Clerk was issued by the office of D&SJ Khybe on **08-04-2023**, wherein the appellant was placed at serial No. 5 of the said list.

The said promotion the appellant was required to be placed on the top of the seniority list of Junior Clerk employees of BPS-11 at District Courts Khyber.

That 04 Officials namely, Hamayun Khan, Muhammad Arif, Shah Saud and Muham ad Haroon who were appointed on 04-03-2020 and 05-03-2020 were placed above the appellant without plausible explanation and sound reasoning.

It was quite shocking that the worthy authority issued the impugned final senerity list vide letter dated **08-04-2023** wherein the appellant was further relegated to serial No. 05 and Four (04) employees who are junior to him **and** were selected and appointed 1 in the subsequent batch were placed above him.

It is worth mentioning that Advertisements for the selection of Junior Clerk (bps. 11) employees were circulated in the daily newspapers on 29-11-2019 and the appel ant along with other candidates was recommended for the job/post on 19-12-2019 the appointment order was issued on 04-03-2020 and 05-03-2020 respectively, where in there was a Departmental Mistake in appointment order, as to why not the date of appointment should be corrected, i.e. 04-03-2020 like other candidates recommented on same date.

That the appellant was selected and appointed in view of his application mades in pursuance of first advertisement and selection made on 19-12-2019. The appellant was lawfully required to be placed senior to the employees selected in the subsequent batch as per recommendation list displayed on official website and notice board. This principle was however ignored and Officials of subsequent batch were illegally & arbitrarily placed senior to Appellant.

That the as per Judicial EstaCode 2021 (KPK Laws Act, 2011) gave a proper guide line for fixation of seniority and promotion of Junior Clerk employees to the next higher a sale

The analogy that employees selected in the batch would rank senior to the t of those appointed and selected in the batch was duly adopted by Judicial EstaCode 221 (KPK Laws Act, 2011) and circulated by the departmental selection committee District Judiciary Khyber. (Copy Enclosed A & B)

It is quite clear from the Judicial EstaCode 2021 (KPK Laws Act, 2011) and tiles regulating the matter regarding seniority, that where the Officials in the common seniority list have been appointed in batch, with varying date of acquisition of SSC and Date of Birth, the Officials appointed in the batch would rank senior, irrespective of their ate of acquisition of SSC and Date of Birth.

Any design harmful to the appellant's service interest cannot be imposed arbitraril ', in violation of the appellant's vested rights of service. The appellant did deserve to be treated equitably fairly and in a just manner without losing the benefit of his prior selection and seniority based on his more than 03 years of continuous and sincere service.

Thus the impugned omission in the impugned seniority list of Junior Clerk Employe: s of District Khyber as it stood on dated **08-04-2023** is not only arbitrary but ilso discriminatory against the principles of equity, law, justice, and propriety, callin: for interference by the worthy authority.

In view of the above, it is requested that by allowing this appeal the impurned final seniority list of Junior Clerk (BPS-11) Employees of District Judiciary Khiber circulated vide No. 337/DSJ dated **08-04-2023** may kindly be set aside and the appenant may be placed at serial No. 01 of the impugned seniority list as per merit/recommendation list.
