PRAYER:- ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, IMPUGNED ORDER DATED 04/03/2023 ISSUED BY RESPONDENT NO. 3 MAY GRACIOUSLY BE SET-ASIDE TO THE EXTENT OF RESPONDENT NO. 4 BEING ILLEGAL, UNLAWFUL, AGAINST THE LAW, RULES, POLICY ON THE SUBJECT AND THE APPELLANT BE PROMOTED AGAINST THE POST OF SST BIO CHEMISTRY BPS-16. ANY OTHER RELIEF WHICH THIS HONOURABLE COURT DEEMS FIT AND PROPER IN THE CIRCUMSTANCES OF THE CASE MAY ALSO BE GRANTED TO THE APPELLANT.

Respectfully Sheweth;-

May it please your lordship appellant beg to solicit on the following factual and legal grounds;-

1. That the appellant is well qualified having M.Ed, B.Ed and BSc Biochemistry Degree and was appointed as a PST Teacher in the respondents

department on 28/03/2015. (Copies of documents and appointment order are annexed as Annexure "A" & "B").

2. That thereafter appellant submitted their arrival reports and started continuously performing their duties till date with full devotion and liabilities. There had no complaint against the appellant in respect of their responsibilities and due to good performance department issued best teacher appreciation certificate to the appellant.
3. That in October 2022 respondent No. 3 issued seniority list of PST Teacher throughout the District Abbottabad whereby appellant was placed at serial No. 319 and respondent No. 4 was 362. Copy of seniority list is attached as Annexure "C".
4. That thereafter, appellant submitted her all relevant documents in the office of respondent No. 3 for promotion against the post of SST Biochemistry (BPS-16).
5. That, on 04/03/2023 respondent No.3 issued impugned promotion order of the respondent No.4 to the post of SST Bio Chemistry in BPS-16 and

whereby refused/ignored promotion of the appellant. Copy of impugned order dated 04/03/2023 is annexed as Annexure "D".

6. That, on \_\_\_/03/2023 petitioner filed departmental appeal before the respondent No.2, against the impugned promotion order dated 04/03/2023. Copy of departmental appeal is annexed as Annexure "E".
7. That, till date respondent No.2 not passed any order on the departmental appeal of the appellant and similarly not given any response on the same.
8. That, as promotion of the present appellant is involved and the department concerned is not considering the same and as there is no other remedy in the present case, but to approach this Honourable Court which has the jurisdiction to entertain the same. Therefore, the appellant feeling aggrieved of the same has filed service appeal on the following grounds;-

**GROUND:-**

- a. That not taking action on the departmental appeal of the appellant and not promoting

the appellant on the post of SST (BPS-16) in Biology/ Chemistry Group w.e.f 04/03/2023 under promotion quota for PST is against the law, rules, norms of justice and material on record, therefore not tenable.

- b. That depriving the appellant from her legal rights of promotion to the post of SST (BPS-16) in Biology/ Chemistry Group under PST by the respondents will damage the service career of the appellant both in monitoring benefits as well as in future promotion chances and against the law issued the promotion order of the respondent No.4 which is liable to be set-aside.
- c. That the appellant has not been treated in accordance with law and rules and has been deprived her legal rights of promotion to the post of SST (BPS-16) in Biology/ Chemistry and ignored the seniority of the appellant and promoted junior teacher/respondent No.4 instead of appellant.

- d. That the appellant was appointed in accordance with law and her rights has been matured for the status of promotion, thus a valid order of promotion is required to be issued in this regard.
- e. That, respondent No.4 was appointed on 10/03/2016 and her service length is six years and six months on the other hand appellant length of service is seven years and nine months which is clearly mentioned in the seniority list.
- f. That the appellant has rendered satisfactory, continuous service without any break for a considerable period of time, hence he is eligible and entitled in all respect to be promoted against the post of SST (BPS-16).
- g. That the conduct of the respondents towards the appellant is illegal, malafide, perverse, discriminatory, without lawful justification.
- h. That as per article 4 & 25 of the Constitution of Islamic Republic of Pakistan 1973, no



discrimination can be made against any person or class on the basis of malafide intentions & no one can be deprived of her fundamental rights.

- i. That when law prescribe something which is to be done in a particular manner that must be done in that manner and not otherwise. The state functionaries are to deal with the employees who are at par, fairly, justly, without nepotism & Favoritism and should be strictly in accordance with law.
- j. That it is inalienable right of every citizen to be treated in accordance with law which envisages that the appellant is entitled to be promoted against the said posts.
- k. That the addresses of the parties have been correctly given in the heading of the appeal.
- l. That other points would be argue at the time of argument with the kind permission this Honourable Tribunal.

It is, therefore, humbly prayed that, on acceptance of the instant service appeal, impugned order dated 04/03/2023 issued by respondent No. 3 may graciously be set-aside to the extent of respondent No. 4 being illegal, unlawful, against the law, rules, policy on the subject and the appellant be promoted against the post of SST Bio Chemistry BPS-16. Any other relief which this Honourable court deems fit and proper in the circumstances of the case may also be granted to the appellant.
