SERVICE APPEAL U/S 4 OF THE SERVICE TRIBUNAL ACT. 1974 AGAINST IMPUGNED ORDER DATED 28.11.2022 WHEREBY THE *APPELLANT* WAS DISCHARGED FROM SERVICE AND HIS DEPARTMENTAL APPEAL/MERCY PETITION REVISION PETITION **FOR** INSTATIMENT IN SERVICE WAS REJECTED VIDE ORDER 03.03.2023 *08.05.2023*.

PRAYER

By accepting this appeal, the impugned orders dated 29.11.2022, 03.03.2023 & 08.05.2023 may please be set aside and the appellant may be reinstated in his service with all back service and consequential benefits.

(2)

Respectfully Sheweth:-

- 1. That the appellant is peaceful and law abiding citizen of Pakistan and is entitled for all the legal and fundamental rights guaranteed under the constitution of Islamic republic of Pakistan 1973.
- 2. That initially the appellant was absorbed /appointed in police department at District Mohmand as constable, Belt No.3260, after fulfilling all codal formalities vide order dated 07-05-2021. (Copy of office order dated 07.05.2011 is attached as Annexure "A")
- 3. That later on the competent authority promoted the appellant as A.S.I in District Mohmand and posted at P.S Ghalanai from Police Line vide order dated 14.04.2022. (Copy of order dated 04.04.2022 is attached as Annexure "B")
- 4. That through another order dated 30.05.2022 the appellant was transferred as Security Officer in the Mohmand Dam with the same rank of A.S.I. (Copy of order dated 30.05.2022 is attached as Annexure "C")
- 5. That after posting at Mohmand Dam the appellant was performing his duties with great zeal and zest and no complaint whatsoever has been filed against the appellant neither any such report was made against the appellant throughout his service.
- 6. That a false and baseless allegations were incorporated against the appellant during performing his duties, an inquiry was initiated against the appellant. Furthermore neither any charge sheet, nor statement of allegations were issued to the appellant through proper way and time.
- 7. That it is pertinent to mention here that no regular and impartial inquiry has been conducted against the appellant and astonishingly the District Police Officer

Mohmand without giving any proper opportunity of being heard passed the impugned order dated 28.11.2022, whereby the appellant was discharged from his duties. (Copy of impugned order dated 28.11.2022 is attached as Annexure "D")

- 8. 8. That the appellant preferred departmental appeal on 12.12.2022 to respondent No.2 who without considering the issue in question rejected the appeal on 03.03.2023 on the ground of limitation inspite of the fact that the appeal was very much within time limit provided in the law. (Copy of Department Appeal & Order dated 03.03.2023 are attached as Annexure "E & E/1")
- 9. That the appellant preferred Revision to Department, which was dismissed summarily vide order dated 08.05.2023. (Copy of order dated 08.05.2023 is attached as Annexure "F")
- 10. That the appellant preferred to move this Hon'ble tribunal against the impugned orders dated 28.11.2022, 03.03.2023 & 08.05.2023 through filing of the instant appeal for the following amongst other grounds:

GROUNDS:

- A. That the appellant has treated un-equally, against the law and thus deprived of equal protection before the law.
- B. That the impugned orders passed by the respondents are illegal ,against the facts and valuable rights of the appellant hence not maintainable and is liable to be set aside.
- C. That the appellant was dismissed from service through the impugned order dated 28.11.2022 on the allegations of being involved in anti-social elements and wearing the rank of ASI as mentioned in the impugned order dated 28-11-2022 without any proof as

he never been remained involved in contacts with antisocial elements in his whole life not only in services and also he was shoulder promoted to ASI therefore he was wearing ASI shoulders according his rank allowed by the department.

- D. That impugned orders of the lower fora have no backing of the statute and is in utter disregard and violative of the law on the subject, hence the impugned orders are not sustainable.
- E. That no regular inquiry has been conducted in the matter nor any witness has been examined by the inquiry committee nor appellant was allowed to cross examine the witnesses appearing against him.
- F. That the appellant is civil servant and cannot be discharged without proper procedure available in the law and rules on the subject.
- G. That appellant is poor person and the only earning hand of the family therefore he is entitled to reinstatement.
- H. That no opportunity of personal hearing is provided to the appellant till date thus the appellant has condemned unheard, therefore the impugned orders are violative of the basic principal of natural justice what to speak up safe administration of justice.
- I. That the impugned orders are illegal, corum-non-judice, hence are void ab initio, therefore liable to be set aside at naught.
- J. That impugned orders whereby the appellants deprived of his vested rights by using the term discharge from service is based on vague allegations, conjecture and surmises, therefore the same is liable to be set aside on this core alone.



- K. That respondents shave awarded maximum punishment to the appellant and thus have caused serious miscarriage of justice.
- L. That the allegations on the basis of which the appellant has been discharged from services are general in nature giving no clue as to how appellant was in contact with anti-social elements. Besides the second allegation is a whimsy one who the department itself given shoulder promotion to the appellant so he is supposed to wear ASI rank shoulders.
- M. That any other ground will be raised at the time of arguments with prior permission of this Honorable Tribunal.

It is, therefore most humbly prayed that by accepting this appeal ,the impugned orders of the respondents may be set aside and the appellants may be reinstated into services along with all back benefits.

Any other relief which this Hon'ble Court deems may be passed if not specifically prayed for may kindly also be granted in favour of appellant.







- 1. That the Appellant is peaceful and law abiding citizen of Pakistan and is entitled for all the legal and fundamental rights guaranteed under the constitution of Islamic Republic of Pakistan 1973.
- 2. That initially the Appellant was absorbed / appointed in Police Department at District Mohmand as Constable, Belt No. 3260, after fulfilled all the codal formalities.
- 3. That later on the competent authority promoted the Appellant as Shoulder ASI in District Mohmand and posted at Police Lines Ghalanai vide Order dated 14.04.2022. (Copy of order dated 14.04.2022 is attached)
- 4. That through order dated 30.05.2022 the appellant was transferred / posted as Security Officer in the Mohmand Dam. (Copy of Order dated 30.05.2022 is attached)
- 5. That after the posting of the Appellant at Mohmand Dam, he was performin; his duties with zeal and zest and no complaint whatsoever has been filed against the appellant.
- G. That a false and taseless allegation were incorporated against the Appellant during

performing of his duties, an inquiry was initiated against the Appellant. Furthermore neither any show cause notice, nor statement of allegation were issued to the Appellant.

- 7. That it is pertinent to mentioned here that no regular and impartial inquiry has been conducted against the Appellant and astonishingly the District Police Officer Mohmand without giving any proper opportunity of being heard, passed the Impugned Order dated 28.11.2022, whereby the Appellant was discharged from duties. (Copy of Impugned Order dated 28.11.2022 is attached
- 8. That the valuable rights of the Appellant has been violated, as it is the legal and fundamental right of any citizen of Pakistan to be given proper opportunity of being heard, but in the instant case of the Appellant, neither any show cause notice, nor any statements of allegations had been issued to the Appellant and not any proper inquiry / investigation has been made in the case of the Appellant and had issued the impugned order dated 28.11.2022 is hasty manner.

ORDER.

This order will dispose of the departmental appeal preferred by ExConstable Usama Khan No. 3260 of Mohmand District against the order of the then
District Police Officer, Mohmand, whereby he was awarded major punishment of
discharge from service vide OB: No. 1999 dated 29/11,2022. The appoilant was
proceeded against departmentally on the allegations that he white posted at Mohmand
Dam was assigned routine security duties but instead to perform his professional duties,
remain to contact Anti-social elements. Besides, he was found wearing the rank of
Assistant Sub Inspector without any orders of the competent authority.

Proper departmental enquiry proceedings were initiated against him. He was issued Charge Sheet alongwith Statement of Allegations and Superintendent of Police Investigation, Mohmand was nominated as enquiry Officer. The Enquiry Officer after fulfilling codal formalities submitted his report to the their District Police Officer, Mohmand concluding that the delinquent Officer was found guilty for the misconduct and recommended for major punishment as per Police Rules, 1934 Chapter-12 Rule-21.

On the perusal of findings, the then District Police Officer, Mohmand Issued him Final Show Cause Notice to which his reply was received/perused and found unsatisfactory.

Therefore, as per recommendations of Enquiry Officer, the delinquent Officer was discharged from service vide OB: No. 1999 dated 29.11.2022 by the then District Police Officer, Mohmand.

Feeling aggrieved from the order of the then District Police Officer.

Mohmand, the appellant preferred the Instant appeal. He was summoned and heard in person in Orderly Room held in this office on 28.02.2023.

From the perusal of the enquiry file and service record of the appellant, it has been found that allegations leveled against the appellant have been proved beyond any shadow of doubt. Moreover, the involvement of appellant in anti-social elements is clearly a stigma on his conduct. Hence, the retention of appellant in Police Department will stigmatize the prestige of entire Police Force as instead of fighting crime, he has himself indulged in criminal activities. Moreover, he could not present any cogent justification to warrant interference in the order passed by the competent authority.

Keeping in view the above, I, Muhammad Ali Khan, PSP Regional Police Officer, Mardan, being the appellate authority, find no substance in the appeal, therefore, the same is rejected and filed/being devoid of merit.
