Joint Parawise Comments on behalf of Respondents No 1, 2 and 3 are as under:-

#### PRELIMINARY OBJECTIONS:-

- 1. That the appellant has no cause of action or locus standi.
- 2. That the appellant has not come to the Tribunal with clean hands.
- 3. That the appellant has been estopped by his own conduct to file the instant appeal.
- 4. That the appeal is time barred.
- 5. That the appeal is not maintainable in its present form.
- 6. That the appeal is bad for misjoinder and non joinder of necessary parties.

#### **FACTS:**

Para No1: No comments.

- i. No comments.
- ii. Correct. But as per Government of NWFP Services and General Administration Department (Regulation wing) Notification dated: 10/09/1990 as annexure "A", amendment, the rules for Patwar Passed Candidates have exempted those officials who do not have qualification of FA but have passed the Patwar Examination from Patwar School on or before 30<sup>th</sup> June 1990. Moreover, as per Land Record Manual 3.9 as annexure "B", the collector is empowered to delete / dismiss the name of those Patwar candidates who did not pass the patwar exam for last 03 years. So, the appellant is one of them who failed the patwar exam in 1996 and confessed in appeal that after 07 years he passed the Patwar Exam in 2003.
- iii. Correct.

iv. As per Notification dated 27/11/2001 and guidelines issued for filling of vacant posts of patwaries from Government of NWFP Revenue Department vide letter dated: 21/02/2002 as annexure "C", in which written test was declared as mandatory for initial recruitment through an open and transparent test instead of stiking to years old registers with dubious record / entries for patwar candidates. So the appellant failed in patwar exam in 1996 and passed patwar exam in 2003 and was enlisted in patwar candidates register in 2004. Later on the post was filled through written test/interview and that time the appellant was overage candidate (overage by one year and one month) and was not selected by DSC for the post of Patwari whereas Mr. Miraj, Mr. Qasim and Mr. Sana Zeb were eligible candidates (within age) for the post of Patwari. After fulfillment of all codal formalities the aforementioned candidates were selected by DSC and appointed as Patwari as annexure "D". The appellant as per above mentioned notification and letter already above annexed "C", appeared against vacant post and appointed as Patwari on dated: 10/07/2006 in this office and granted age relaxation to the appellant. As per Seniority Rule 09 of West Pakistan Patwar Subordinate Service Rules 1963, "The Seniority inter se of the members of the service in the various grades thereof shall be determined in accordance with the order of merit assigned by the appointing authority, provided that persons selected for the service in an earlier selection shall rank senior to the persons selected in a later selection" as annexure "E". Therefore Mr Kashif Jamal is later selected/ appointed as Patwari and Mr. Miraj Khan, Mr. Muhammad Qasim, and Mr. Sana Zeb earlier selected / appointed as Patwari and shall senior to Mr. Kashif Jamal Patwari in the Seniority List of Patwaries.

#### v. Correct.

- vi. The appellant was appointed as Patwari on 10/7/2006 and as per Patwar Subordinate Service Rules 1963 and Section 17 of Civil Servant (Appointment, Promotion, Transfer) Rules 1989 as annexure "F", the seniority of officials of the same cadre is to be determined according to the First Entry into Government Service in that cadre. So, as per rules the official is rightly placed in the seniority list and no injustice was made by this office. That DPC dated: 27/05/2018, appellant was included in the Departmental Promotion Committee for completion of panel as his senior patwaries had not passed the Kanungo Exam at that time.
- vii. & viii. Partially correct. That the Competent Authority is empowered by rules that during exigency of services any official is to be assigned post in OPS/temporary basis and is to be reverted to his original post at any time during service after completion of task etc. In this regard the appellant filed complaint against this

office in Commissioner Office Kohat. This office informed the high up as well as appellant that his services was no more required due to which he was reverted to his original post as Patwari vide letter No 5716/DC-Kt/Estb dated: 29/09/2020 as annexure "G".

- Para No 2: Incorrect. Land Record Manual, annexure B and Government of NWFP Revenue

  Department Notification and letter dated 21/02/2002, annexure C, may be perused.

  That the initial recruitment against vacant posts at that time is purely mentioned in

  Notification dated 27/11/2001, NWFP Revenue Department and Land Record

  Manual and no injustice was made against initial recruitment of Patwaries as the

  Seniority list of Patwaries is maintained on the basis of their initial recruitment as

  Patwari.
- Para No 3: It is pertinent to mention here that Safder Rehman's, Date of Appointment is 01/04/1985 and Appellant Kashif Jamal's, Date of Appointment is 10/07/2006. As per Section 17 of Civil Servant (Appointment, Promotion, Transfer) Rules 1989 as annexed "H", therefore Mr Safdar Rehman is senior to Mr Kashif Jamal, the Appellant. That the forgoing seniority for promotion has been deleted vide Establishment Department Notification dated: 06/08/2020 as annexure "I", after that Mr Safder Rehman is eligible for taking promotion at any time during service.

That as per Board of Revenue, Service Rules Notification No 1942/Estt: I/135/SSRC dated: 23/01/2015 as annexure "J". The criteria for promotion to the post of Kanungo are as "By promotion on the basis of seniority-cum-fitness, from amongst the Patwaris and Naib Office Kanungos of the district concerned with three years service as such and who have passed the Departmental examination of Kanungo". So, there is no time frame of passing of Kanungo exam.

It is worth mentioning here that no doubt the appellant's case regarding his seniority list is in trial in the Honourable Service Tribunal Khyber Pakhtunkhwa Peshawar but his seniority issue is purely with the official named Mr Sanazeb Patwari (BPS-09) who has neither promoted to the next higher rank nor even considered to be promoted and no Status Quo received from Honourable Court to this office.

Para No 4. Incorrect. That the seniority of patwaries to further promotion i.e. Kanungo is considered from the date of their appointment as regular Patwari. It does not matter if a Patwari higher in rank passes Kanungo exam later than the Patwari lower in rank. That as per Board of Revenue, Service Rules Notification No 1942/Estt: I/135/SSRC dated: 23/01/2015 and Civil Servant (Appointment, Promotion & Transfer) Rules 1989. So all the patwaries who have been considered for promotion in the DPC dated: 11/12/2020 and been promoted as Kanungo (BPS-11) are senior to the appellant.

- Para No 5. No Status Quo received from Honourable Court. That the DPC dated: 11/12/2020, has been conducted within the aforementioned notification and as per Seniority list maintained on date of appointment. So, the appellant is junior most official amongst all officials (Patwaries) who have been promoted to higher rank i.e. Kanungo (BPS-11). Furthermore foregoing seniority for promotion has been deleted vide Establishment Department Notification dated: 06/08/2020 and no injustice, irregularities were made / occurred and the laid down criteria of promotion from the post of Patwari (BPS-09) to Kanungo (BPS-11) was fully followed by this office.
- Para No 6. Incorrect. The appellant was informed through this office letter No 249/DC-Kt/Estb dated: 21/01/2021 as annexure "K", that the seniority is maintained on date of appointment not on passing of Kanungo Exam.
- Para No 7: That apex court after careful perusal of the available record and as per law/rules and being devoid of merit the appeal of the appellant is liable to be dismissed.

#### **GROUNDS:**

- A. Incorrect. That as per law/rules the seniority list of Patwaries has been maintained according to Date of Appointment and no violation of rules was made and treated all officials in one scenario of rules under section 17 of Civil Servants (Appointment, Promotion & Transfer) Rules 1989 as applied by this office.
- B. Incorrect. The seniority list of Patwaries for various years placed for perusal as annexures L, M, N, O, P and Q. That as per date of appointment the officials were promoted to next higher rank i.e. Patwari (BPS-09) to Kanungo (BPS-11). Therefore as per Seniority list all the Patwaries have been considered for promotion in the DPC dated: 11/12/2020 and been promoted as Kanungo (BPS-11) are senior to the appellant.
  - (i) Incorrect. The DPC after careful perusal of all available record, promoted the Patwari (BPS-09) to the post of Kanungo (BPS-11).
  - (ii) Incorrect. That Notification dated: 22/10/2011 regarding foregoing seniority has been deleted vide Establishment Department Notification No dated:06/08/2020 as annexure "R".
  - (iii) That as per Board of Revenue Service Rules there is no time frame for passing of Kanungo Exam for promotion.
  - (iv) Incorrect. That as per Notification / instruction issued from NWFP Revenue & Estate Department already annexed above, the initial recruitment is through test/interview and not from old patwar register. Therefore, the Appellant Kashif Jamal was considered for recruitment by DSC but at that time he was overage and deferred from the post of Patwari. Respondent No 6 Mr. Miraj was selected by DSC so Respondent No 6 recruited earlier and senior to appellant and deserved promotion.

- (v) That as per Board of Revenue, Service Rules Notification No 1942/Estt: I/135/SSRC dated: 23/01/2015 (annexed I). The criteria for promotion to the post of Kanungo are as "By promotion on the basis of seniority-cum-fitness, from amongst the Patwaris and Naib Office Kanungos of the district concerned with three years service as such and who have passed the Departmental examination of Kanungo". So, there is no time frame of passing of Kanungo exam.
- (vi) It is pertinent to mention here that no doubt the appellant case regarding his seniority list is in trial in the Honourable Court of Service Tribunal Khyber Pakhtunkhwa Peshawar but his seniority issue is purely with the official named Mr. Sanazeb Patwari (BPS-09) who has neither promoted to the next higher rank nor even considered to be promoted and appellant has also not provided any Status Quo order from Honourable Service Tribunal Peshawar. Moreover, the appellant was posted as ADK on temporary basis due to exigency and was reverted to his actual post.

That the Departmental Promotion Committee legally, as per law/rules declared Respondent No 4 to 6, fit for promotion and promoted to the post of Kanungo (BPS-11). Furthermore, appellant Date of Birth is 15/03/1975 and Date of. Appointment as Patwari is 10/7/2006. There were some posts of Patwari laying vacant in this office and as per NWFP Revenue & Estate Department Notification dated: 27/11/2001, patwar pass candidates were called for appointment by DSC as already enlisted candidates. The appellant at the time of recruitment was considered by the DSC for appointment but two patwar candidates including appellant, were found overage. The appellant was overage candidate by 01 year and 01 month due to which he was deferred by DSC and other eligible candidates were appointed for the post of Patwari as annexure "S" and appointment order is "T". Furthermore, as per 3.6 Land Record Manual, the candidates whose name was entered in the Patwar Pass Candidates Register cannot claim his enlistment for appointment on priority basis as annexure "U". That the Seniority list was prepared on the basis of initial recruitment as per rules framed in Civil Servants (Appointment, Promotion and Transfers) Rules 1989 and Service Rules frame for appointment of Revenue Staff by NWFP Revenue & Estate Department notification dated: 27/11/2001 as annexure "V".

- C. Incorrect. That all the Patwaries who have been considered for promotion are senior to appellant and the promotions of all officials are according to law/rules.
- D. Incorrect. That the appellant is Junior official to Respondent No 4 to 6 (Mr. Safder Rehman, Mr. Musharraf Masood and Mr. Miraj Khan) as per Date of Appointment which

is based for promotion to the post of Kanungo and that time was not fit for promotion. Therefore, no irregularity, no favoritism, injustice were occurred by this office. The Departmental Promotion Committee after careful perusal of record, free, fair and transparent and as per law/rules declared Respondent No 4 to 6 fit for promotion and promoted to the post of Kanungo (BPS-11) are liable to be maintained. Therefore, appellant has been treated in accordance with rules and Respondents raised additional grounds at the time of arguments.

In view of the above, that the Departmental Promotion Committee, after careful perusal of the available record, Notification, Seniority, Service Rules and other relevant documents (already annexed above), promoted the Respondents 4 to 6 and issued Order dated 11/12/2020, according to law/rules and the same is requested to be maintained as no injustice, violation of rules and malafide intension was occurred / involved by this office. Therefore, it is prayed that no substance is available in the case and appeal of the appellant may be dismissed / rejected.

#### **GENERAL**

- 1. **Short title and commencement:** (1) These rules may be called the <sup>2</sup>[Khyber Pakhtunkhwa] Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.
  - (2) They shall come into force at once.
- 2. **Definitions:-**(1) In these rules, unless the context otherwise requires:-
  - (a) "Appointing Authority" in relation to a post, means the persons authorized under rule 4 to make appointment to that post;
  - (b) "Basic Pay Scale" means the Basic Pay Scale for the time being sanctioned by Government, in which a post or a group of posts is placed;
  - (c) "Commission" means the <sup>3</sup>[Khyber Pakhtunkhwa] Public Service Commission;
  - <sup>4</sup>(d) "Departmental Promotion Committee" means a committee constituted for making selection for promotion or transfer to such posts under a Department, or offices of Government, which do not fall within the purview of the Provincial Selection Board;
- <sup>5</sup>(dd)"Departmental Selection Board" means a Board constituted for the purpose of making selection for initial recruitment /appointment to posts under a Department or office of Government in Basic Pay Scale 17 not falling within the purview of the Commission:

Provided that more than one such committees may be constituted for civil servants holding different scales of pay".

- (e) "Departmental Selection Committee" means a committee constituted for the purpose of making selection for initial appointment to posts under a department, or office of Government [in Basic Pay Scale 17 and below not falling within the purview of the Commission];
- (f) "Post" means a post sanctioned in connection with the affairs of the Province, but not

#### PART-VI

#### SENIORITY

- 17. **Seniority :-(** 1) the seniority inter se of civil servants <sup>50</sup>(appointed to a service, cadre or post) shall be determined:-
  - (a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission <sup>51</sup>[or as the case may be, the Departmental Selection Committee;] provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection; and
  - (b) in the case of civil servants appointed otherwise, with reference to the date of their continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post,

**Explanation-I:-** If a junior person in a lower post is promoted to a higher post temporarily in the public interest, even though continuing later permanently in the higher post, it would not adversely effect the interest of his seniors in fixation of his seniority in the higher post.

**Explanation-II:-** If a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted the person promoted first shall rank senior to the person promoted subsequently; provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for the time being for want of certain information or for incomplete record or for any other reason not attributing to his fault or demerit.

**Explanation-III:-** A junior person shall be deemed to have superseded a senior person only if both the junior and the senior persons were considered for the higher post and the junior person was appointed in preference to the senior person.

- (2) Seniority in various cadres of civil servants appointed by initial recruitment vis-à-vis those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that cadre; provided that if two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment.
- <sup>52</sup>(3) In the event of merger/restructuring of the Departments, Attached Departments or Subordinate Offices, the inter se seniority of civil servants affected by the merger/restructuring as aforesaid shall be determined in accordance with the date of their regular appointment to a cadre or post.
