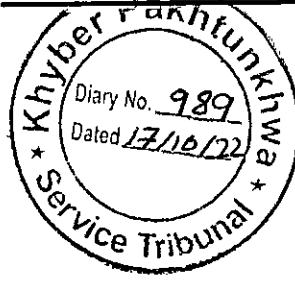

1. That the above titled petition was pending adjudication before this Honourable Court which was fixed for arguments on 18.01.2022.


