PRELIMINARY OBJECTIONS.

- 1. That the appellant has not filed departmental appeal at all, hence, the appeal in hand is not maintainable.
- 2. That the appellant desires to be adjusted against wrong post, hence the appeal is not maintainable.
- 3. That the appellant has filed the instant appeals at much belated stage, which is clearly hit by the doctrine of laches. Therefore, this appeal is not maintainable and is liable to be dismissed.
- 4. That the service appeal 468/2022 was dismissed as withdrawn by this Honourable Tribunal vide order dated 31/10/2022, the appellant filed another appeal No.1651/2022 and the instant service appeal with the same prayer, facts and grounds, thus the instant appeals before this Honourable Service Tribunal are badly barred by time and hit by the principle of resjudicata, therefore, the appeals are not maintainable and liable to be dismissed.
- 5. That the service appeal is wrong, baseless and not maintainable, it shows no strong cause to be taken for adjudication, therefore, the same service appeal is liable to be rejected/ dismissed.
- 6. That the service appeal is unjustifiable, baseless, false, frivolous and vexatious. Hence the same is liable to be dismissed with the order of special compensatory cost in favour of respondents.
- 7. That no constitutional or legal right of the appellant has been violated, therefore, the appellant is not entitled to invoke the constitutional jurisdiction of this honourable Service Tribunal under Article 212 of the constitution of Pakistan.
- 8. That the appellant has not come to the Court/Tribunal with clean hands.

- 9. That the appellant has concealed the material facts from this Honourable Tribunal.
- 10. That the appeal is bad for misjoinder and non-joinder of the necessary party.
- 11. That the appellant has filed the instant appeal just to pressurize the respondents.
- 12. That the appellant has no cause of action to file the instant appeal.
- 13. That the appeal is not maintainable in the eye of law.
- 14. That the instant appeal is not maintainable in the present form and also in the present circumstances of the issue.

Facts:-

The most important note about the issue.

The appellant filed Service appeal No. 468/2022, with the prayer which is reproduced as,"That on acceptance of this appeal the impugned order dated 13/12/2017 may very kindly be modified/rectified to the extent of promotion of the appellant to the post of SCT (BPS-16) w.e.f. 24/04/2016 instead of 13/12/2017 with all back benefits. The respondents may further please be directed to enlist the name of appellant on her correct seniority position below the name of Mst.Ramim Begum as per seniority list issued on 11/02/2019. Any other relief which this August Tribunal deems fit that may also be awarded in favour of the appellant," the same was withdrawn vide order sheet dated 31/10/2022 annexed as H at page 23 to 24 with memo of the Service Appeal No.1651 of 2022. The appellant filed a fresh Service Appeal No.1651/2022 with the same prayer which is reproduced as, "that on acceptance of this appeal the impugned order dated 13/12/2017 may very kindly be modified/rectified to the extent of promotion of the appellant to the post of SCT (BPS-16) and the appellant be promoted against the same post w.e.f. 26/06/2016 with all consequential benefits. Any other relief which this August Tribunal deems fit that may also be awarded in favour of the appellant," The next date fixed for hearing is 13/06/2023, that the appellant also filed the instant Service Appeal No. 1864/2022 with the same prayer facts and grounds, therefore, this para-wise comments may also be considered for Service Appeal No. 1651/2022, fixed for hearing before this Tribunal on 13/06/2023. They may also be clubbed.

That the appellant filed the same appeal with the same prayer, facts and grounds under Service Appeal No.468/2022, which was dismissed as withdrawn vide this Honourable Service Tribunal order dated 31/10/2022. Thus the instant Service Appeal before Honourable Service Tribunal is barred by the principles of resjudicata and is liable to be dismissed. That repetitive, frivolous and fraudulent litigation after final adjudication of matter has no legal backup; same is reported in 2011 SCMR 27. It is a well settled principle of interpretation of notification and/ or an executive order that the same can operate prospectively and not retrospectively. If it is violated, it would tantamount to opening a floodgate for all similarly placed persons Reliance is placed on PLD 1997 SC 315 and 2021/SCMR 124. Civil appeal No. 511/2021 is the fresh judgment in this regard. That the written certificate with signature at page 05 of memo of appeal no. 1651/2022 is exist which is reproduced as," it is, certified that no other earlier appeal was flied between the parties" but actually S.A No. 468/2022 was filed between the parties. Furthermore, the said certificate is also exist at page no 07 of memo of appeal



No

No.1864/2022, which amounts unclean hands, false and concealment of facts in part of the appellant. This ground alone is sufficient to dismiss the appeal with special compensatory cost in favour of the department, being not maintainable.

- 1. That the appellant was initially inducted in the Elementary & Secondary Education Department, Khyber Pakhtunkhwa, against CT BPS-09 post as untrained @ of Rs. 1605/- per month fixed vide Directorate of Education FATA, NWFP, Peshawar Endst:No.18226-27, dated Peshawar the 06/08/1995. It is pertinent to mention the post of CT is a District cadre post, the appellant hails from District Swabi while appointed at Bajaur Agency, which is quite objectionable. As for as her performance of duty at Bajaur is concerned, the respondents are not in the position to say any thing about that, because the appellant has not arrayed as respondent the concerned forum in the list of respondents. She got the requisite professional qualification prescribed for initial recruitment i.e CT on 31/03/2001. She was regularized in service on 31/03/2001 at Bajaur Agency, because regular appointment means an appointment of a duly qualified person in the prescribed manner in accordance with law, rules, regulation & policy, which standard was evidently lacking in case of the appellant till 30/03/2001. After passing the CT course on 31/03/2001, she was accordingly regularized in service; therefore, she was given her due position in the CT seniority list at Bajaur Agency. She was transferred from Bajaur Agency to District Swabi. Therefore she was placed at the bottom of Seniority list of CT. As per judgment, 1983 PLC (C.S) 730, "if a civil servant is transferred from one office to another at her own request, she may lose the benefit, for the purpose of seniority, of the services rendered in the former office." She was upgraded from CT BPS-16 to CT BPS-16 vide order Endst:No.1513 dated Swabi the 12/04/2016 at S.No.7. She claims her seniority in between Rameem Begum and Nishat Begum vide promotion order dated 26/04/2016 in the Seniority list, which is unsigned. Different cadre could not be included in the same seniority. Reliance is placed on 1993 PLC (C.S) 14. Promotion is not a vested right of a civil servant. Same is reported in 2002 SCMR 1056. The two teachers in question were SCT while the appellant was CT at that time. The cadre was different; therefore, the seniority shall also different. The stance of the petitioner is conjectural, contemptuous, surmise, vexatious, false, baseless and ludicrous. It is pertinent to mention that the appellant is availing the financial benefits of BPS-16 with effect from 01/07/2015. Judgment in SA 11/2015 dated 13/06/2016 and up gradation order dated 12/04/2016 annexed as A & B.
- 2. That the appellant was transferred from Bajaur Agency to the District Swabi vide order dated 18/04/2003. As per Khyber Pakhtunkhwa Civil Servants (appointment, promotion and transfer) Rules, 1989, 8(2), which is reproduced as ,"A person so transferred shall be placed at the bottom of the cadre strength which she joins for the purpose of determining her seniority viz.a-viz other members borne on the cadre," therefore, the appellant was entitled for seniority in CT cadre



w.e.f. 18/04/2003 instead of 31/03/2001. Furthermore, it is mandatory for each and every Government Servant to perform her duty with all zeal and zest because she is paid from the Government exchequer for her job.

- 3. That as per rule 8(2) of the Khyber Pakhtunkhwa Peshawar Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, she is the junior most CT of all the CT employees appointed in District Swabi till 18/04/2003. The appellant was promoted from CT to SCT vide order dated 13/12/2017 and was rightly placed at serial number 143 in the final seniority list, stood at 31/01/2021 and in subsequent final seniority list of SCT stood on 31/03/2022, she was placed at S.No.128 in that seniority list. The two teacher in question were promoted from CT to SCT vide order dated 26/04/2016 while the appellant was promoted from CT to SCT vide order dated 13/12/2017. The appellant is trying to obtain benefit of unsigned seniority list of 2019 and did not challenge the seniority list stood on 31/01/2021. She challenged an unsigned list of 2022. Therefore, the stance of the appellant is, illegal, unlawful, mind bugling, un-ethical, irrational, un-human, and frivolous baseless. false. surmise. contemptuous, vexatious and ludicrous.
- 4. That as discussed in length above, the appellant did not impugn the proper seniority list duly signed by the authority, wherein her correct position in the 31/01/2021 seniority list is 143 while in the seniority list stood on 31/03/2022 is 128. No junior colleagues have been marked senior to the appellant. The seniority has been determined under rule 17 (b) of the Khyber Pakhtunkhwa Civil servants (Appointment, Promotion and Transfer) Rules, 1989.
- 5. That the appellant annexed a page 21 as annexure D, with memo of appeal is claiming her departmental appeal with subject "appeal for promotion w.e.f. 26/04/2016 and correction of seniority, The date under signature is 13/12/2021, which shows it is badly barred by time. Furthermore, it is not a departmental appeal at all because she did not submit/hand over it to anyone. On the basis of this un-authentic documents, she filed an incompetent service appeal with prayer," that

on acceptance of this appeal the impugned order dated 13/12/2017 may very kindly be modified/rectified to the extent of promotion of the appellant to the post of SCT (BPS-16) w.e.f. 26/04/2016 instead of 13/12/2017 with all back benefits. The respondents may further please be directed to enlist the name of appellant on her correct seniority position below the name of Mst. Ramim Begum as per seniority list issued on 11/02/2019. Any other relief which this August Tribunal deems fit that may also be awarded in favour of the appellant." The appellant with drawn this appeal dated 31/10/2022. Astonishingly, the annexure-G page 31 with memo of appeal with date 02/09/2022 addressed to the Director Elementary & Secondary Education Khyber Pakhtunkhwa, Peshawar is not a departmental appeal at all because she did not submit/handover it to any of the Government authority. It has no legal back up because on the same stance the S.A No.468/2022 was pending before the Honourable Service tribunal for adjudication. In the instant S.A the appellant left her stance/plea," she may be promoted w.e.f. 26/04/2016 instead of 13/122017 with all back benefits,: Thus she herself admitted that she is rightly promoted from CT to SCT w.e.f. 13/12/2017," Therefore, the prayer in the instant service appeal is illegal and unlawful. As per rule 17(b) of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989," if a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted, the person promoted first shall rank senior to the person promoted subsequently," The service appeals are also badly barred by time, Departmental appeal was not availed, so the appeal in the Tribunal not maintainable. Reliance is placed on PLJ 1991 Te.c(Service)153: 1992 PLC (C.S) 666, 1994 PLC (C.S) 1262 PLC (C.S)606. No scope for repeated appeals/representations available to the Civil servant and the period of limitation could not be extended by repeated representations Reliance is placed on 2001 SCMR 912, 2004 SCMR 497, 2009 PLC (C.S) 89 and 2007 PLC (C.S) 15. The plethora of judgments of the August Apex Court of Pakistan the petitions are dismissed as barred by time." The seniority list annexed with memo of appeal i.e 2019 & 2022 are Returnist (Errice)

unsigned and unauthentic. These seniority lists denied outright.



That the appellant did not file any departmental appeal against the final seniority list of 2021 & 2022. The stance of the appellant is conjectural, surmise, contemptuous, frivolous, baseless, false and ludicrous. Seniority lists 2021, 2022 & Notifications of promotion annexed as C, D & E.

That the appellant was not in a promotion zone, therefore, she was not rightly promoted. The appellant is trying to create her right of promotion, which has no legal back up at all. She wants to lead the department by it nose. She is throwing arrows in the dark. She is talking argy bargy, just for creation of her right of promotion illegally and unlawfully. It is a well settled principle of interpretation of notification and/or an executive order that the same can operate prospectively and not retrospectively. Same is report in PLD 1997 SC 315. It is also held that notification and/or executive order can operate prospectively and not retrospectively. Reliance is placed on Civil Appeal No.511/2021 in WP No.3111-P/2020 PHCP.

6. That the appellant is not an aggrieved person because Civil Servant cannot ask for promotion as a right and granting or refusal of promotion is a matter, which is within the exclusive domain of the government/executive authority. If promotion is denied to a Civil Servant it could not be termed as denied of any fundamental right. There is no fundamental right with regard to the posting, transfer or promotion as such. Reliance is placed on 2003 PLC (C.S) 2012, 2003 PLD SC 110 and 2009 SCMR 61. The appellant has no cause of action to file the instant appeals and the appeals in hand are liable to be dismissed on the above facts and circumstance.

Grounds:-

A. Incorrect, hence denied. The final seniority lists issued in 2021 & 2022 are in accordance with law, rules, facts, policy, norms of natural justice and materials on record hence tenable and liable to be kept intact Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion



and Transfer) Rules, 1989, Rule 17 (b) has been implemented in the preparation of this seniority list.

- B. Incorrect, hence denied. The appellant has been treated by the respondent department in accordance with law,, rules, policy, facts and norms of justice. Thus the question of violation of Article 4 and 25 of the constitution of Islamic Republic of Pakistan, 1973 can not arise.
- C. Incorrect, hence denied. The final seniority lists 2021 & 2022 are in accordance with the real soul of rule 17 (b) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, these rules were in field at the time for the determination of seniority.
- D. Incorrect, hence denied. The respondent department acted in just, transparent and bonafied manner while issued the final seniority list circulated in the year 2021 & 2022, which is effective upon the rights of the appellant as well as all the private respondents, therefore, tenable and liable to be kept intact.
- E. Incorrect, hence denied. The respondents did not discriminate the appellant amongst her colleagues by enlisting her name on correct position of the final seniority list 2021 & 2022. The seniority list annexed with memo of appeal is a false unverified and unrecognized document.
- F. Incorrect, hence denied. The appellant was placed at her correct position in SCT final merit list 2021 & 2022. As per rule 17 (b) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 her correct position in the SCT final merit list 2021 is 143 while in 2022 is 128. How it will be ludicrous that a candidate promoted to SCT in 2017 be kept prior in merit position from the candidate who is promoted in 2016," The SCT final merit lists 2021 & 2022 are prepared as per provision/mandate of the rule 17(b) of the Khyber Pakhtunkhwa Civil Servants (Appointment,





Promotion and Transfer) Rules, 1989 being in field. No junior is marked senior than the appellant in the SCT final merit list 2021 & 2022. The stance/plea of the appellant is conjectural, contemptuous, ludicrous, frivolous, vexatious, baseless, false and mind bugling. Therefore, the same is tenable in the eye of law and liable to be kept intact.

- G. Incorrect, hence denied.
- H. Incorrect, hence denied.
- I. That the respondents seek permission to raise/argue other points/grounds at the time of hearing the case.

In view of the above stated submissions, it is earnestly requested that the appeal may very graciously be dismissed with special compensatory cost in favour of the respondents.

PIR BAKHSH-SHAH, MEMBER: Admittedly, the appellant was appointed as untrained PTC Teacher on 29.10.1989 and his name was included in the seniority list of PTC Teachers when he passed PTC examination on 24.12.1993. He has brought this service appeal for the following prayer:-

or rule in respect of not considering untrained service towards seniority be set aside, declare discriminatory, arbitrary, void abinitio and the appellant untrained service w.e.f 01.11.1989 be considered towards seniority, consequent thereof the appellant be given seniority w.e.f 01.11.1989, the (date when the appellant was regularly appointed) with all consequential benefits."

2. Arguments heard and record perused.

- Learned counsel for the appellant argued that the department has wrongly considered regular appointment of the appellant w.e. from 24.12.1993 the date on which appellant passed his PTC course and his service period as untrained teacher was wrongly ignored which started from 29.10.1979. He submitted that even the first appointment of the appellant on 29.10.1979 was a regular appointment when seen in the light of the Finance Department Notification dated 30.03.2009 and dated 12.10.2009. He submitted that by way of the said notifications the untrained teaching period was excluded only for the purpose of arrears of the increments and allowances but once the graded pay was allowed to the appellant from the date of their first appointment on 29.10.1979 so his seniority cannot be refused to the reckoned from the said date.
- 4. The appeal was resisted by learned Government Pleader on the ground that the above referred notification were valid to the extent of the graded pay and by no stretch of imagination those could be stretched to include regular appointment of the appellant. He submitted that the appellant was appointed on contract basis, on fixed pay, and he was never regular appointed much less in the prescribed manner in accordance with rules. He further submitted that the subject matter of this appeal is seniority but it is evident that no private respondents who now stands senior to the appellant, have been made party in this appeal. He submitted that being devoid of merits, the appeal may be dismissed.

We have heard pro & contra arguments at length and have carefully perused the record. Ordinarily on a post for which a certain special training/examination is must so such appointment without such course/examination cannot be treated as a regular examination. The admitted position in this case is that the appellant was initially appointed as untrained teacher. He was appointed against a fixed pay. There is no legislation or notification from the respondents side specifying in particular that appointment of the PTC Teacher (appellant) will be regular appointment from the date of their first appointment. The Tribunal is afraid to subscribe to the view of the learned counsel for the appellant that in the light of the referred notifications the appellant became regular servant from the date of their first appointment. A regular appointment means an appointment of a duly qualified person in the prescribed manner in accordance with the law and rules which standard is evidently lacking in case of the appellant. After passing the PTC course on 24.12.1993 it seems that the appellant was accordingly regularized in service, therefore, he was given his due position in the seniority list after his regular appointment which step is in accordance with the law and the rules on the subject. In the light of the foregoing discussion, the Tribunal is of the considered view that being devoid of merits, the instant appeal is liable to be dismissed. The same is therefore, dismissed. Parties are left to bear their own cost. File be consigned to the record room.


