**PARAWISE COMMENTS ON BEHALF OF RESPONDENT NO. 1 TO 3**

**Respectfully Sheweth:-**

**Preliminary Objections:-**

- i. That the appellant has got no cause of action to file the appeal.
- ii. The appellant has got no locus standi to file the instant appeal.
- iii. That the appellant is estopped to file the instant appeal.
- iv. That the appeal is bad for misjoinder and nonjoinder of necessary parties
- v. That the appeal is bad in eyes of law and not maintainable.
- vi. That the appellant has not approached the honorable Tribunal with clean hands.
- vii. That the appeal is **badly barred** by law and limitation.

**Facts:-**

1. Pertains to service record of the appellant.
2. Completion of prescribed training of appellant is mandatory as per Rule 19.25 of Police Rules-1934.
3. The appellant is initially appointed as Probationer Assistant Sub Inspector on date **28.02.2009**, on completion of his mandatory training, probationary period and courses provided under Rule 19.25 of Rules ibid, the appellant is **confirmed in the rank of ASI from the date of his initial appointment on 28.02.2009** and brought of List E vide order of Respondent No. 2. The appellant has been granted due seniority, treated in accordance with the rules and has not been deprived from his legal rights. Hence, para C of the memorandum of appeal is unjustified and without any substantiate.

4. All officials of the rank of appellant and he have been treated in accordance with the relevant rules *ibid*. The appellant has neither identified / clarified the names of Police officers from whom promotion and seniority he is aggrieved?, from where the appellant has been deprived?, nor he has challenged any order of promotion, notification of seniority list. The appellant is treated in accordance with chapter 13 of Police Rules 1934. Furthermore, the seniority and probation is maintained in accordance with Rule 12.2 (3) of the Rules *ibid* which is reproduced as under:-

**12.2. Seniority and probation:-**

(3). *All appointments of enrolled Police officers are on probation according to the rules in this Chapter applicable to each rank. Seniority to the case or upper subordinates, will be reckoned in the first instance from date of first appointment, officers promoted from a lower rank being considered senior to persons appointed direct on the same date, and the seniority of officers appointed direct on the same date being reckoned according to age, seniority shall, however be finally settled by dates of confirmation, the seniority inter se of several officers confirmed on the same date being that allotted to them on first appointment: Provided that any officer whose promotion or confirmation is delayed by reason of his being on deputation outside his range or district shall, on being promoted or confirmed, regular the seniority which the originally held vis-à-vis any officers promoted or confirmed before him during his deputation.*

In view of the above, the plea advanced by the appellant is incorrect, unjustified / un-clarified and based on mere surmises and conjunctures.

5. The appellant has not been discriminated and treated in accordance with rules. The appellant has admitted redressal of his grievances and expressed his satisfaction on confirmation and due seniority vide **revised seniority** list No. 4844-58/EC dated 29.05.2017 issued by respondent No. 2. The appellant being aggrieved from seniority list issued by respondent No. 2 vide Endst No. 1093-1105/EC dated 02.02.2016, approached in service appeal No. 588/2015. During pendency of the said service appeal the respondent No. 2 issued or revised seniority list No. 4844-58/EC dated 29.05.2017 and the appellant is assigned due seniority. During the course of hearing before this Honorable Tribunal, the appellant had also expressed his satisfaction over the revised seniority list on the basis of which the appeal was disposed of by the Honorable Tribunal vide judgment dated 01.11.2019 and the said fact has been reflected in the judgment. Thus in view of above legal position the matter falls under the ambit of *resjudicata*.  
**Copy of revised seniority list is annexure A.**

6. The appellant has admitted redressal of his earlier grievance and expressed satisfaction over the revised seniority list under Rules 12.2(3) & 13.18 was issued by respondent No. 2. The remaining para of the memorandum of appeal is incorrect and against the rules. The appellant and all PASIs & promotees ASIs are brought on List E with immediate effect and their seniority is fixed in accordance with Rules 12.2(3). The contention of appellant to bring him on list E with retrospective effect is not justified as per rules ibid and according to decision / guidance of a high level committee of Central Police Office, Peshawar. **Copy of decision is "annexure B"**. Further, promotion to the next rank (offig: SI) is subject to qualifying the requisite mandatory courses, training, period and occurring / availability of vacancies in the respective ranks in the Region. The appellant has been **promoted to the rank of officiating sub inspector** on due course of time vide order dated 17.10.2017, **confirmed in said rank** vide order dated 06.11.2020. The appellant has also been brought on **list F** vide order dated 15.09.2021 and his name is placed at S. No. 1236 of the seniority list issued by respondent No. 1, therefore, promotion to the rank i.e officiating Inspector shall be carried out at Central level according to seniority list, occurring of vacancies, seniority cum fitness and on his own turn. Copies of promotion (offig: SI), confirmation (SI), and seniority list F (relevant page) are **annexure C, D & E**.
7. Para No. 7 of appeal is unjustified and merely based on presumption. However, again stated that the appellant has been brought on promotion List "F" vide notification dated 15.09.2021 of respondent No. 1 and his promotion to the next rank will be considered subject to fulfilling the required criteria, occurring of vacancies in the rank of officiating inspector, seniority-cum-fitness and on his own turn. In this regard detail reply has been submitted in para No. 6.
8. Detail reply has been submitted in paras No. 6 & 7. However, it is again added that the appellant is promoted to the rank of officiating SI, confirmed in the said rank after fulfilling the required criteria under Rules 19.25 A of Police Rules 1934 (Amended-2017) and brought on promotion List F under Rule 13.15. Further promotion of appellant to the rank of officiating inspector is subject to seniority cum fitness and on his own turn. The appellant has annexed seniority list of the year, issued on **21.07.2020** as annexure "B" of this appeal, while annexure "E" of the comments is fresh seniority list is issued on **19.09.2021**, wherein his name is stood at S. No. 518 (F list of Sub Inspector annexed "A") vide No. 422/P-E-II, dated 01.12.2022 and according to Rules 13.15(4) of the Rules ibid, seniority in list "F" will be in accordance with the date of entry in that list i.e list "F".

9. Pertains to record, however, it is submitted that according to Police Rules 13.9 & 13.10, lists D & E shall be maintained by each Deputy Inspector General of Police. In view of rules ibid, each Police Region in Khyber Pakhtunkhwa has maintained its own lists ibid in their respective Region. Therefore, the grievances of officials of other district / Region if any do not relate to appellant and the writ petition mentioned in para 9 of appeal is neither related to appellant, nor to Kohat Region.
10. As replied in para No. 9 in the instant petition, the Honorable Court passed direction to the concerned / specific unit for implementation of committee recommendation on the issues, pertaining to concerned officials / unit. Further the appellant was not a party in the said petition, nor any direction is issued to Kohat Region i.e Respondent No. 2. Thus the order / judgment of Peshawar High Court passed in writ petition No. 3720-P/2018 is in personam in nature and not applicable to Kohat or other Police Region in different issue.
11. Not related to appellant and respondents as well. Reply in detail is submitted in para No. 10.
12. Incorrect, the case of appellant is not identical in nature of cases of the officials, of other districts / CCPO / Region. The appellant had filed representation to respondent No. 2, which has been rejected with a speaking order. Further added that the appellant has already been brought on promotion List "F" and further promotion will be made on his own turn according to seniority list "F" maintained at Central Level i.e Central Police Office, Peshawar. Thus the appellant has got no cause of action.
13. Pertains to record, however, it is added that the instant appeal is bad in eyes of law / rules.
14. The instant appeal is badly time barred and liable to be dismissed on limitation.
15. As replied in above paras.


**Grounds:-**

- A. Incorrect, the appellant has been treated in accordance with the rules. Detailed reply has been submitted in facts of the comments. However, again it is stated that the appellant has been confirmed in the rank of ASI from the date of his initial appointment promoted to the rank of officiating SI, confirmed in the same rank and brought on List "F" after completion of mandatory training, courses, tenure period and occurring of vacancies. The appellant has already brought in list F. Hence, his grievances have already been resolved, while further promotion to the rank of officiating Inspector is subject to suitability-cum-fitness and occurring of vacancies at Central level.
- B. Each and every case has its own facts and merits. The citation of judgment of august court referred by appellant is not applicable at the instant case.

- C. Incorrect, para "C" of the appeal is general in nature and based on presumption. **The appellant has not pointed out / identified any officer joiner to him is promoted from where he is aggrieved or ignored from his right.** Again stated that confirmation and promotion is carried out in accordance with the rules. **The appellant has been confirmed, promoted to the rank of SI and brought on List "F" in accordance with the relevant rules.**
- D. Para D of the appeal is a repetition and reply has already submitted in facts of the comments.
- E. As replied above, confirmation and promotion from the rank of List D & E is made by each Region according to available vacancies and each Region has their own lists ibid, while List "F" for further promotion to the rank of officiating inspector is maintained at Central Police Office level wherein the name of appellant has already been brought on list "F" for further promotion on his own term and availability of vacancies.
- F. As replied in above paras.
- G. As replied in above.
- H. The respondent may also be allowed to advance other grounds during the course of arguments.

In view of the above, it is submitted that the appeal contrary to facts, law & rules, devoid of merits, not maintainable and badly time barred, may graciously be dismissed with costs.
