# PARA WISE COMMENTS ON BEHALF OF RESPONDENTS.

# PRELIMINARY OBJECTIONS.

- 1) That the service appeal is not maintainable in its present form.
- 2) That the appellant has not come to this honourable Service Tribunal with clean hands.
- 3) That the present Service appeal is badly barred by law and limitation.
- 4) That this honorable Service Tribunal has got no jurisdiction to entertain the present service appeal.
- 5) That the appellant has suppressed the material facts from this honorable service tribunal.

# ON FACTS:

- 1. Correct to the extent that the appellant was enlisted as constable in the year 2010, the
- rest of para is incorrect. Further the entire service record of appellant is tainted with bad entries. The appellant was directly charged vide FIR No 107 dated 13.10.2020 u/s 337(i) 25 (D), Telegraph Act Police Station Talash and later on acquitted the basis of compromise. Furthermore the appellant is habitual absentee, as he deliberately failed to join duty. So for as the domestic problems of the appellant are concerned, the official record of the replying respondents is silent. (Copies of FIR, Court order & bad entries
- : are attached as annexure "A"- "B" and "C")
- 2. Incorrect, the reply of appellant to the show cause notice was found not satisfactory having no relevancy with the facts and nature of the case. (Copy of reply enclosed as annexure "D")
- 3. Needs no comments.
- 4. The appellant acquitted by the honourable court u/s 249 A CrPc, in the criminal case vide FIR No.107 dated 13.10.2020 u/s 337 (i) 25 (D), Telegraph Act 1885 Police Station
  - Talash on the base of compromise.
- 5. Incorrect, all the codal formalities have been fulfilled by the respondents in the departmental proceedings against the appellant. The appellant was issued show cause

notice and ground of action to explain reasons behind absence. The reply was found not satisfactory and he was provided opportunity of personal hearing, to defend himself but he failed to advance any plausible reasons about the absence. Departmental enquiry has been conducted against the appellant and after scrutiny of record; the appellant was dismissed from service. (Copy of show cause notice, ground of action, , finding report and dismissal order enclosed as annexure "E"- "F"- "G"- "H")

- Incorrect, the departmental appeal of the appellant was filed by the respondent No. 02 on solid reasons keeping in view his previous record. (Copy of order is attached as annexure "I")
- 7. The appellant has no cause of action to file the instant service appeal & inter aliaapproached this Honourable Tribunal with unsound grounds.

#### **GROUNDS**

- A) Incorrect, the order dated 01.03.2021 was issued in accordance with law and no violation of law has been committed by the respondents. The appellant remained absent w.e.f 27.01.2021, till date of dismissal therefore he was dismissed from the date of absence. Furthermore each and every case has its own facts and merits; hence the quoted judgments/ precedents are not applicable in the case in hand.
- B) Incorrect, the appellant released on bail in the year 2020, while he absented himself from his lawful duty in the year 2021 intentionally without any plausible reasons. Furthermore the appellant dis-obeyed the orders of his senior command and failed to join new place of posting. He is required to seek leave or permission from his seniors and also to join new/place of posting being member of disciplined police force, but he failed to do so, hence proceeded against the appellant departmentally as per law/ rules.
- C) Incorrect, show cause notice and ground of action was issued to the appellant and duly served upon him. His reply was found not satisfactory. No violation has been committed by the respondents in the whole proceedings.
- D) Incorrect, inquiry has been conducted and the appellant was provided opportunity of hearing but he failed to advance any good reasons in self defence. As discussed above that each case has its own facts and merits.
- E) Incorrect, the appellant was heard in person to defend himself but he failed to advance any cogent reasons regarding his willful absence.
- F) Incorrect, all the codal formalities have been fulfilled before issuance of order.
- G) The respondents also seek leave of this honorable Tribunal to rely on additional grounds at the time of arguments/ hearing.



Hence, keeping in view the above circumstances, although, the offences u/s 25-D Telegraph Act is not compoundable, however, the complainant party has compromise with the accused in the principle offence, therefore, section 25-D Telegraph Act is merged. Moreover, the factum of above mentioned compromise has rendered conviction of the accused improbable in due course of trial even if all the PWs are examined. Moreover, in the light of judgment of Honourable Peshawar High Court (PLD 2016 Peshawar 26). The parties in this case too have decided to live in peace by forgetting their differences, then acquittal is the proper way despite the fact that the offenses are non compoundable.

Therefore, on acceptance of the compromise, the accused Hasan Sardar and Ilyas Sardar sons of Bakht Sardar are hereby acquitted of the charges levelled against them u/s 249-A CrPC.

Sureties of the accused are discharged of their liability of bail bonds. Case property, if any, shall be dealt with in accordance with law.





This Order will dispose of appeal of Ex-Constable Ilyas Sardar No.580 of Dir Lower of District for reinstatement in service.

Brief facts of the case or the Ex-Constable Ilyas Sardar No.580 while posted to police post Shidas of Police station Lala Qila appear before the DPO, Dir Lower on 16.02.2021 in connection with absence/suspension. Prior to this he was remind absent from duty with effect from 11.01.2021 to 31.01.2021 (Total 21 days). He was transferred from police line Timargarah to PPA shidas vide DD No. 54 dated 01.02.2021 but he intentionally failed to. insure his presence at new place of posting in did not join his duty. He dis obedience and unprofessional attitude on his part. He was issued show cause notice No.23/EB dated 16.02.2021 through LO Police line Timargarah the reply which was received on 22.02.2021 he was called in orderly from on 03.03.2021 for personal hearing and found unsatisfactory. Full opportunity was giving to him to explain his position but he failed to produce any cogent reason in his self defence nor satisfy the DPO. Being found guilty of the charges leveled against him, the District Police Officer, Dir Lower awarded him major punishment of dismissal from service from the date of his absence 27.01.2021 with immediate effect vide QB No.290, dated 11.03.2021.

He was called in Orderly Room On 21/.04.2021 and heard him in person. The appellant could not produce any cogent reason in his defence. Service record of the appellant shows that he samed 39 had entry in his service. Which clear cut show his inefficiency and disinterest in Police job.
