PRELIMINARY OBJECTION

1. That the instant appeal is badly barred by time and not maintainable to appeal rules. Hence liable to be dismissed.

PARA WISE COMMENTS ON BEHALF OF RESPONDENT NO. 1 TO 4.

Respectfully shewith

The respondents submit as under:

1. That this para is admitted to the extent of promotion to the post of SST (General) on 01.11.2014 (Annexure-A) and performed duty up to 28.02.2022 and later on remained absent w.c.f 01.03.2022 due to which the principal concerned reported the appellant on 15..03.2022 about the absenteeism of the appellant w.e.f 01.03.2022 (Annexure B) along with stoppage of salary (Annexure C) which was further sent to Director Education for seeking guidance being SST BPS-16 dated: 16.03.2022 (Annexure D) and the same was returned with the direction to issue notices to the appellant accordingly (Annexure E). To insure natural justice and opportunity for the lively hood, first notice issued on 11.05.2022 (Annexure F) but the appellant did not reply and remained absent while another opportunity provided to the appellant and second notice was issued on home address on 13.06.2022 (Annexure G) but again the appellant did not bother and failed to heed to the notices and remained absent without any information. To follow codal formalities and due process of law, Director Education was approached for further course of action regarding notices in two leading newspapers on 01.07.2022 (Annexure H) which was returned on 20.07.2022 to DEO(F) Buner and delegated

power to issue notices in two leading newspaper(AnnexureI) and the same was followed and letter sent to Director information along with notice on 01.08.2022 (Annexure J) which was published in Daily Mashriq Peshawar 15.08.2022 (Annexure K) and Daily Azadi Swat dated: 17.08.2022 (Annexure L) but the appellant against slept over and remained absent till date. to confirm the status of the appellant after the notice issued in daily newspaper, principal GGHSS Shahdam was directed to update this about the duty status of the appellant which was reported on 30.08.2022 and confirmed the appellant is still absent without any information (Annexure M). it is further stated that for further course of action, Director Education who is competent authority for SST's BPS-16, sent a letter for departmental proceedings (Annexure N) and resultantly major penalty of removal from service was imposed upon the appellant and she was removed from service vide notification under Endstt:No.1137-40 dated: 13.10.2022 (Annexure O) but the appellant concealed the facts from this Hon'ble Service Tribunal. Hence the instant appeal is liable to be dismissed.

3. That this para No. 3 is not admitted and denied because details has already been incorporated in the above para No. 1.

8. Penalty imposed upon the appellant according to the prevailing rules and laws which is sustainable the eye of law.


9. That the Respondent also seek permission to raise further points at the time of arguments


