The Director Land Records, Khyber Pakhtunkhwa being Competent Authority is pleased to approve initiation of disciplinary proceedings against Mr. Hamadullah, Naib Qasid office of the Director Land Records, as such the undersigned has been appointed as Enquiry Officer vide No.LR-IV/DLR/Estt./3232-35, dated D6.04.2022 to investigate the following charges:-

- Ð That the accused was habitual enjoying French & privilege leaves without obtaining prior permission of the Competent Authority.
- That despite repeated verbal/written warnings, explanations, etc; ii) the accused did not mind his way towards performance of his duty. On 08.04.2022, 13.04.2022, 21.04.2022 and 26.04.2022, the accused remained absent from duty without any approval of the competent authority during the course of Inquiry.
- The accused was found habitual late comer and did not observe lii) official timing.

# PROCEEDINGS OF INQUIRY

On receipt of inquiry, the accused was summoned and provided adequate opportunity to submit his written statement and other details of evidence in his defence. Written statement of the accused is annexed as Annexure-A. The accused was also heard In person and was provided the opportunity of cross examination as well. The accused was also confronted with relevant record. However, the accused submitted written statement on oath that he will strictly observe official timing, will be careful in future and will not avail leave without any prior approval of his superiors by admitting all the aforementioned charges (Annexure-B).

The departmental representative namely Mr. Iftikhar Hussain, Superintendent disclosed that numerous verbal complaints against the accused about his willful absence were pouring since his appointment. The accused made commitments to be careful in future, but in valn. The representative officers added that the said accused was given opportunities to ensure his presence and observe official timing, but fruitless and still remains absent almost twice in a week.

To elaborate the charges, Mr. Sawairullah, Mr. Iftikhar Hussain, Mr. Afsar Jan, Zabitullah, Gohar Zaman, Akbar Ullah, Sohail Khan, were consulted. According to them the accused is ghost official.

# FINDINGS

Repeated explanations, warnings (both verbal & written), commitments of the accused and consultations of the officers/officials reveal that since the accused backed out from his out from his commitments/promise and did not mind his way to ensure his presence & availing willful absence, therefore, the charges stand proved against the accused official as per following details:

- During enquiry from 07.04.2022 to 26.04.2022, Hammad Ullah, Naib i. Qasid, DLR office was summoned and strictly told to mend his behavior and to be punctual. Despite that he did not payed any heed to it and continued with same attitude.
- Attendance sheet was maintained during this period and he was asked ii. to mark his sign in and sign out to which he also did not comply.
- Section staff faced numerous issues and difficulties because of his this lii. casual and ignorant attitude.
- iv. Moreover, many of the letters (Dak) are pending due to his nonavailability.
- His phone was off and he was absent on 08.04.2022, 13.04.2022, v. 21.04.2022 and 26.04.2022 without prior approval/permission.
- He left the office early at Zuhar on 14.04.2022 and 15.04.2022. vi.
- He again left the office early on 22.04.2022 and 25.04.2022. vii.

### CONCLUSION

Although the accused official once again made commitment in writing and promised to be careful in future and will not avail willful leave, however, a lie has no legs to stand upon.

### RECOMMENDATIONS

The accused official (Hamad Ullah, Naib Qasid) showed his lack of interest in discharging of his duty and willful leave, hence his this act come under the preview of inefficient or ceased to be efficient, guilty of misconduct and guilty of habitually absenting himself from duty without prior approval of leave and make him liable/tantamount to be proceeded against under Khyber Pakhtunkhwa, Civil Servants (Efficiently & Discipline) Rules, 2011 and major penalties Rule-4 (b) (iii) & (iv)are proposed

# OFFICE ORDER

No. LR-IV/Kafoor Dheri/Complaints/ $\underline{12436-42}$ . WHEREAS, the appellant (Mr. Hamad ullah, Naib Qasid office of the Director Land Records, Khyber Pakhtunkhwa) was proceeded against under Rule-3(a) (b)(c) of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011.

AND WHEREAS, the Appellant was awarded major penalty of "Removal from Service" under Rule 4-()R i EECt (iii) of the rules ibid.

AND WHEREAS, the Appellant preferred Departmental Review/Appeal dated 15.07.2022 against the arded penalty of "Removal from Service" issued vide No. LR-IV/Estt:/Vol:III/9446-52; dated 29.06.2022.

NOW THEREFORE, in exercise of powers conferred under Rules 14(5)(ii) read with 4-I(a)(ii) of the Exposer Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011, and Rule 7 (3) of the Khyber Exhtunkhwa Civil Servants (Appeal) Rules, 1986, I being Competent/Appellate Authority, is pleased to modify the awarded penalty and convert it into minor penalty of "withholding of three increments for a period of three years with cumulative effect" upon Mr. Hamad Ullah, Naib Qasid office of the Director Land Records, Shyber Pakhtunkhwa, with immediate effect. ### SHOW CAUSE NOTICE

l, Ijaz-ur-Rehman, Director Land Records, Khyber Pakhtunkhwa, as competent authority under Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules 2011, do hereby serve you Hamad Ullah, Naib Qasid, office of the Directorate of Land Records, Khyber Pakhtunkhwa as follows:-

That consequent upon the completion of enquiry conducted against you by Mr. Umar Mukhtar, Assistant Director Land Records, Khyber Pakhtunkhwa received vide letter No. ADLR/Estb: /5527 dated 27.04.2022, through which major penalty i.e. Removal from service was imposed vide No.LR-IV/Esttb:/Vol-III: 9446-52 dated 21.06.2022. However, during personal hearing a written statement on oath was submitted to the effect that in future no such incident will be happened & will be careful in official. Therefore the said charges were converted to minor penalty i.e. "withholding of three increments for a period of three years with accumulative effect" vide No.LR-IV/Kafoor Dheri/complaint/12436-42 dated 10.08.2022 in light of the written agreement. But apparently of the above, you committed the following irregularities:-

- 1. That you are habitually latecomer and leave the office early. You do not observe the official timings.
- 2. That you wilfully remained absent from the office for a period of the 10-15 days in the months (on different occasion/dates).
- 3. That you were time and again warned/directed verbally / in written to be punctual but you did not mend your ways and did not comply with the orders of competent authority.
- 4. That you deliberately remained absent from your official duty on 05, ,10,13,14,17,18,19,20,25,28 October,2022, 01,02,03,04,07,08,10,11,14,15,16,17,18,21, 22,23,25,30 November, 2022 & 01, 02, 05, 06 December, 2022 without any prior approval / permission of the competent authority, showing your lack of interest in official duty.

I am satisfied that you have committed the following acts/omissions specified in rule-3 of the said rules.

- a) Inefficient or has ceased to be efficient for any reason:
- d) Guilty of habitually absenting himself from duty without prior approval of leave.

2. As a result thereof, I, as competent authority, have tentatively decided to impose upon you major penalty of removal from service as defined under Rule-4 of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011.

<sup>3.</sup> You are, thereof, required to show cause as to why the aforesaid penalty should not be imposed <sup>upon</sup> you. And also intimate you desire to be heard in person.

<sup>4</sup> If no reply to this notice is received within 03 days or nor more than 07 days of its delivery, it shall be presumed that you have no defence to put in and in that case ex-parte action shall be taken <sup>against</sup> you.


