



TRIBUNAL ACT 1974 AGAINST THE NON PROMOTION OF THE  
APPELLANT TO THE RANK OF DSP FROM THE RANK OF  
INSPECTOR.

Respectfully Sheweth

1. That the appellatant was appointed in the police department Khyber pakhtunkhwa and was retired at the age of superannuation on 13-02-2023. (Copy of retirement order is annexed as annexure "A")
2. That the appellatant submitted an application before the Inspector General of Police Khyber Pakhtunkhwa for his supersession and promoting of other junior officer to the rank of DSP complaining

therein, the disseminating treatment of the appellant. (Copy of the application is annexed as annexure "B")

3. That despite the fact that the appellant was placed at serial no 131 of the seniority list and private respondents ( Respondents no 3 & 4) including senior were awarded pro-forma promotion to the rank of DSP after their retirement. (Copies of orders are annexed as annexure "C")
4. That the appellant being eligible as per the seniority list as well as in other respect has been ignored in promotion process to the rank of DSP. Needless to mention here that legitimate expectancy for getting promotion is also favoring the present appellant.
5. That final revised seniority list of inspectors of Khyber Pakhtunkhwa, Police for the year 2022 as stood on 06-12-2022 is issued for all concerned, where, the appellant was on serial no 131. (copies of seniority list dated 06-12-2022 are annexed as annexure "D")
6. That the application for promotion of the appellant has been forwarded to the District Police officer concerned by the Inspector General of Police Khyber Pakhtunkhwa, Peshawar, where after the District Police Officer forwarded letter dated 29-03-2023 to the Regional Police Officer Malakand Region at Saidu Sharif Swat for necessary and further action. (Copy of letter dated 29-03-2023 is annexed as annexure "E")
7. That the Regional Police Officer Malakand Region forwarded letter dated 10-04-2023 recommending the appellant for pro - forma promotion and stating in the letter that officers junior to the appellant have already been awarded pro - forma promotion to the rank of DSP after their retirement hence the appellant is also entitle for the said promotion. (Copy of the letter dated 10-04-2023 is annexed as annexure "F")

8. That officers who were junior as well as senior to the appellant were promoted to the rank of DSP after their retirement and the appellant was deferred in the process of promotion.
9. That the letter of recommendation letter sent by the Regional Police Officer Malakand Region to the Inspector General of Police Khyber Pakhtunkhwa still pending and has not been acted upon feeling aggrieved from the said in action of the respondents the appellant prays for his pro - forma promotion to the rank of DSP on the following grounds amongst others.

**GROUND;**

- A. That the stance of the respondents of not awarding pro - forma promotion the appellant to the rank of DSP after his retirement is against the law facts and circumstances of the case hence not tenable in the eyes of law.
- B. That the appellant was placed at serial no 131 of the seniority list but the even junior ranking officials were promoted in the appellant was discriminated despite his being senior and terms of seniority rules.
- C. That the respondent no 3 was on serial No 136 of the said seniority list has been promoted to the rank of DSP on 01 .03. 2023. Pertinent to mention here that the said DSP was retired on 19. 02. 2023 meaning thereby that he was promoted after his retirement.
- D. That the respondent No 4 was on serial No 138 of the said seniority was also promoted as DSP on 01. 03 .2023 who was retired on 14 .02. 2023, he has also been promoted after his retirement.





- E. That the appellant has not been treated in accordance with law because the law mandates that everyone should be dealt with in accordance with law, rule and regulation.
- F. That the appellant is also entitle in every other respect for the pro – forma promotion to the rank of DSP because the appellant has served the department effectively and diligently throughout his service and no complaint whatsoever has been made against the appellant from any quarters.
- G. That the concept of pro – forma promotion after their retirement is benefit conferred upon the Civil Servant by rules and regulation but the appellant has been deprived from this benefit without any legal justification.
- H. Any other ground with leave this Honorable court will be raised at the time of arguments.

It is therefore humbly prayed on acceptance of this appeal the non - promotion of the appellant may kindly be declared illegal and unlawful and the appellant may kindly be promoted to the rank of DSP with all back benefit.


