SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE. TRIBUNAL ACT. 1974 **AGAINST** THE ORDER NO. 363/KASHIF ULLAH/GDCKK/22 DATED 12-09-2022, WHEREBY THE CADRE OF THE APPELLANT WAS CHANGED FROM LAB ATTENDANT TO THAT OF **CHOWKIDAR** ANDALSO TRANSFERRED ONPOLITICAL INFLUENCE AGAINST THE LAW AND RULES, FEELING AGGRIEVED THE APPELLANT PREFERRED .



DEPARTMENTAL APPEAL, BUT THE SAME WAS NOT RESPONDED TO DESPITE THE LAPSE OF STATUTORY PERIOD OF TIME.

#### PRAYER:

That on acceptance of this appeal the order impugned may very kindly be set aside and the appellant let to perform his duties as lab attendant at Government Degree College Khwazakhila.

#### Respectfully Sheweth:

#### Facts:

- i. That the Appellant was appointed as Chowkidar at Government Girls Degree College Kwaza Khila Swat in due course of law by observing all the codal formalities. Copy of the appointment order is enclosed as Annexure "A".
- ii. That the Appellant was then transferred to Government Degree College Khwaza Khila and performed his duties as Chowkidar at Government Degree College Khwaza Khila. Copy of the order dated 10-09-2021 is enclosed as Annexure "B".
- iii. That certain post of Lab Attendant were announced and the Appellant also submitted an application for the same. That the Principal made my permanent order of Lab Attendant as he was authority. Copy of the advertisement is enclosed as Annexure "C".

- iv. That all the necessary entries were made in the record and the Appellant assumed his charge as Lab Attendant. Copies of the Attendance Register are enclosed as Annexure "D", that of the relevant pages of service book are enclosed as Annexure "E" and that of the salary statement are enclosed as Annexure "F", respectively.
- v. That vide order Endst: No. 1301-02 / J-22 dated 02-09-2022 the Appellant was again transferred to Government Girls Degree College Khwaza Khila and then to Government Degree College Charbagh on the post of Chowkidar. Copy of the order dated 02-09-2022 is enclosed as Annexure "G".
- vi. That feeling aggrieved the Appellant brought the same into the notice of the Respondent No. 3, who vide order Endst: No. 1377-80/J-22 dated 07-09-2022 cancelled the order dated 02-09-2022. Copy of the order dated 07-09-2022 is enclosed as Annexure "H".
- vii. That in order to pursue his case the Appellant submitted an application for the provision of the copies of the documents, but the same are yet to be provided. Copy of the application is enclosed as Annexure "I".
- viii. That the appellant feeling aggrieved submitted departmental appeal for the redressal of his grievances, but the same is not responded to despite

the lapse of the statutory period of time. Copy of the departmental appeal is enclosed as Annexure "]".

- ix. That strange enough and flabbergasting pending disposal the departmental appeal the Respondent No. 3 again cancelled his order dated 07-09-2022 vide order Endst: No. 1975-79 Kashifullah/2022 dated 15-12-2022 against the law and rules on the subject and is liable to be cancelled as well. Copy of the order dated 15-12-2022 is enclosed as Annexure "K".
- x. That still feeling aggrieved and having no other option this Honourable Tribunal is approached on the following grounds.

#### **Grounds:**

- a. That the Appellant is dealt with in manner not warranted by the law and rules on the subject emanating from the commands of the constitution.
- b. That the Appellant was duly appointed / adjusted against the vacant post of Lab Attendant and all the relevant entries were also made in the service record and the Appellant also took over the charge and performed his duties as such but due to political influence the cadre of the Appellant was changed in utter violation of the law and rules on the subject, which is never approved by the law.
- c. That this is a classic case of misuse and abuse of authority in a very colorful and fanciful manner



just to please the political elite for personal gains by bulldozing all the codal formalities and relevant laws and rules and showing utter disregard to the same.

- d. That the Appellant has been denied his vested and accrued rights.
- e. That the Appellant has been discriminated with.

It is, therefore, very respectfully prayed that on acceptance of this service appeal both the impugned orders may very kindly be set aside and the Appellant let to perform his duties as Lab Attendant as his original place of posting.

Any other relief deemed appropriate in the circumstances and not specifically prayed for may also very kindly be granted.
