## PRELIMINARY OBJECTION:-

- a) That the appellant has got no cause of action to file present service Appeal.
- b) That the appeal is not based on facts.
- c) That the appeal is not maintainable its present form.

Incorrect, as per reports of intelligence Agencies, appellant remained involved in malpractices having links with undesirable elements, while posted at aTakhta beig PP, Police station Jamrud and after fulfillment of codal formalities i.e.(enquiry proceedings) appellant was remove from service.(Annexure-A Dismissal Order No.1436/PSO Khyber, dated Khyber 30.05.2020).
- 6. Incorrect, enquiry procedure provided in police disciplinary rules 1975 has been adhered in enquiry proceedings. Furthermore, In this regard

departmental enquiry was initiated against appellant. Charge sheet and statement of allegation were also issued against the defaulter officer separately with order No. 1263-A/PSO Khyber, dated the 29.04.2020, the appellant (defaulter ASI) was called to enquiry office for recording his statement. In defense against the allegation leveled against him (Appellant). In statement, the defaulter official failed to submit any cogent reason in his defense, after fulfillment of codal formalities enquiry officer recommend, that appellant/ASI Hamid Khan may be awarded punishment according to rules and regulations in order to settle an example for aother as deterrence who are the helping hands of criminal inside the department or involved in anti-social and criminal activities, hence removed from service.(Annexure-B, Charge Sheet, Summary of Allegation Annexure-C Order No.1263-A/PSO Dated 29.04.2020).

7. Incorrect, as already explained in Para No.06 (Annexed-D enquiry report).

- 8. Incorrect, respondents are doing every act according to rules, regulation and in the ambit of law, no in justice or illegality has been done with appellant. Moreover, chief Traffic Officer and SP/HQrs City Traffic were appointed as inquiry officers for further denovo enquiry. Enquiry officers after conducting proper enquiry submitted their finding that he is not found guilty of the charges leveled against him. The competent authority SSP/Coordination to conduct the proceedings afresh and submit report immediately. The SSP/Coordination Peshawar submitted his enquiry report, that the statement of previous Supervisory officer/ indicates that, corruptions and malpractice during the period of appellant were rampant, which clearly shows/ provide evidence and proof of the involvement of the staff and incharge of the post hence major punishment of removal from service was converted into forfeiture of two year approved service from appellant. (Annexure-E order No.4035-36-PA dated Peshawar 15.10.2021).
- 9. Incorrect, the appellant has got no cause of appeal; therefore the instant appeal may kindly be dismissed on following grounds.

#### Grounds.

A. Incorrect, as already explained in the preceding Paras, however, respondents are doing every act in the ambit of law, no injustice or illegality has been done with the appellant.

- B. Correct, however, respondents are doing every act/ manner in according to law, rules and regulations.
- C. Incorrect, as already explained in the preceding Paras. Moreover respondents have acted accordance with natural justice equality.
- D. Appellant has already been treated in accordance with the constitution of Pakistan 1973, however for the remaining Para it has already explained in the preceding Paras.
- E. As already explained in preceeding Paras.
- F. Incorrect, as already explained in the above mentioned Paras. However, no illegality or injustice done with appellant.
- G. Respondents may be allowed to raise other grounds at the time of arguments.

Prayer:

# ORDER

As per reports of Intelligence Agencies, ASI Hamid Khan remained involved in malpractices having links with undesirable elements while posted at Takhta Baig PP. Police Station Jamrud consequent upon which the undersigned being a competent authority under Govt: Servants Service & Efficiency Rules 1975 issued a Show Cause Notice with the opportunity to be heard in person which the defaulter official did not availed.

In reply of the Show Cause notice the defaulter constable failed to submit any cogent reason regarding the allegations leveled against him consequently a Charge Sheet with Summary of Allegations was issued & Acting SDPO Hqrs Khyber was appointed as Enquiry Officer vide this office No. 1263-A/Khyber, dated 29/04/2020.

The Enquiry Officer in his finding report stated that the defaulter in his written statement in his defense failed to submit any cogent reason and failed to defend himself against the allegations before the enquiry officer. Furthermore, enquiry made locally through various sources revealed that the ASI is ill reputed and involve in malpractices. After which the defaulter was issued a Final Show Cause Notice by the undersigned with an opportunity to be heard in person. In reply of the Final Show Cause Notice the defaulter again failed to submit any solid reason.

Keeping in view the recommendations of the Enquiry Officer & available record the defaulter ASI Hamid Khan is hereby awarded <u>a major punishment of REMOVAL FROM</u> <u>SERVICE</u> with immediate effect.

The act of delinquent officer falls within the ambit of gross misconduct and is liable to be proceeded under the NWFP (now Khyber Pakhtunkhwa) Police Rules 1975.

For the purpose of scrutinizing the conduct of the said defaulter with reference to the above allegations, I, District Police Officer, Khyber being authorized officer hereby nominate Enquiry Officer as below to enquire into the charges within the meaning of 2 (iii) under the NWFP (now Khyber Pakhtunkhwa) Police Rules, 1975.

An enquiry was conducted where the defaulter ASI was called to this office for recording his statement in defense against allegations leveled against him. In his statement, the defaulter official failed to submit any cogent reason in his defense. A secret inquiry through other sources was also conducted against the ASI which also revealed that the ASI is involved in malpractices which is a gross misconduct on his part. It was also learned that the official is ill reputed.

Conclusion:

The defaulter is involved in malpractices and ill reputed and brought a bad name to this department hence is not eligible for policing duty. He also involves his subordinates in malpractices.

Recommendation:

It is recommended that ASI Hamid Khan may be awarded punishment according to the rules & regulations/law in order to settle an example for all criminals disguised as police officials/officers who are the helping hands of criminals inside the department or involved in anti-social and criminal activities.

OFFICIALS OF DISTRICT KHYBER.

This is denovo departmental enquiry against Ex-ASI Hamid Khan of district Khyber "as per report of Intelligence, he remained involved in malpractice having links with undesirable elements while posted at PP Takhta Baig Police Station Jamrod"

With reference to the above allegations he was charge sheeted by the DPO/Khyber and SDPO Head Quarters Khyber was appointed as E.O.

The E.O recommended the defaulter ASI for suitable punishment upon which DPO Khyber awarded him major punishment "<u>Removal from service</u>" vide order No. 1436/PSO Khyber dated 30.05.2020.

Later on ex-ASI filed departmental appeal before W/CCP against the impugned order and for re-instatement into service.

The defaulter ASI was heard by W/CCPO in OR. He was re-instated into service for the purpose of de-novo proceedings and CTO Peshawar was directed to entrust the enquiry to SP/Hqrs Traffic Peshawar.

Accordingly SP Headquarters, Traffic Peshawar conducted enquiry and opined that ex-ASI Hamid Khan was not found guilty of the charges leveled against him and recommended that previous punishment " **Dismissal from service may be converted into minor punishment**" and he may be reinstated into service.

After perusal the enquiry the W/CCPO passed the following remarks and directed the undersigned to conduct proceedings and report :-

- 1) Previous supervisory offices have not been consulted for his performance.
- 2) Nor of the contents of the reports against him analyzed.

In order to verify the character of EX ASI Hamid Khan intelligence agencies were contacted for verification of his previous character. The reply received to this office narrates that maximum ex-khasadars posted on Pak Afghan route were involved in collecting illegal amount from cargo trucks including Takhta Baig check post and after Police system the then DPO dismissed 16 ex-khasadars on account of mal-practices.

Statements from his previous supervisory officers DSP Mazhar Afridi, SHO Akbar Khan (Station House Officer Bara) were also recorded (Enclosed). <u>FINDINGS.</u>

Keeping in view of the available record the following findings are achieved.

- 1. SP/Hqrs Traffic Peshawar already conducted a Departmental enquiry however he did not contact/consult his immediate supervisors/ colleagues regarding his character and performance and secondly no secret report through agencies was obtained to ascertain the character and verify the allegations.
- 2. The statements of his previous supervisory officer indicates that corruption and malpractices during the period were rampant which clearly shows/provide evidence and proof of the involvement of the staff and In-charge of the post which was being done under his very nose. He is therefore found guilty into the matter.

2-A denovo departmental inquiry was initiated against ASI Hamid Khan of District Police Khyber who was re-instated in service for the purpose of denovo inquiry, order issued vide Endst No.1039-41/PA, dated 27-08-2020.

He was again issued Charge Sheet and Summary of Allegations by Chief Traffic Officer and SP/HQrs City Traffic Peshawar was appointed as inquiry. The inquiry officer after conducting proper enquiry submitted his findings that he is not found guilty of the charges levelled against him. The competent authority after perusal of the findings of the inquiry officer referred the inquiry to SSP/Coordination to conduct the proceedings afresh and submit report immediately. The SSP/Coordination Peshawar submitted his inquiry report that the statement of previous supervisory officer indicates that corruption and malpractices during the period were rampant which clearly shows/provide evidence and proof of the involvement of the staff and incharge of the post, therefore he is guilty into the matter.

The ASI was heard in person in O.R and the relevant record and inquiry report 4perused. During personal hearing he totally denied the allegations levelled against him. After perusal of record the undersigned reached to the conclusion that the punishment awarded to him seems too harsh. The other 16 officials who were also dismissed have already been reinstated in service on the same allegations. Therefore, the punishment awarded to him by DPO Khyber vide No 1436/PSO Khyber is hereby set aside. He is hereby reinstated in service with immediate effect. He is awarded the punishment of approved service for two years. No benefit is granted for the period he remain out of service.
