



ORDER

- 5th July, 2023
1. Learned counsel for the petitioner put appearance. Mr. Asad Ali Khan, Assistant Advocate General alongwith Dr. Arif Mehmood (respondent No.2) and Mr. Farooq Khan, Law Officer present.
 2. Learned counsel for the petitioner objected that, although, the judgment was implemented in its terms but in Paragraph-03 of the order, passed, in compliance with the judgment, the date of arrival of the petitioner was written as 01.04.2022, whereas, the petitioner has alleged that he has submitted arrival on 18.01.2022, which arrival report also bore endorsement of the office of the respondents. Copy of the said arrival report is produced by the learned counsel for the petitioner, which is handed over to the representative of the respondents, who assured that he would verify the date of arrival/arrival report bearing 18.01.2022 date from



their own record and if that was found they would accordingly modify the order. It is thus directed that the respondents shall check and verify the arrival report from their own record and make correction, if that is found in their record to have been duly filed and in case that was not filed, the respondents shall take action against the delinquent official, who put endorsement on the application dated 18.01.2022, filed by the petitioner. This application is disposed of in the above terms. However, if found that the application dated 18.01.2022 was not filed and was not available on the record of the respondents, the petitioner would be at liberty to make application for redressal if he so desires.
