#### PARAWISE COMMENTS ON BEHALF OF RESPONDENT NO. 1 & 2.

Respectfully Sheweth: -

#### PRELIMINARY OBJECTIONS: -

- 1. That the appellant has got no cause of action to file the instant appeal before the Hon'ble Service Tribunal.
- 2. That the service appeal is not maintainable and not entertainable in its present form.
- 3. That the appellant has no locus standi to file the instant Service Appeal.
- 4. That the appellant has not come to the Hon'ble Service Tribunal with clean hands.
- 5. That the appellant has concealed material facts from this Hon'ble Service Tribunal.
- 6. That the appeal is based by law and limitation.
  - 1. No Comments.
  - 2. Correct to the extent that the appellant was charged on account of fake/contradictory, Fardat issued in violation of rules knowledge, authority of the land owner. After conducting proper enquiry under the Efficiency & Discipline Rules, imposing major penalty of compulsory retirement(Annex-A), later on reduced/converted into minor penalty by withholding of three increments for a period of three years (Annex-B) with cumulative effect in light of departmental appeal filed by the appellant, hence the opportunity /remedy has already been availed and he is not entitled for further relief being a serious charges of male practices leveled against the appellant.
  - 3. Incorrect, the Service Delivery Center Staff are the custodian of precious land records. They are trusted to keep the land records of people safe & secret. They are expected to ensure privacy regarding lands of the public. One of the main objective of the land records computerization is make the records safe, but in the instant case he took a very easy and succumbed to the pressure and telephone calls and provided land records to irrelevant people. Due to his, this action seems a big fraud took place which created agonies for many people and embarrassment for Revenue Department.
  - **4.** As stated in Para-03 above.
  - 5. Incorrect; As per recommendation/report of Inquiry Officer, the service provider (Mr. Faheem Ullah, Computer Operator) statements reveals some contradiction as issuance of Fardat without consent of owners seems illegitimate, while the incumbent Patwari Halqa has no role at all as the Halqa has already been made live in Service Delivery Center.

6. Correct to the extent that the appellant filed a Department Appeal before the Senior Member Board of Revenue, wherein the SMBR has accepted the appeal and converted the awarded penalty into withholding of three increments for a period of three years.

#### **GROUNDS:**

- A. Incorrect, the appellant was charged on account of very serious changes of Fake/contradiction, fardat issued in violation of rules, knowledge authority of the land owners. Therefore, the appellant proceeded strictly in accordance with the existing prevailing rule.
- B. Incorrect; The appellant proceeded strictly in accordance with the provision of E & D Rules & set precedence.
- C. Incorrect; All the opportunity for defence of case has already been availed by the appellant as provided under the rules.
- D. Incorrect; All the codal formalities has been adopted strictly in accordance with the provision of rules/law.
- E. Incorrect- as stated in Para-03.
- F. Incorrect- as stated in Para-03.
- G. Incorrect; As per finding of Inquiry Officer, the Service Delivery Center Staff are the custodian of precious land records. They are trusted to keep the land records of people safe & secret. They are expected to ensure privacy regarding lands of the public. One of the main objective of the land records computerization is make the records safe, but in the instant case he took a very easy and succumbed to the pressure and telephone calls and provided land records to irrelevant people. Due to his, this action seems a big fraud took place which created agonies for many people and embarrassment for Revenue Department.
- H. In case of Abdul Ghafar Patwari Halqa Behlolzai Peshawar. He remained Patwari at mouza Kafoor Dahri on 14.03.2016 to 16.06.2017. Now he is Patwari mouza Behlolzai. Mouza Kafoor Dahiri is live and attestation of Mutation and issuance of Fard are done in the SDC and Patwari has no role in entering of mutation or issuance of fard. He has not issued fard nor did he signed any document in this case. As far as CDR is concern it will be jumping to the desired results to rely on CDR because we have no data regarding the quality of the telephone calls. We don't know what was asked and what was replied because CDR in the present form only shows us number of telephone calls which are 223 outgoing call and 221 incoming calls from Mr. Ajmali Khan, the main character behind the preparation of fake power of attorney. However, being Revenue official and being ex-Patwari of the Mouza where fake power of attorney has been prepared it is not good rather alarming that Patwari has relations too deep with a person who is master mind of fake power of attorney. But in this case prime facie no solid proof of his involvement could be found.

# BACKGROUND:

The undersigned was appointed as Inquiry Officer vide notification No. LR-W/Inquiry/Kafoor Dairi/2121-29 dated 10.03.2022 (Annex-I) to conduct the enquiry under the Khyber Pakhtunkhwa Servants (Efficiency & Discipline) Rules, 2011. Charge Sheets and Statement of Allegations in respect of Mr. Saleem Ahmad ex-Sub-Registrar-II Peshawar (now waiting for posting in Director Land Records), Mr. fabcemullah Computer Operator SDC Peshawar and Mr. Abdul Ghafar Patwari Halqa Behlolzai Deputy Commissioner Peshawar have been enclosed. The Director Land Records provided copy of the Fact Finding enquiry conducted by the then ADC Peshawar which was perused.

. ISSUE: A fake Power of Attorney (where upon thumb impression of deceased persons have been affixed) No. 1599 Bahi No. 4 vol-137 dated 06.05.2021, its execution and registration of sell deed No. 3749 Bahi No. 01 vol-2501 dated 25.05.2021. 14.

#### PROCEEDINGS

The statement of allegations and charge sheets were duly served upon all three under inquiry officials namely Salim Ahmed Sub Registrar, Ghaffar Ali Patwari and Fahemullah Computer Operator. All the three officials were given 15 days for replies/statements.

The above named officials were given the opportunity of hearing and written statements.

### STATEMENT OF MR. SALEEM AHMED. EX-SUB-REGISTRAR-II. PESHAWAR

- That para-1 of the allegation is incorrect, in fact I have observed all legal and codal formalities at the time of appointing Commission in the light of Section-38 of the Registration Act 1908 which authorize the Sub-Registrar to appoint Commission, Section-38 is reproduced for your perusal please. Copy enclosed as (Annex-A).
- (a) A person who by reason of bodily infirmity is unable without risk or serious inconvenience to appear at the Registration officer, or

(b) a person in jail under civil or criminal process, or

(c) person exempt by law from personal appearance in court and who would but for the provisions next hereinafter contained by required to appear in person at the registration officer.

(2) In the case of every such person the registering officer shall either himself go to the house of such person, or to the jail in which he is confined, and examine him or issue a Commission for his examination.

Allested

pertinent to mention here that the Advocate Gharib Gul Ahale Commission has disclosed at the time of application that he is counsel of the applicants and he personally identified them.

After the report of Commission of Power of Attorney was thoroughly examined After the Commission has categorically mentioned that all the Executants of the deed and witnesses have signed/thumb impress the deed in his presence. Thereafter the Power of Attorney was registered at Serial No. 1599 in Book No. 4 on 06.05.2021.

Hir. Hasham Ali and 11 others moved/filed an application before Assistant Commissioner Peshawar for cancellation of the said Power of Attorney wherein they have stated that they are owners of inherited property measuring 400-kanals in mouza Kafoor Dehrin Peshawar, in respect of which their maternal cousins Mr. Ajmali khan and Sabz Ali Khan sons of Abdul Hamid Khan have obtained a Power of Attorney from them which was signed/thumb impress by them and now the pplicants demanded the Sale consideration on which their cousins annoyed and insulted them, on receipt of said applications from Assistant Commissioner Peshawar, I called Gharib Gul Advocate Ahle Commission and inquired from him about said application. I also asked him that whether he is satisfied about the Power of Attorney and signatures/thumb impressions of executants, for which he did not reply properly, thereafter I called the attorney holders Ajmali and Sabz Ali and cancelled the Power of Attorney on 04.08.2021 vide cancellation deed No. 2414 Bahi 4 under the Power of Attorney Act.

In reply to Para-2 of the Charge Sheet:

It is humbly submitted that I have not violated any Law and I have not gone beyond my Jurisdiction as I was working under Registration Act 1908, thereafter at the time of Registration of Power of Attorney I have followed Para-A Sub-para-1 of Section-33 which says "if the principal at the time of executing the power of attorney feeides in any part of [Pakistan] in which this Act is for the time being in force, a Power of attorney executed before and authenticated by the Registrar or Sub-Registrar within whose District or Sub-District the principle resides.

In reply to Sub-para-III it is humbly submitted that detailed reply has already

been given in afore mentioned paras, thereafter there is no need for repetition.

I have done my job according to Law and Rules by observing all legal and godal formalities and have not gone beyond my Jurisdiction what has been done it was done in good faith and I am not guilty of any mis-conduct and have not violated any Rules. It is further prayed that the Charge sheet may kindly be withdrawn and I may graciously be exonerated from the charges.

# STATEMENT OF MR. FAHIMULLAH, COMPUTER OPERATOR, SDC PESHAWAR

With due respect it is stated that on 26.04.2021, Sabz Ali S/O Abdul Hameed Khan NO Sara sang Kasoor Dheri Peshawar visited SDC officer personally having original CNICe of owners and copies of few CNICs on which the words "For Power of Attorney Only were written. After which, I validated each original CNIC along with copies

through data there in my computer system and I also validated Date of Expiry on CNICs. Since few owners were not having their CNICs so I was told that they belong CNICs. Since few owners were not having their CNICs so I was told that they belong confidently of sitting Deputy Speaker Mehmood Jan and they have an agreement with the family of sitting Deputy Speaker Mehmood Jan and they have an agreement with their which, he showed a stamp paper in which their agreement was made and sit and Sids Ali S/O Abdul Hamced was made Attorney by the owners. Then I took original CNIC and Mobile No. from Sabz Ali and entered these in Computer System. And fard was given for Power of Attorney on which a note was written for Sub-Registrar to get complete detail of owners and their ID Cards.

The nephew of ex-Senior Member Board of Revenue Mr. Syed Zafar Ali Shah namely syed Abbas Shah and Ayaz, Gohar and Qasim have taken fardat for Registry and Power of Attorney of the family of Deputy Speaker Mehmood Jan's for 1863 kanals land (Record enclosed). They were not having their CNICs nor their copies. Calls were received from Board of Revenue also and all of our staff used to do their work till laight. Even Tehsildar was also called to the office in the evening. Deputy Speaker's reference was given whenever they were directed to produce the actual owners of the land. Or higher-ups were approached in obtaining fards. Due to which we could not call family members of the Deputy Speaker Mehmood Jan's family. Because we were pressurized by approaching higher ups whenever the actual owners were called.

The Higher ups cancelled the Power of Attorney when they knew that it was fake. After which ex-SMBR Syed Zafar Ali Shah called our Deputy Director Asghar to his office and said that whenever my nephew give you my reference, don't do any of his work until and unless my PS calls you. After few days, brother of Deputy Speaker the sham came and gave me his mobile No. and told me that our fards to be handed over to Qasim only and introduced him to me. After which we didn't give their fard to anyone.

bear Almighty ALLAH as witness that I haven't got any bribe or money from any one nor I knew that Sabz Ali S/O Abdul Hameed will use the fard for illegal work. Kindly I may not be charged. I will pray for your good self all of my life.

## STATEMENT OF MR. CHAFFAR, PATWARI HALQA, MOZA BEHLOL

Malak Abdul Ghaffar Patwari was posted at Moza Kafoor Dheri through order No. 8583-87/Deputy Commissioner(P)DK dated 14.06.2016 and then through Order No. 12122-74/DC(P)DK dated 16.06.2017 was transferred from Kafoor Dheri.

In mouza Kasoor Dheri the Power of Attorney done in 2021 does not carry my signature. Nor I am a witness in that. Neither was it executed in my presence. I have no connection with the said power of attorney and neither have I attorney with the transactions carried out on the basis of that power of

I provide information only according to the Law but that does not mean that I have ever given any wrong advice or help in preparing or using any illegal document. In this matter, I am totally innocent and I have been blamed without any basis.

Therefore, the accusation regarding the power of attorney is wrong and baseless. I completely deny that allegation because on the power of attorney there is neither my signature nor prepared by me. Above all, I was posted in Kafoor Dheri for only few months from 14.03.2016 to 16.06.2017 and after that I was transferred from Kafoor Dheri. I have been transferred as Patwari at Moza Behlol Zai on 09.01.2021 and presently I m working there. Charge report is enclosed.

While the Power of Attorney in question is of 2021, of which creating any connection with me is not only wrong and baseless but unfair and an effort to malign me.

I have never committed any wrong and illegal act and about this power of attorney, I state on oath that I have no information regarding it neither have I tried to keep anything hidden. I am ready to provide any kind of proof regarding it.

Due to above, any kind of proceedings against me will not only be unfair but also a reason for mental and physical torture.

Therefore, it is requested to accept my reply and file the charge sheet against me. Moreover, the undersigned also requests for personal hearing.

### PINDINGS

In case of Mr. Saleem Ahmad ex-Sub-Registrar-II Peshawar. In his statement he has abrown the responsibility of affixing thumb impressions of the deceased persons on the shoulders of Ahle Commission and the Ahle Commission may have committed blunder by doing the illegal and immoral job of taking thumb impressions of deceased persons but the Ahle Commission was enabled to do so by Mr. Saleem Ahmad ex-Sub-Registrar-II Peshawar. Assigned jurisdiction of Sub-Registrar-II is Town-III & Town-IV while the mouza where the issue is created is in Town-II. There used to be a stesting various documents even in the circles of Naib Tehsildars but no such powers of tradition or emergency was there for the appointing of Ahle Commission in an area/town, the work of which was not assigned to Sub-Registrar-II. Therefore,

Lease of Abdul Ghafar Patwari Halqa Behlolzai Peshawar. He remained Patwari at bouza Kafoor Dahri on 14.03.2016 to 16.06.2017. Now he is Patwari mouza Echlolzai. Mouza Kafoor Dahri is live and attestation of Mutation and issuance of Fird are done in the SDC and Patwari has no role in entering of mutation or issuance in fard. He has not issued fard nor did he signed any document in this case. As far as CDR is concern it will be jumping to the desired results to rely on CDR because we have no data regarding the quality of the telephone calls. We don't know what was rested and what was replied because CDR in the present form only shows us number of telephone calls which are 223 outgoing call and 221 incoming calls from Mr. Ajmali Khan, the main character behind the preparation of fake power of attorney. However, being Revenue official and being ex-Patwari of the Mouza where fake power of attorney has been prepared it is not good rather alarming that Patwari has relations too deep with a person who is master mind of fake power of attorney. But in this case prime facie no solid proof of his involvement could be found. Therefore,
