RESPECTFULLY SHEWETH;

Respondent humbly submits as under.

Preliminary objections:

- 1) That the appellant has no cause of action/locus standi to file the instant Service Appeal.
- 2) That the appellant is concealing material facts from this honorable service tribunal.
- 3) That the present appeal is bad for mis-joinder and non-joinder of necessary parties.
- 4) That the appellant is estopped by his own conduct to file the instant appeal.
- 5) That the instant appeal is not maintainable in its present form.
- 6) That the present appeal is badly Time barred.

ON FACTS:

 Para -01 is correct with the explanation that appellant got her appointment order on dated 09-04-2022 with connivance of exlitigation representative of DEO (F) Nowshera by deceiving the competent authority falsely stating about court order/judgment regarding their appointments, however failing so by providing the verified copies of the said judgment an enquiry was ordered on dated 28-04-2022 to probe into the matter and thus upon the submission of enquiry report vide memo No.189-90 dated 11-05-2022, the competent authority after due satisfaction withdrawn/cancelled the appointment order vide Endst No. 5521-26 dated 12-05-2022. (Copies of appointment order, enquiry report and withdrawal order are annexed as annexure A, B, and C respectively)

- 2) Para -02 is correct with the above explanation that appellant got her appointment order fraudulently which was later on duly withdrawn.
- 3) Para -03 is also correct with the above explanation.
- 4) Para-04 is incorrect appellant was under probation and just served about 01 month time only i.e. from 09-04-22 to 12-05-22 upon an appointment order received fraudulently thus cancelled.
- 5) Para-05 is incorrect with the explanation that explanation from both appellant and representative were called time and again to provide the verified copy of court judgment upon which she was appointed but they failed to provide so, resultantly her appointment order was withdrawn/cancelled.
- 6) Para 6 is incorrect, in the annexed order the suit of the appellant has been dismissed so how she can be appointed upon such order, furthermore no such order was provided prior to the instant appeal.
- 7) Incorrect, as the appellant failed to provide the very order of the court in her favor stating which her appointment order was issued thus withdrawn immediately.
- 8) Incorrect as explained above.
- 9) Incorrect as explained above.
- 10) Incorrect, Appellant is not an aggrieved person at all.

- A) Ground A is incorrect, the appellant has fraudulently availed her appointment order, respondents has just acted according to law and rules. Similarly no discrimination has been made as appellant obtained her appointment order just by falsly stating about the court judgment in their favour.



- 3. ADO (lit) may be discharges off from her duty and the litigation matter may be assign to another illegible officer of Education Department.
- 4. The ADO(lit) may be proceed to quarter concerned for disciplinary action under the E & D Rules-2011 for such negligence on the part of litigation.
