

**SERVICE APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICES TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED INACTION OF THE RESPONDENTS BY NOT PROMOTING THE APPELLANT WITHIN THE 75 % QUOTA TO THE POST OF BUDDER AND AGAINST THE INACTION OF THE RESPONDENTS BY NOT DECIDING THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINTY DAYS.**

**PRAYER:-**

That on acceptance of the instant service appeal the respondents may please be directed to promote the appellant to the post of *Budder* under the 75 % promotion quota with all back benefits. Any other remedy which this august Tribunal deems fit that may also be awarded in favour of the appellant.

**Respectfully Sheweth:**

1. That initially the appellant was appointed as Depot Cooli (BPS-01) in the respondents department vide order dated 03.08.1988. Copy of the appointment order dated 03.08.1988 is attached as Annexure .....**A.**
2. That while joining the respondents department in pursuance to the mentioned order, the service book of the appellant was properly

prepared by the competent authority. Copy of the service book is attached as Annexure .....**B.**

3. That till date the appellant is performing his duties on the same post as is evident from the pay slip of the appellant. Copy of the pay slip is attached as annexure .....**C.**

4. That service structure of the respondents were notified vide notification dated 26.11.2020 wherein the prospect of promotion was provided to the Class-IV employees. Copy of the notification dated 26.11.2020 is attached as Annexure .....**D.**

5. That it is pertinent to mention her that appellant served in Class-IV for almost 35 years and in pursuance to the notification for providing the prospects of promotion to the appellant cadre, he preferred departmental appeal for promotion as there are certain posts lying vacant in promotion quota but the same has not been decided within the statutory period of ninety days. Copy of departmental appeal is attached as Annexure .....**E.**

6. That by not deciding the departmental appeal within the statutory period of ninety days and having no other remedy file the instant service appeal on the grounds inter alia.

**GROUND S:**

**A-** That the impugned inaction of the respondents by not promoting the appellant to the post of *Budder* under the promotion quota in light of the notification dated 26.11.2020 is against the law, facts, norms of natural justice and materials on the record.

**B-** That the appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

**C-** That the impugned inaction of the respondents is arbitrary and malafide as the same is omission of Section 9 of the Khyber Pakhtunkhwa Service Act 1973, read with Rule 7 of the Khyber Pakhtunkhwa (Appointment, Promotion & Transfer) Rules 1989.

**D-** That according to Article 38 (e) of the Constitution of Islamic Republic of Pakistan, 1973 the state is bound to reduce disparity in the income and earning of individuals including persons in the services of the federation, therefore in light of the said Article the appellant is fully entitled for the intended relief.

**E-** That the appellant has been discriminated on the subject noted above and as such the respondents violated the principle of natural justice.

F- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that the instant service appeal may kindly be accepted as prayed for.
