





**THAT ON ACCEPTANCE OF THIS APPEAL, THE  
RESPONDENTS MAY KINDLY BE DIRECTED TO  
REVISED THE CONFIRMATION ORDER OF SI AND**

**INSPECTOR IN PURSUANCE OF ORDER DATED 21/04/2012 WHICH IS ONLY EXTENT TO REVISION OF ASI AND FURTHER DIRECTED TO THE ASSIGN THE CORRECT SENIORITY TO APPELLANT WITH HIS BATCHMATES AND CONSIDER THE APPELLANT FOR PERFORMA/NOTIONAL PROMOTION TO THE POST OF DSP RESPECTIVELY FROM DUE DATE/ WITH HIS COLLEAGUES AND JUNIORS WITH ALL BACK AND CONSEQUENTIAL BENEFITS. ANY OTHER REMEDY, WHICH THIS TRIBUNAL DEEMS FIT AND APPROPRIATE THAT, MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.**

**RESPECTFULLY SHEWETH:**

**FACTS**

1. That the appellant was appointed as constable and then promoted to the post of officiating ASI from the post of Head Constable vide order dated 02/02/2005. The appellant was required to be confirmed in the rank of ASI w.e.from 25/01/2007 along with his colleagues but the appellant was confirmed in the rank of Assistant Sub Inspector in the year 2009 and promoted to post of officiating SI and also brought appellant's name to List E vide order dated 28/08/2009. **(copy of the promotion order and order dated 28/08/2009 is attached as annexure A, & B.**
2. That the appellant was not recommend to undergo upper class course for the reason appellant was overage due to late confirmation in the rank of ASI and the colleague of the appellant was passed the upper course and confirmed in the rank of SI on 19/07/2011 which is evident from the seniority list. Thereafter, the appellant was given revised confirmation to the post of ASI w.e.from 25/01/2007 as per his entitlement vide order dated 21/04/2012. **Copy of the revise notification is attacked as annexure-C.**
3. That thereafter, the worthy PPO was kind enough to grant permission to the overage Sis to undergo upper class course. Keeping in view that permission appellant was selected for upper course in the year 2015 and appellant successfully completed the upper course in the year 2015. **Copy of the notification dated 18/06/2015 is attached as annexure-D.**

4. That the appellant was confirmed in the rank of SI w.e.from 27/08/2015 vide order dated 08/09/2015 after completion of Upper class course. **(copy of confirmation order is attached as annexure-E).**
5. That the appellant was included to list F and promoted as offg: Inspector vide order dated 15/12/2015 with immediate effect while the colleagues of the appellant was included in list-F and promoted as offg: inspector on 20.12.2011 which is evident from the seniority list F. Thereafter the notification dated 29/12/2015 was issued wherein the appellant was included in list F and promoted as offg: inspector with his colleagues but in the List-F the colleagues of the appellant was placed at S.no 66 & 67 but the appellant was placed at S.No: 574 which is illegal and unlawful. The appellant was under pretext that the admission date of List F was revised which is incorrect. **Copy of the notification dated that 15/12/2015 and 29/12/2015 and seniority list are attached as annexure-F, F1 & G.**
6. That the appellant was confirmed as inspector w.efrom 15/12/2017 vide order dated 02/08/2018 while the colleagues of the appellant was confirmed in the year 2014. **(Copy of the order dated 02/08/2018 is annexure H).**
7. That one of the colleague of the appellant was promoted to the rank of DSP on regular basis with immediate effect vide order dated 30.01.2018. The appellant after confirmation in rank of inspector filed Departmental appeal for correction of seniority and for promotion to the post of DSP wherein appellant clearly stated that the appellant was on verge of retirement. **Copy of order and departmental appeal is attached as annexure-I & J.**
8. That thereafter, filling departmental appeal, the other colleague of the appellant Mohammad Javed was promoted to the post of DSP vide order dated 11/12/2018 and the appeal of the appellant was not responded which shows malafide. The appellant than file several reminders to the department for decision of the departmental appeal and lastly also request file to RTI for information regarding his appeal in response to which the appellant was called for personal hearing on 09/01/2023 but again till date no decision was made on departmal appeal of the appellant. **copy of order 11/12/2018, reminder, request personal hearing letter are attached as annexure-K, L, M, N & O.**


9. That the appellant feeling aggrieved having no other remedy hence the instant appeal on the following grounds amongst other.

GROUNDS:



- A) That not correcting the seniority list and not deciding the departmental appeal of the appellant was against the spirit of Supreme court judgment, norms of Justice and fair Play therefore liable to be modified.
- B) That the appellant was entitled for Seniority and position with their batch mates according to superior court judgment but he was deprived from his legal and constitutional right for the fault of others.
- C) That the appellant entitled to be confirmed in the rank of ASI in year 2007 but confirmed in the year 2009 which badly effect the seniority of the appellant however latter on the appellant was assign the revised confirmation in the year 2012 w.e.from 2007 In rank of ASI but not fruit full to the appellant because the colleagues of the appellant was promoted to inspector in year 2011. One mistake of the deptt given irreparable loss to the appellant whereby his considerable period was wasted.
- D) That many officers, junior to the appellant are serving in the rank of DSP, which is discrimination.
- E) That in response to the Departmental appeal of the appellant RPO Haraza region file comments to PPO wherein he admitted all the facts as correct mentioned by the appellant but the Departmental Appeal of the appellant was not decided. **Copy of comments is attached as annexure-P.**
- F) That the appellant is the senior most honest and dutiful officers with unblemished record but has not been promoted along with his colleagues. he has been discriminated.
- G) That appellant's entire services is unblemished and has completed all the courses but he has been denied due promotion on different occasions without his fault , so much so that he has not been n placed on the list of officers to be considered for promotion

- H) That the deptt may be directed to implement the judgment of Supreme Court OF Pakistan in Letter and spirit and give the seniority and confirmation along with his batchmates. the batch mates of the appellat is in DSP Rank even junior to the appellat was in DSP Rank and some is inspector which is evident from the seniority list .
- I) That the appellat was included to list F and promoted as offg: Inspector vide order dated 15/12/2015 with immediate effect while the colleagues of the appellat was included in list-F and promoted as offg: inspector on 20.12.2011 which is evident from the seniority list F. Thereafter the notification dated 29/12/2015 was issued wherein the appellat was included in list F and promoted as offg: inspector with his colleagues but in the List-F the colleagues of the appellat was placed at S.no 66 & 67 but the appellat was placed at S.No: 574 which is illegal and unlawful.
- J) That the appellat was not treated according to the law and rules and deprive from the legal right of the promotion.
- K) That the appellat seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellat maybe accepted as prayed for.

**RESPECTFULLY SHEWETH:**


1. That the instant appeal is pending before this Honourable Tribunal in which no date has been fixed.
2. That matter related to seniority and promotion and as according to Supreme Court Judgment reported as 2002 PLC cs 1388 no limitation run. So there is in interest of justice the limitation may be condoned.
3. That after submitting comments by the RPO Hazra Division the appellant under pretext that the appeal of the appellant may be accepted therefore the appellant waiting for the same but deptt after considerable delay call the appellant for personal hearing but in vain. So, delay of the appellant was not intentional.
4. That the august Supreme Court of Pakistan has held that decision on merit should be encouraged rather than knocking-out the litigants on technicalities including limitation. Therefore, appeal needs to be decided on merit (2003, PLD (SC) 724.
5. That, the appeal of the appellant on merit is good enough to be decided on merits.

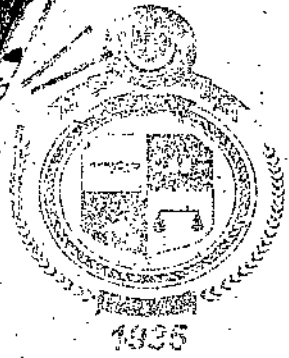

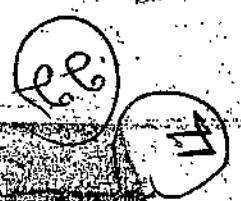

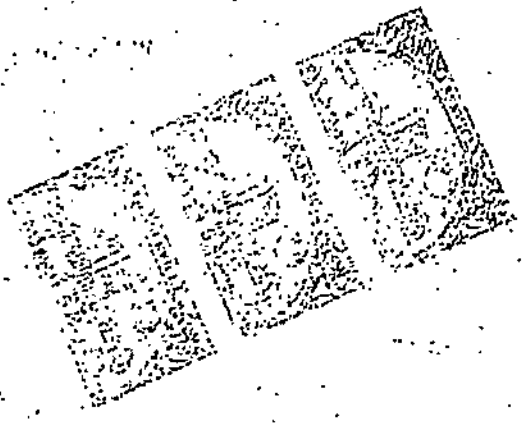
