



**APPEAL UNDER SECTION 4 OF KHYBER  
PUKHTUNKHWA SERVICES TRIBUNAL ACT  
1974 AGAINST THE IMPUGNED ORDER  
DATED:12.11.2022 AND 02.02.2023.**

---

**PRAYER IN APPEAL:**

*On acceptance of this appeal*

- i) Impugned Departmental promotion Committee minutes, order dated:12.11.2022 and 02.02.2023 may kindly be declare against the law and rules and the same may also be set aside and*
- ii) impugned seniority lists and especially final impugned seniority list of December 2022 may kindly be declare against the law and rules and the appellant may also be declare senior to Respondent No.3 from the date of his initial appointment with all back benefits of service.*

**Respectfully Sheweth:**

1. That initially the appellant was appointed in local Government department in the year 1995 and as such latter on the

appellant joined the respondent/department on 30.11.2005 as Junior scale Stenographer along with respondent No.3.(Copies DPC minutes, appointment order, seniority list along with salaries slip are annexure-A)

2. That latter on, a seniority list of 2005 was issued where against the law rules respondent No.3 was placed senior from appellant, so against the same the appellant raised object on the said seniority list and signed the same with protest, so respondent No.1 and 2 assured the appellant that the seniority list will be rectified accordingly but latter on, time and again the respondents issued impugned seniority lists by ignoring the appellant stance.(Copies of seniority lists are annexure-B)
3. That latter on, a Departmental promotion committee was constituted for promotion to the post of Senior Scale Stenographer BPS-16, so illegal/incorrect seniority list was placed before the DPC, where the appellant against raised objections on the same but the members of Departmental promotion committee recorded illegal observations on the same and as such on the basis of incorrect/illegal seniority list respondent No.3 was promoted to the post to Senior Scale Stenographer BPS-16 through impugned Departmental promotion committee minutes and order dated:12.11.2022.(Copies of impugned DPC minutes and order dated:12.11.2022 are annexure-C)
4. That against the impugned DPC minutes and order dated:12.11.2022, the appellant preferred departmental appeal on 15.11.2022 (Copies of departmental is annexure-D)
5. That latter on, during pendency of departmental appeal the respondents issued impugned seniority list of December 2022, so when the appellant got knowledge about the impugned seniority list of 2022 so against the same, the appellant also filed departmental appeal before the Resp No.2 so both the

appeals were dismissed through where the same was dismissed through impugned order dated:02.02.2023. (Copies of seniority list of December 2022 and impugned order dated:02.02.2023 is annexure- E)

That being aggrieved from the impugned orders, the appellant approached this Hon'ble Tribunal on the following grounds amongst other inter alia:

**GROUND:**

- A. That the impugned seniority lists and orders passed by respondent No.1 are against facts, law and relevant rules, hence untenable being unjust and unfair.
- B. That the whole departmental proceedings of departmental promotion committee was based on personal whims and wishes and they have promoted their blue eyed without caring for the policy and rules and just to accommodate his nears and dears, the appellant was kept junior on the seniority lists from respondent No.3 and recorded illegal observations in DPC minutes
- C. That ignoring the appellant's seniority in seniority list is glaring illegality which is totally against the law and relevant rules.
- D. That impugned promotion order dated:12.11.2022 and subsequent impugned order dated:02.02.2023 of appellate authority is against the law and rules.
- E. That the appellant well within time raised objections on seniority list but the respondents without caring for the law rules issued impugned seniority list and on the basis of illegal seniority lists promoted the appellant to next higher rank, which actions & inactions highly prejudiced the promotion prospects of the appellant, hence the actions & inactions of the respondents are illegal and against the constitution as well.

F That any other ground may be adduced during the course of argument, with the kind permission of this Hon'ble Court.

It is, therefore, most humbly prayed, *On acceptance of this appeal*



The details of vacancies to be filled in are as follows: -

Stenotypist(BPS-12). Two vacancies in this category were required to be filled in through initial recruitment. For that purpose 22 persons filed applications out of whom 19 candidates appeared in the written test and ten 10 persons qualified the written test and all the eligible candidates were subjected to practical test and then interviewed and in this category Mr. Murad Khan s/o Shafiullah r/o Dheri Julagram & Mr. Shaukat Ali s/o Mehmood Khan r/o Khar Malakand Agency were considered to be the most suitable for the posts.

K.P.O (BPS-10) 39 applications were filed for the post of Key Punch Operator out of whom 35 candidates appeared in the written test and 30 candidates qualified. All the eligible candidates were subjected to practical test and subsequently interviewed.






Mr. Hussain Ali s/o Aziz Gul r/o Batkhela Malakand was found to be the best for the post of Key Punch Operator.

Junior Clerk(BPS-5). One post of junior clerk was required to be filled in. For the post of Junior clerk 63 applications were filed, out of whom 50 persons appeared in the test and 25 candidates qualified the written test. Subsequently 24 persons were interviewed. Out of them Mr. Mohammad Kamran s/o Dost Mohammad r/o Khar Malakand Agency scored the highest marks and was found to be the fit person for the post

Naib Qasid. There was only one vacancy for the post of Naib Qasid. 56 persons filed applications for the said post. Out of whom Mr. Khwaja Sahib s/o Khaista r/o Mekkhand Malakand Agency is eligible for the post after thoroughly interviewing them.

01. SENIOR SCALE STENOGRAPHER (BPS-16)

The post of Senior Scale Stenographer (BPS-16) was fallen vacant to appointment by transfer of one Mr. Abdul Ahad Senior Scale Stenographer (BPS-16) to the Hon'ble Peshawar High Court, Mingora Bench/ Dar-ul-Qadwat Swat vide order bearing Endst: No. 336-44/Admn: dated 14/01/2022 of Hon'ble Peshawar High Court, Peshawar.

As provided at serial No. 02, column No. 05 of the Peshawar High Court (Subordinate Courts Staff) Recruitment Rules, 2003 the method of recruitment under this category is;

- i. 25% by initial recruitment; and
- ii. 75% by promotion, on the basis of Seniority-cum-fitness, from amongst the holders of the post of Stenotypist (BPS-14) with at least three years' service as such.

As per report of the Budget & Accounts Assistant, Sessions Courts Malakand according to budget book, number of sanctioned posts under this category is 03, & as such the available 01 vacant of the category is required to be filled by promotion. Thus, the committee unanimously decided to fill the post through promotion amongst the holders of the post of Stenotypist (BPS-14) with at least three years' service as such.

Therefore, as per working paper furnished by the office, the committee considered the following three senior most officials of the category for promotion;

- i) Mr. Shaukar Ali Steno Typist (BPS-14)
- ii) Mr. Murad Khan Steno Typist (BPS-14)
- iii) Mr. Fazal Ghaffar Steno Typist (BPS-14)

The committee not only perused the service record of the officials length of service, qualification but also personally interviewed them in reference to their proficiency, however, Mr. Murad Khan, Steno-typist amid interview raised an objection about his seniority and averred that keeping in view of his age, academic qualification & previous service in the Local Government Department and being recruited on the same date with Mr. Shaukat Ali has the privilege to be promoted as Stenographer instead of Mr. Shaukat Ali, Steno typist, but when he was confronted with the seniority lists since 2005 till December, 2021 maintained by this office for the purpose of promotion & other official purposes, persistently accepted & signed by him, he then responded that he only signed the same under protest in the year 2019-20. His objection

mentioned above is hereby replied by the committee in view of the official record which reveals that according to the office order bearing No. 2464-72 dated 30.11.2005 issued by the office of D&SJ, Malakand. (Competent/appointment authority) Mr. Shaukat Ali, was placed at serial No.1, whereas Mr. Murad Khan was placed at the S.No.2 meaning thereby that Mr. Shaukat Ali was considered senior in order of merit to Mr. Murad Khan by the Committee at the time of their initial appointment. Furthermore, Mr. Murad Khan, failed either to challenge the order dated 30.12.2005 or his seniority by filing any representation to the competent authority or availing any other channel as against the seniority list issued yearly since, 2005 till date, hence in this view of the matter the objection so raised has no legal sanctity and can't be considered at this belated stage by the committee.

Keeping in view of the above, service record & good ACRs for the last three 03 years of the officials, the committee unanimously recommended Mr. Shaukat Ali, for promotion to the post of Senior Scale Stenographer (BPS-16) on the basis of his seniority-cum-fitness.

02. SENIOR CLERK (BPS-14)

A post of Senior Clerk (BPS-11) was lying vacant due to newly creation of the post vide august Peshawar High Court Peshawar letter No. 1688-1705/B&A dated 06/06/2022.
