

Petitioner namely Sher Ali Khan in person present. Mr. Sher Ghani, Inspector alongwith Mr. Fazal Shah Mohmand, Additional Advocate General for the respondents present.

Representative of the respondents produced copy of letter No. 8488-90/WPC dated 08.06.2023 addressed by Regional Police Officer, Malakand at Saidu Sharif Swat to the Assistant Inspector General of Police, Legal, Khyber Pakhtunkhwa, Peshawar regarding implementation of the judgment under execution. Representative of the respondents requested that further time may be granted for implementation of the judgment.



The execution petition in hand was instituted on 14.10.2022, however the respondents have failed to implement the judgment, despite several opportunities being given to them. Vide order dated 10.11.2022, last chance was given to the respondents for submission of implementation report. Vide order dated 05.01.2023 another opportunity was granted to the respondents for submission of implementation report and the matter was adjourned for 09.02.2023. On the said date, representative of the respondents again sought time for submission of the implementation report and the matter was thus adjourned for 07.03.2023. On the said date too, the respondents failed to submit implementation report and another chance was given to them by adjourning the matter to 04.04.2022. On the said date, Mr. Imran Khan Inspector (Legal) had appeared before the Tribunal and had submitted an undertaking that the judgment under execution will be implemented and compliance report will be submitted soon.
