SECTION 4 UNDER APPEAL KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 FOR DECLARATION TO THE EFFECT THAT THE APPELLANT WAS REMOVED FROM ON 12/10/2020. THE APPELLANT WAS SERVING HAVELIAN BUT **SDEO** WITH AS DRIVER NOTICE, **SHOW CAUSE ANY** WITHOUT STATEMENT OF ALLEGATION AND WITHOUT **OPPORTUNITY PROVIDING** HEARING HAS BEEN REMOVED FROM SERVICE VIDE IMPUGNED REMOVAL FROM SERVICE ORDER DATED 12/10/2020 WHICH IS VOID, AB-INITIO CORAM NON JUDICE, AGAINST THE SETTLED PRINCIPLE OF LAW ON THE SUBJECT HENCE, THE IMPUGNED REMOVAL FROM SERVICE ORDER IS LIABLE TO BE SET ASIDE.

PRAYER: ON ACCEPTANT OF THE INSTANT SERVICE APPEAL IMPUGNED REMOVAL FROM SERVICE ORDER DATED 12/10/2020 MAY GRACIOUSLY BE SET ASIDE AND RESPONDENTS MAY BE DIRECTED TO REINSTATE THE APPELLANT IN SERVICE WITH ALL SERVICE BACK BENEFITS. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEM APPROPRIATE IN CIRCUMSTANCE OF CASE MAY ALSO BE GRANTED TO THE APPELLANT.

Respectfully Sheweth;-

That Facts forming the background of instant service appeal are arrayed as under;-

1. That the appellant was appointed as Driver on 03/08/2017 and was posted in the office of SDEO (Female) Havelian against the vacant post. Copy of

appointment order dated 03/08/2017 is attached as Annexure "A".

- 2. That the appellant took over the charge of the post in the office of SDEO (Female) Havelian District Abbottabad. Copy of charge report of the appellant is attached as Annexure "B".
- 3. That the respondent No. 3 posted the appellant from the office of the SDEO (Female) Havelian to SDEO (Female) Lora on 07/12/2019 but the order of transfer/ posting of the appellant was kept secrete by respondent No. 3.
- Female Havelian regarding misuse of Government vehicle as well as petrol collected from PSO Lady Gardan Abbottabad. Besides, the appellant also submitted that in case of misuse and damage of the vehicle, the appellant shall not be responsible. Copy of application duly endorsed is attached as Annexure "C".
- 5. That respondent No. 3 with out providing opportunity of personal hearing, show cause notice

and statement of allegation, removed the appellant from service vide impugned removal from service order dated 12/10/2020, received by the appellant on 16/10/2020. Copy of order is attached as Annexure "D".

6. That feeling aggrieved, the appellant filed Departmental appeal against the impugned removed from service order vide departmental appeal dated 20/11/2020, but reply of the departmental appeal is still awaited. Copy of departmental appeal is attached as Annexure "E" Hence, the service appeal of the appellant is filed inter alia on the following grounds.

GROUNDS:

- a) That the conduct of respondents Department towards the appellant is malafide, perverse, discriminatory and against the law.
- b) That the posting/ transfer order of the appellant from SDEO (Female) Havelian to SDEO Lora remained under key and lock and appellant was not aware about her posting from Havelian to Lora. That, the

appellant is being a made scape goat due to no fault in his part, the respondent No. 3 with the collusion of departmental officials without showing cause, explanation, proceeded, the appellant ex-parte which is against the law. That no one can be proved guilty without giving him opportunities of personal hearing, cross examining the opposite party Besides, as per article 10-A it is fundamental right of every citizen to have fair trail.

- his duty during the period with effect from

 4-12-2-19 to 11-10-20 which has been shown as absent. The appellant was not paid salary for the services rended by him towards the department.
- d) That respondents Department has the appellant to the place which is utterly unknown to the principals of jurisprudence, natural justice, fair play, as well as good governance.

e) That the matter relates to the terms and conditions of service, and this Honourable Tribunal has jurisdiction to entertain appeal of appellant under article 212 of the constitution of Islamic Republic of Pakistan.

f) That appeal of the appellant is titled within the period of limitation.

It is, therefore, humbly prayed that on acceptant of the instant service appeal impugned removal from service order dated 12/10/2020 may graciously be set aside and respondents may be directed to reinstate the appellant in service with all service back benefits. Any other relief which this Honourable tribunal deem appropriate in circumstance of case may also be granted to the appellant.



Para wise comments on behalf of the Respondents No 1 to 3.

Respectfully Sheweth:

Para wise comments on behalf of the respondents No 1 to 3 are as under.

PRELIMINARY OBJECTIONS.

- 1. That the appellant has no locus standi/cause of action to file service appeal.
- 2. That the service appeal is not maintainable in its present form.
- 3. That the appellant has not approach this Honorable Tribunal with clean hands.
- 4. That the appellant suppressed the original facts from this Honorable tribunal and not entitled for any relief and service appeal is liable to be dismissed.
- 5. That the service appeal is hopelessly time barred.
- 6. That the service appeal is bad for mis-joinder non -joinder of the necessary and proper parties.
- 7. That the appellant is stopped to agitate the instant matter before this Honorable Tribunal.
- 8. That the act of the respondent is in accordance with law and rules the order dated 12-10-2020 issued after fulfillment of the codal formalities, hence appeal is liable to be dismissed.

- 1. Para No.1 of the service appeal is correct to the extent that the appellant was appointed in accordance with rules and law.
- 2. Para No.2 service appeal is correct that after the appointment appellant took charge as Driver in the office of SDEO (Hevalain) Abbottabad and perform his duties with Concern 5DEO (Female) Havelain, but after the transfer of SDEO (Female) Havelian, Mst Yasmeen Aziz, the attitude of the appellant in taking interest/charge in the office of the new SDEO in the office of SDEO (Female) Havelian was very inappropriate, appellant created various difficulties. Neither complied with the new SDEO's order nor cooperated with the office in other matters. Proof of this is the order book from the SDEO order which the appellant did not comply. The SDEO wrote a letter against appellant, hence he was suspended but later on the appellant have given affidavit, and was re-instated on his services. (Photocopy of SDEO (F) Havelain letter and order Book, charge reports, reporst are annexed as Annexure "A" & "B" respectively).
- 3. The reply of Para No.3 of service appeal is that the appellant was transferred from office of the SDEO (Female) Tehsil Havelian to SDEO (Female) Tehsil Lora District Abbottabad due to his anger and bad behavior of which the appellant was well aware as he deliberately did not take charge at the said station. The appellant falsely stated that the order was kept secret from him only to protect himself. Appellant is not entitled for any relief. It is worth to mention that the SDEO (Female) Havelain proposed suspension of the appellant vide letter No. 834-38 dated 04-05-2019 on the improper conduct and disobedience. Later on Office of DEO (Female) Abbottabad Suspended the Appellant on SDEO (Female) Havelian Complaint vide letter No.3813-15 dated 04-05-2019. During this time, appellant submitted affidavit regarding his duties that he will perform his duty regularly and honestly. Thus the appellant was re-instated vide letter NO. 5500-4 dated 24-06-2019. (Photocopy of SDEO (F) Havelain suspension letter and the DEO (Female) Abbottabd suspension order, affidavit and the re-instatement order are annexed as Annexure "C" & "D" "E" "F" respectively).
- 4. Reply of Para 4 of the appeal is that concern SDEO (Female) Havelain reported vide letter No 1476 dated 03-12-2019, about the misbehavior misconduct, inefficiency and insubordination at work against the appellant. Appellant was verbally warned to correct his behavior, in retaliation but he filed application against the SDEO (Female) Havelian Abbottabad. The SDEO Havelian requested the SHO Havelian to take action against the appellant in accordance with the prevailing law due to the inappropriate behavior and threats of the appellant. Moreover, Manshi Khan Chowkidar Government Girls Primary School Havelian Station has also filed an application against the appellant. The appellant's application against the SDEO (Female) Havelain is merely to defend himself. (Photocopy of SDEO (F) Havelain report, application and application of the Munshi khan are annexed as Annexure "G" "H", "I" respectively)
- 5. Para No 5 of the appeal is incorrect. It is submitted that the transfer order of the appellant No. 10152-56 dated 07-12-2019 from SDEO (Female) Havelian to SDEO (Female) Lora Abbottabad has been issued. The appellant was well aware of the transfer order but

appellant disobeyed the order and did not take charge in SDEO Lora. The explanation was called vide letter NO. 592 dated 27-01-2020, but appellant did not response. The SDEO (Female) Lora Abbottabad sent absent report vide letter No. 796 dated 18-05-2020 regarding appellant non-compliance of transfer order. That on the report of the SDEO (Female) Lora show cause Notice No. 2964-68 dated 23-06-2020 served on appellant home address, and telephonic calls and message on his cell were made, but appellant did not give any response. The notice of absent dated 09-08-2020 also issued. (Photocopy of explanation order, report of SDEO(F) Lora and the copy of show cause Notice, photocopy of mobile calls and message and absent notice are annexed as Annexure "J", "K", "L" & "M" respectively)

6. Para No 6 of the appeal is incorrect. Appellant is not aggrieved person. It is worth to mentioned that the fact and finding inquiry was conducted vide letter NO 953 dated 12-02-2020 by Mst Ayesha Nas SDEO (Female) Lower Tanawal, and allegations leveled against appellant were proved. The regular inquiry was conducted vide letter No. 1906-14 dated 17-03-2020 but the appellant failed to appeared before the inquiry committee. Another show cause notice served on appellant home address vide No. 2964-68 dated 23-06-2020. But appellant neither appears nor submit his reply. Show cause Notice and absent Notice in two newspapers was published vide No. 5077 dated 04-08-2020 and 8th August 2020. After fulfilling all the legal requirements, the dismissal order of the appellant was issued. (Photocopy of fact and finding inquiry, regular inquiry are annexed as Annexure "N", "O", "P" respectively)

REPLY ON GROUNDS:

- a) Ground "a' of the appeal is incorrect. The conduct of answering respondents is in accordance with rules and law.
- b) Para "b" of the ground is incorrect. The appellant was aware of all the circumstances but did not deliberately take charge on his transfer. The department has done all the proceeding in accordance with the law. The appellant is giving this excuse to save himself. However, the department issued show cause notices to the appellant on his home address in accordance with the law which the appellant deliberately did not receive. The appellant is not entitled for any relief. Hence, the instant appeal of the appellant may be dismissed.
- c) Para "c" of the ground is incorrect. Appellant was treated in accordance with law and rules. Appellant remain absent w.e.f 04-12-2019 to 11-10-2020, hence not entitled for any relief.
- d) Para "d" of the ground is incorrect. As replied above.
- e) Para "e" of the ground is legal. However proper preliminary objections have been raised.
- f) Para "f" of the ground is that the appeal is timely barred and the appellant is not entitled for any relief.

It is therefore humbly prayed that in the light of foregoing comments the appeal may graciously be dismissed with cost.







2. On the target date we first, waited for him.


Around 11:20 a.m undersigned called him and told the purpose but he again refused to appear and expressed his old statement which he gave to you on 5.12.2019 and requested for posting in Abbottabad instead of Lora or Havelian due to his ailing father. (Annexed as D).

3. Ms. Nagina Bibi appeared before the committee and submitted her statement after replying to the questions which asked her verbally (Annexed as E).

Findings: 1. Awais Khan's behavior is immature and irresponsible towards his duties and service.

2. Ms. Nagina's attitude towards her ex driver/ subordinates does not depict any personal grudge despite Awais Khan's unprofessional attitude and blame of both driving skills and POL pending bills (Annex F)

4. SDEO (Fernale), Lora's letter about not taking over the charge by Awais Khan is self explanatory (Annexed as H).

CONCLUSION

All allegations /charges proved.

Recommendations:

1. Cancel his transfer order for SDEO (Female), Lora and retain him in your office for six months under observation with grooming on compassionate grounds by converting his absence period into leave without pay as per Govt rules and regulations.

2. Two annual increments with commutative effect may also be stopped.

3. SEDO (Female), Havelian may be directed to pay all outstanding /pending POL bills in the name of her office by PSO filling station, Abbottabad.
