Prayer:-

On acceptance of this appeal, the impugned order dated 03/12/2020, may kindly be set aside and the appellant may kindly be promoted/confirmed to list-"F" with all back benefits according to law and rules.

Respectfully Sheweth:-

1. That initially the appellant was recommended/promoted to list-"D" as officiating Sub-inspector alongwith the respondent No. 5 to 7 on 04/08/2011 and later on through order dated 16/03/2015 the appellant alongwith respondent No. 5 to 7 were confirmed as ASI's/PASI to list-"E".
(Copy of list "D" & list "E" are attached as annexure A & B)
2. That later on, on 09/02/2016 the appellant and respondent No. 5 to 7 were promoted on officiating basis to list-"F", so after recommending the appellant for the list-"F" on officiating basis, the appellant through written requests approached through official respondents for recommending his

name for the various mandatory courses of police because for promotion and for confirming his name to list "F" these courses were essential and mandatory according to law and rules. (Copy of order dated 09/02/2016/list-"F" and applications are attached as annexure C & D)

3. That thereafter, without considering the seniority of the appellant and that too no fault of the appellant confirmation/promotion to list-"F" was differed through impugned order dated 03/12/2020 and Juniors to appellant i.e. respondent No. 5 to 7 were confirmed/promoted to list "F". (Copy of impugned order dated 03/12/2020 is attached as annexure E)
4. That against the impugned order dated 03/12/2020 the appellant preferred departmental appeal to respondent No. 1 but the same was not decided in the statutory period. (Copy of departmental appeal is attached as annexure F)
5. That feeling aggrieved from the impugned order the appellant filling this service appeal on the following grounds inter alia.

G R O U N D S :-

- A. That the impugned order dated 03/12/2020 is against the law rules and seniority, and also again the principle of natural justice hence liable to be set aside.
- B. That the appellant was condemned unheard as no opportunity of personal hearing/defense has been provided to the appellant.
- C. That the appellant's promotion was ^ediffered on the ground that the appellant has not undergone the requisite mandatory courses to the list "F" and as such without any fault of the appellant his promotion was differed and without carrying for the seniority and law and rules juniors to appellant were promoted, which is against the norms of justice.
- D. That when the appellant was promoted to list "F" on officiating basis in the year 2016, so time and again the appellant made several written requests to official respondent for recommending his name for requisite/mandatory courses, but no fruitful result.
- E. That the grounds on which the appellant was not promoted to list "F"/confirmation is against the law

and rules, because according to relevant rules the courses are not mandatory for confirmation to list "F" but the official respondents totally ignored the aspect and with ill intention promoted/confirmed his blue eyed i.e. respondents No. 5 to 7.

- F. That the appellant seeks permission to added other grounds during the course of arguments.

It is, therefore, most humbly prayed that On acceptance of this appeal, the impugned order dated 03/12/2020, may kindly be set aside and the appellant may kindly be promoted/confirmed to list-"F" with all back benefits according to law and rules.

Any other relief available in the circumstances of the case, not specifically asked for, may also be granted to the appellant.

PRELIMINARY OBJECTIONS:

1. That the appeal is badly barred by Law & limitation.
2. That the appellant has got no cause of action and locus standi to file the present appeal.
3. That the appeal is bad due to misjoinder and nonjoinder of necessary parties.
4. That the appellant has not come to the Tribunal with clean hands.
5. That the instant appeal is not maintainable in its present form.
6. That the appellant has concealed the material facts from this Hon'ble Tribunal.

FACTS:

1. Pertain to record, hence needs no comments.
2. Incorrect. Police Department is a discipline force having its rules and regulations which are being followed in letter and spirit. Promotion from one rank to another rank is being dealt in accordance with seniority cum fitness as envisaged in Police Rules 13.1. Similarly confirmation in the substantive rank is also governed by Police Rules which are being strictly adhered by the respondent department. Prior to confirmation in the rank of Sub-Inspector, one has to fulfill some criteria mentioned for the confirmation in the rank of Sub-Inspector. The appellant was promoted to the rank of Sub-Inspector on 09/09/2016, however for the confirmation in the rank of Sub-Inspector, the appellant was required to fulfill certain criteria for the confirmation i.e. passing Upper College Course and criteria mentioned in Police Rules 13.10(2) and 13.13 which was not completed at that time, therefore the stance taken by the appellant for

recommending his name to list "F" is not prudent to the mind as for recommendation to list "F" one has to fulfill the above mentioned criteria. As far as the respondent No.05 to 07 is concerned, in this connection it is submitted that they have been confirmed in the rank of Sub-Inspector on 20/02/2020 respectively, fulfilling the requisite criteria for confirmation i.e. passing upper college course and other mandatory periods as envisaged in Police Rules 1934. (Copy of selection for respondents No. 05 & 06 i.e. order No. 12343-61/E, dated 19.12.2018, passed by respondent No. 04, result No. 1035/S, dated 23.04.2019 passed by Commandant Police Training College Hangu and selection order No. 4737-66/E, dated 17.04.2019, result No. 1735/S, dated 24.09.2019 passed by Commandant Police Training College Hangu is hereby attached as annexure A, B, C & D). The name of appellant was not recommended for inclusion in list "F" because the appellant did not passed the upper college course till 2020. It is also pertinent to mention here that the name of appellant was included in the upper college course vide order No. 7038-54/E, dated on 09/08/2018, however he returned to the concerned district as unqualified on 25/09/2018, therefore he did not passed the upper college course while his other colleagues i.e. respondent No.05 to 07 qualified the upper college course before the appellant. (Copy of Order No. 7038-54/E, dated 09.08.2018 passed by Respondent No. 04 & Signal No. 100830-50, dated 19.10.2018 Office of Commandant PTC Hangu is hereby attached as Annexure E & F).

3. Incorrect. The appellant was recommended for upper college course however due to his own fault he was returned as unqualified so the fault lies on part of appellant rather than the respondents. As far as the deferment of the appellant from list "E" is concerned, in this connection the same has been explained thoroughly at para No.02.
4. Pertain to record, however it is submitted that unless and until the requisite criteria for the confirmation in the rank of Sub-Inspector is not being fulfilled, no one could be recommended for inclusion to list "F".
5. That action and inaction of the respondents are in accordance with law therefore the instant service appeal may kindly be dismissed on the following grounds.


GROUNDS:


- A. Incorrect. That the order dated 03/12/2020 is in accordance with law and rules.
- B. Incorrect. Promotion and confirmation to the substantive rank is being dealt in accordance with Police Rules 1934 as there are certain principles for the same which cannot be violated at any cost for the sake of principle of seniority-cum-fitness.


- C. Incorrect. As explained above.
- D. Correct to the extent that appellant was promoted to list E on officiating basis in the year 2016; however for the confirmation in the rank of Sub-Inspector, he was supposed to fulfill the requisite criteria for confirmation which he did not fulfill, therefore he was confirmed in the rank of Sub-Inspector later on after fulfilling the requisite criteria.
- E. That the respondents may be allowed to add any other grounds at the time of hearing of appeal.


PRAYER:

STANDING ORDER NO. 3 /2015

Mandatory Trainings in Specialised Schools

This Standing Order is issued under Article 10(3) of Police Order 2002 in pursuance of the Police Policy Board decision taken in its 18th meeting held on 13th August 2015.

2. Aim: - This Standing Order aims at enhancing the capacity of police officers in such essential skills that would enable them to work effectively and efficiently. KP Police have established a number of specialised schools that are imparting valuable training courses to lower and upper subordinates. It is therefore essential that officers take advantage of these training facilities.

Specific minimum tenure of upper subordinates in the specialised schools needs to be linked with promotion to the next rank.

3. Mandatory Training for promotion of Upper Subordinates: - An Upper Subordinate shall not be confirmed and promoted to the next higher rank unless he/she, in addition to other mandatory requirements, completes and qualifies training courses and obtain a total of nine (09) marks in one or more of the following schools:

- A. Police School of Investigation, Peshawar.
- B. Police School of Intelligence, Abbottabad.
- C. Police School of Tactics, Peshawar.
- D. Police School of Explosive Handling, Nowshera.
- E. Police School of Information Technology, Peshawar.
- F. Police School of Public Disorder and Riot Management, Mardan.

4. A training course of one week duration at any of the above schools will carry one (1) mark while a two week course will carry two (2) marks. A candidate has to successfully complete and qualify each of the courses.

5. An upper Subordinate may choose different courses at any school but will not repeat the same course.

6. All the above mentioned Schools will keep a complete record of the participants of the courses and the marks obtained by each participant in those courses and it would be the responsibility of the Director of each school to share the record with DIG Training and AIG Establishment.

7. On the completion of any course, the Director of the respective School will also send a report in respect of each participant to the head of the concerned District/Region/Unit who will be responsible to ensure that the result of the course attended and marks obtained is entered in the service roll of the concerned upper subordinate.


8. Directors of each of the above Police Training Schools will issue the details of all courses that are to be offered in the next six months one month in advance. DIG Training will circulate the schedule etc of the courses among the various units.

8. Respective RPOs and DPOs will nominate officers for the above courses. However, once an officer is selected for a course, his name will not be cancelled. In case an officer nominated for a course does not join the course for which he is selected, he will stand suspended and closed to a Region other than where he is serving.

9. **Application:** - This standing Order will be effective with immediate effect. However, those upper subordinates who are to be promoted within six months of the notification of this order will earn two points prior to promotion while those that are to be promoted between 6 months and one year of the notification of the order will earn three marks prior to promotion.

10. **Power to remove difficulties:** If any difficulty arises in giving effect to this order, the Provincial Police Officer may by notification make such provisions as deemed appropriate.

11. **Amendment:** - All previous Standing Orders on the subject, to the extent of the provisions of this order, shall stand amended.


