Respectfully Sheweth:-

Comments on behalf of respondents are submitted as under:-

PRELIMINARY OBJECTIONS:-

- 1. That the appellant has no cause of action to file the instant appeal.
- 2. That the appellant has no locus standi to file the present appeal.
- 3. That the appellant did not come to this Honorable Tribunal with clean hands.
- 4. That the present appeal has been filed to pressurize and blackmail the respondents.
- 5. That instant appeal is hopelessly time barred hence, liable to be dismissed.
- 6. That the instant appeal is not maintainable in its present form hence, liable to be dismissed.
- 7. That the appellant has suppressed the material facts from this Honorable Tribunal, hence, not entitled for any relief and appeal is liable to be dismissed without any further proceeding.
- 8. That impugned order dated 30-09-2022 was issued after observing all the codal formalities hence, same is liable to be maintained.

Factual Objections:-

- 1. That the Para No. 1, of the instant service appeal pertains to service record of the appellant hence, need no comment.
- 2. That the Para No. 2, of the instant service appeal is subject to cogent proof.
- 3. That the Para No. 3, of the instant service appeal as composed is incorrect hence, denied as appellant not acquitted from criminal charge as Annexure "D" is <u>pre-arrest bail order not acquittal one</u>. Furthermore, as per report of Principal GHSS

Ziarat Masoom Abbottabad vide Endstt: No. 157 dated 06-06-2022, appellant remained absent from duty without any application / information w.e.f 21-05-2022 to 30-09-2022. Furthermore, as per **Rule 20** of Govt of Khyber Pakhtunkhwa Conduct Rules 1987, it was the duty of the appellant to inform the Principal concerned regarding his involvement in a criminal case but he failed to do so. (Copy of Absent Report dated 06-06-2022 and relevant pages of Rules are annexed herewith as **Annexure "A" & "B"** respectively)

- 4. That the Para No. 4, of the instant service appeal as composed is incorrect hence, denied as no application was received.
- 5. That the Para No. 5, of the instant service appeal is correct. Furthermore, Show-cause notice was served upon appellant vide Memo No. 3979 dated 02-07-2022 through Principal GHSS Ziarat Masoom Abbottabad but appellant failed to submit reply within stipulated time and also failed to appear for personal hearing. Moreover, absence notice was published in leading newspapers vide letter No. 6290 dated 01-09-2022 whereas, appellant failed to appear in person and also failed to reply the reasons of absence of notice. (Copy of letter No. 3979 dated 02-07-2022, Show-cause notice, letter No. 6290 dated 01-09-2022 and Newspaper cutting are annexed as Annexure "C", "D", "E" & "F" respectively)
- 6. That the Para No. 6, of the instant service appeal is correct.
- 7. In reply to Para No. 7, of the instant service appeal it is submitted that as impugned order dated 30-09-2022 has been issued by competent authority after observing all codal formalities. Hence, same is liable to be maintained.

GROUNDS:-

- a. That ground a, of the instant appeal as composed is incorrect hence, denied as replied above.
- b. That ground b, of the instant appeal as composed is incorrect hence, denied and not admitted as replied in para-5 above.
- c. That ground c, of the instant appeal as composed is incorrect hence, denied as Showcause notice was served upon appellant vide Memo No. 3979 dated 02-07-2022 through Principal GHSS Ziarat Masoom Abbottabad but appellant failed to submit reply within stipulated time and also failed to appear for personal hearing. Moreover, absence notice was published in leading newspapers vide letter No. 6290 dated 01-09-2022 whereas, appellant failed to appear in person and also failed to reply the reasons of absence of notice.
- d. That ground d, of the instant appeal as composed is incorrect hence, denied and not admitted. The appellant has treated according to law, rules and policy.

- e. That ground e, of the instant appeal as composed is incorrect hence, denied as impugned order dated 30-09-2022 has been issued by competent authority after observing all codal formalities.
- f. That ground f, of the instant appeal as composed is incorrect hence, denied and not admitted. No valuable rights of appellant have been violated
- g. That ground g, of the instant appeal as composed is incorrect hence, denied and not admitted. Appeal is hopelessly time barred.
- h. That the respondents seek leave of this Honorable Tribunal to raise additional points at the time of arguments.

It is, therefore, very humbly prayed that in the light of forgoing comments the service appeal in hand may graciously be dismissed with cost throughout.

GOVERNMENT OF KHYBER PAKHTUNKHWA CONDUCT RULES, 1987


Statutory Provision regarding Conduct.

Section.15 Civil Servants Act, 1973.-The conduct of a civil is regulated by rules made, or instruction issued, by Government or a prescribed authority, whether generally or in respect of a specified group or class of civil servants.

The Khyber Pakhtunkhwa Government Servants (Conduct) Rules, 1987.

- 1. Short title and commencement. (1) These rules may be called The Khyber Pakhtunkhwa Government Servants (Conduct) Rules, 1987.
- (2) They shall come into force at once.
- 2. Extent of application:-These rules apply to every person, whether on duty or on leave within or without The Khyber Pakhtunkhwa serving in connection with the affairs of The Khyber Pakhtunkhwa, including the employees of the Provincial Government deputed to serve under the Federal Government or with a statutory Corporation or with a non-Government employer, but excluding:-
 - (a) members of an All-Pakistan Service serving in connection with the affairs of the Province;
 - (b) employees of the Federal Government or other authority deputed temporarily to serve under the Provincial Government; and
 - (c) holders of such posts in connection with the affairs of the Province of Khyber Pakhtunkhwa as the Provincial Government may, by a notification in the official Gazette, specify in this behalf.
- 3. **Definitions**:-(1) In these rules, unless there is anything repugnant in the subject or context;
 - (a) "Government" or "Provincial Government" means the Government of The Khyber Pakhtunkhwa;
 - (b) "Government Servant" means a person to whom these rules apply;
 - (c) "Member of a Government Servant's family" includes:-
 - (i) his wife, children and step children, parents, sisters and minor brothers, residing with and wholly dependent upon the Government Servant; and
 - (ii) any other relative of the Government servant or his wife when residing with and wholly dependent upon him; but does not





20. Report by Government servant in case of his involvement is criminal case: If a Government servant is involved as an accused in a criminal case he shall bring the fact of such involvement or conviction, as the case may be, by notice of the Head of the Office or Department immediately or, if he is arrested, released on bail, soon after such release.

21. Unauthorized communication of official documents or information: Government servant shall, except in accordance with any special or general order Government, communicate directly or indirectly any official information or contents of any official document to a Government servant not authorised to receive or to a non-official person, or to the press.

- 22. Approach to Members of the Assemblies:- No Government servant sk, directly or indirectly approach any member of the National Assembly or a Province Assembly or any other non-official person to intervene on his behalf in any matter.
- 23. Management, etc. of Newspapers or Periodicals:- No Government shall except with the previous sanction of Government, own wholly or in periodical publication.
- 24. Radio-Broadcast and communications to the Press:- No Government servant shall, except with the previous sanction of Government, or any other authority empowered by it in this behalf, or in bonafide discharge of his dutie participate in a radio broadcast or television Programme or contribute any articles write any letter, either anonymously or in his own name or in the name of any other person to any newspaper or periodical:

Provided that such sanction shall generally be granted if such broadcast television programme or such contribution or letter is not, or may not k considered likely to jeopardize the integrity of the Government servant, k security of Pakistan or friendly relations with foreign states or to fend public ordardecency or morality, or tantamount to contempt of court, defamation or incitement of an offence:

Provided further that no such sanction shall be required if such broadcast of television programme or such contribution or letter is of a purely literary, artists or scientific character.

*Note:-Government officials unless so authorized are not allowed to hold pression conferences and to have direct contacts with media. *No.SOK-V/E&AD/Mise/VOL-IV DI; 11-10-2018]

25. Publication of information and public speeches capable of embarrassing Government :-(1) No Government servant shall, in any document published or any public atterance, radio broadcast or television programme, or in any other manner make any statement of fact or opinion which is capable of embarrassing the Federal or any Provincial Government.


