WRITTEN COMMENTS for and on behalf of Respondents 7, 9-11, 13-24 and 26

I. PRELIMARY PBEJCTIONS:

- 1. That the subject Appeal under reply is not at all maintainable both in substance and as well as in form.
- 2. That there accrues no *locus standi* / cause of action to the appellant, as the matter of seniority had in principle been laid to rest by the apex court while deciding Civil Appeals No. 320-324 of 2012 and 126-130 of 2013 vide judgment dated 03.11.2016.
- 3. That the appeal in hand is squarely hit by the principles of constructive res judicata.
- 4. That appellant, who's very appointment / induction in the Management Cadre of the Health Department has been held to be bad in law by this Tribunal, is *estopped* by his own conduct to file the instant appeal.
- 5. That the appellant has not stated the facts of the case as they actually obtain and has conveniently held back all material information, for which he is liable to be put to task.
- 6. That the grounds of appeal are too vague and general besides being insubstantial and false. The appellant has conveniently avoided to particularize and state any tangible

objection against the Seniority List which he seeks to challenge. He has even avoided to mention his very date of his appointment.

- 7. That the appeal in hand is clearly barred by law.
- 8. That the appeal under reply is hopelessly barred by time.
- 9. That appellant has raised a false and vexatious claim and has approached the Tribunal with unclean hands, so the appeal under reply is liable to be dismissed with special compensatory cost.

II. REPLY ON FACTS.

- 1. Correct, however the induction of the appellant in the Management Cadre has been notified on 07-05-2018, wherein he figures in Serial No. 31 of the Notification. About this very notification this august Tribunal had already passed a detailed Judgment while deciding Service Appeal No: 830-P/2018 and few other connected Service Appeals, thereby holding that the Notification *ibid* was in conflict with the relevant provision of Khyber Pakhtunkhwa Health (Management) Service Rules, 2008. (the Rules).
- 2. Needs no reply as this particular issue has already been dilated upon and decided by the august Tribunal as mentioned above.
- 3. Incorrect, misconceived and misconstrued, hence denied.
- 4. Correct that the *vires* of the Rules and all other matters relating to one-time induction of doctors from General to Management Cadre notified back in 2008/09 had been subject matter of different Service Appeals before the Tribunal, whereby the *vires* of Rules was upheld and observation regarding two years cushion period to be provided to those doctors who at the relevant time did not have the prescribed minimum qualification was passed.
- 5. Correct, however pertinent to add that while deciding CPLA's on 03-11-2016, the Supreme Court of Pakistan has clearly laid to rest the issue of seniority in the following terms;

"As regard the submission of the learned ASC for the appellants in Civil Appeals No. 320 to 324 of 2012 he was unable to explain before us as to how the seniority of the appellants will be affected by the impugned judgement of the

Tribunal. More so, when the respondents claim before the tribunal itself was not that of granting them seniority but that of allowing them to acquire qualification for opting in management cadre. If the respondents at all join Management cadre, their seniority will be counted from the date of their joining in the Management cadre and not from any earlier period which is also established principle that a person joining fresh cadre is relegated to the lowest position of that cadre. Thus, there seems to be hardly any reason much less justifiable to interfere with the impugned Judgment of this Tribunal more so on the ground urged by the learned ASC for the appellants. The Civil Appeals No. 320 to 324 of 2012 are therefore, dismissed."

- 7. Correct, however while deciding Service Appeal No: 830/2018 this august Tribunal has interpreted the relevant rule in the following manner:
 - **"7.** Therefore-noted history of matter relevant for decision of appeals is hand suggest that the Health (Management) Service Rules 2008 were never declared ultra vires by any court of law and duly held the field from date of inception. In appellants rules, the pursuance to the appointed/absorbed in the Management Service. The issue, on the other hand, seems to have arisen after amendment in Rule 10 in view of judgement of this Tribunal and that of apex court when the same was misinterpreted and misapplied in order to provide cushion period of two years to those officials who were duly qualified for absorption into the Management cadre under Rule 10 of N.W.F.P Health (Management) Service Rules, 2008 read with schedule-I thereto. By virtue of amendment dated. 10.05.2017, only the officers of the General cadre who were in regular and continuous service, were provided opportunity to improve their qualification as required by the Rules of 2008 in order to exercise the option under the rules. By no stretch of imagination, the amendment ever meant to include the officers who were qualified enough for their absorption into the Management cadre after the promulgation of the rules in 2008 but did not opt for the purpose. The language of Rule 10 itself suggested that it was a onetime exercise to fill in the posts in the Management cadre from amongst the officers of General cadre. Through such provisions the scope of Rule 10 was enlarged to include the officers who could improve their qualification in order to match the requirements contained in the rules within a period of two years and not otherwise. In such view of the matter, it can safely be held that the respondents who fell into the category of officers having prescribed qualification at the relevant time but failed to opt for their absorption into the management cadre before the coming into force of amended rules on 20.05.2017, were not eligible for the purpose of absorptionsubsequent to the amendment in the rules."

- **15.** Misconceived, hence denied. The issue was raised by the appellant before the Peshawar High Court through Writ Petition No. 2868/2021, however, the august High court had upheld the Notifications dated. 14-06-2021, 25-06-2021 and 06-07-2021.

- 17. Misconstrued and false as laid, hence denied. The issue of seniority has been correctly decided by the competent authority much in accordance with the rulings of Supreme Court of Pakistan in the matter.

Without prejudice to the answering respondents valid challenge to the very induction of appellant in the Management Cadre, as a matter of record the date of induction of the former in the said Cadre is much prior to that of appellant.
