- 1. Pertains to record, hence no comments.
- 2. The respondents prepared the seniority list according to prescribed mechanism and in light of ESTA CODE / absorption policy etc. While compiling seniority list of the Village Secretaries those officials, who were adjusted against lower grade than their original grade were kept at the top of seniority list. The appellant filed appeal against rhe seniority list to respondent No.1, who after proper hearing in light of above referred rules / policies examined its contents and rightly rejected the appeal of appellant and issued final seniority list for further necessary action i.e. promotion etc. it is pertinent to mention



that the instant appeal is filed much later than completion of the seniority process and occurrence of subsequent events.

- 3. Incorrect, there is no such promotion in the pipeline.
- 4. Incorrect, hence denied. Balance of convenience lies in favour of official respondents in case of denial of interim relief, applicant will not suffer irreparable loss. Moreover, he has no prima facie case in his favour,
- 5. That stance taken in parawise comments/reply may kindly be considered as integral part of their reply.




