

RESPECTFULLY SHEWETH:-

Reply on behalf of respondents is submitted as under:-

Preliminary Objections:-

1. That the applicant has no cause of action to file the instant application.
2. That the instant application is not maintainable in its present form.
3. That the applicant has no locus standi to file instant application.
4. That applicant was appointed as PET (Untrained) on 12-06-1995 and acquired short term course on 11-05-1999 and his seniority.
5. That as per reported judgment 1982 PLC (CS) 784 untrained period cannot be counted in seniority. Hence, in view of the judgment of Apex court instant application is liable to be dismissed on this score alone.
6. That the applicant has filed the present application just to pressurize the respondents.
7. That the applicant has not come to this Honorable Tribunal with clean hands. Hence, not entitled for any relief.


8. That the applicant is estopped to sue due to his own conduct.
9. That the instant application is not maintainable due to non-joinder and mis-joinder of necessary parties.
10. That the instant application is against the Rules and Policy of the Government as well as section **56 (d) of the Specific Relief Act.**


FACTUAL OBJECTIONS:-


1. No comment.
2. That the Para No. 02 of the instant application as composed is incorrect hence, denied and not admitted. As per final seniority list the name of applicant falls at serial No. **730** wherein last person promoted was on serial No. **369**. Further submitted that 77 SPETs were recommended by Departmental Promotion Committee (DPC) on the basis of acquiring M.Sc HPE and B.Ed vide Notification dated 05-04-2022. Moreover, **Annexure "F"** of the main service application is self created and not acceptable. As Seniority list was uploaded on official website of E&SE Department. Hence, application in hand is liable to be dismissed without any further proceedings. (Copy of relevant pages of seniority list and Notification dated 05-04-2022 are annexed as **Annexure "A" & "B"** respectively)
3. That the Para No. 3 of the instant application as composed is incorrect hence, denied. Joint parawise comments on behalf of answering respondents are also being submitted before this Honorable Tribunal and instant reply may be considered as part and parcel of comments.

That answering respondents seek leave of this Honorable Tribunal to raise additional grounds/ points during the course of arguments.

Under the circumstances it is humbly requested that in the light of above referred facts application in hand may please be dismissed with cost.


