Comments on behalf of respondent No.1 to 3

Respectfully Sheweth:

Preliminary Objection:

- 1. That the appellant has got no cause of action to file the instant appeal.
- 2. That the appellant has not come to this honorable Tribunal with clean hands.
- 3. That the appellant has concealed material facts from this Honorable Tribunal.
- 4. The appellant has been removed from service in light of rule 3(d) of civil servants E&D Rules 2011 and Rule 9 of the ibid rules.
- 5. That the appellant has stopped by his own conduct to bring the present appeal.
- 6. That the appeal is bad due to miss joiners of necessary parties.
- 7. That the appeal is barred by law and no departmental appeal is made to the competent authority against the impugned order. Hence not maintainable under Section-4 of Service Tribunal Act.

On facts:

- 1) That Para-1 pertains to record, hence no further comments.
- 2) That Para-2 is Incorrect. The appellant regularly draw her salaries under DDO Code (MW6015-Inspiction) as ASDEO in the office of DEO North Waziristan since 2018, while she was transferred in the year 2018 from DEO Office to School. It is pertinent to mention here that she had never performed her duty either at school or DEO Office Since 2018.
- 3) That Para-2 is Incorrect. The appellant was regularly drawing her salary from DEO Office NWTD(DDO Code MW6015) since 2018 while she had never perform duty at DEO Office since 2018. She was also served an Explanation Notice Endstt: No 15705 dated 03/04/2021 (Copy is annexed as A), but she failed to respond and remain absent from her duty. The office of the respondent No 3 than signed Source-II/ Inactive pay but District account office has not honored the source. Than the appellant change her cost center with the help of clerical staff and draw her salaries from GGHS Zawab kot NWTD. Than the office of the respondent No3 wrote a letter No 20353-59 dated 29/06/2021(Copy is annexed as B) to respondent No 2 to initiate disciplinary action against the willful absentee and drawl of salary as ASDEO. Again she was served a show cause notice No 28458-63 dated 10/05/2022. (Copy is annexed as C). She also fail to

respond and remained absent from her duty. Finally she was imposed major penalty of removal from service by the competent authority with Endstt: No 5823-27 dated 08/06/2022. (Copy is annexed as D)

- 4) That Para-2 is Incorrect. The appellant has been removed from service as per report of the respondent No 2 in light of rule 3(d) of civil servants E&D Rules 2011 and Rule 9 of the ibid rules.
- 5) That Para-3 is incorrect. Detail reply is submitted in the above paras on facts.
- 6) That keeping in view the above facts, the instant appeal may kindly be dismissed on the following grounds

Grounds:

- A. <u>Incorrect and Denied</u>, the Respondent Department is bound to abide by the law /Rules and Policy and has acted accordingly.
- **B.** <u>Incorrect and Denicd</u>, Detail Reply has already been submitted above under Para-2 and 3 above on facts.
- C. <u>Incorrect and Denied</u>, The appellant had been withdrawing her salary since 2008 from the DDO Code MW6015 (office of the DEO (F)) while she had neither perform her duty at DEO office Nor at School during the mention period.
- D. <u>Incorrect and Denied</u>, The appellant was served with explanation and show cause notice but she fail to reply the same. She was absent since 2018 and was drawing her salary regularly.
- E. <u>Incorrect and Denied</u>, The appellant is just trying to mislead this honorable tribunal by manipulating the facts, she was absent for almost 4 years and there is no issue of maternity leave which might be for 90 days by rules after fulfilling other formalities.
- **F.** <u>Incorrect and denied</u>, the Respondent Department is bound to abided by the law /Rules and Policy and has acted accordingly.
- **G.** <u>Incorrect and denied</u>, the Respondent Department is bound to abided by the law /Rules and Policy and has acted accordingly.
- **H.** Respondents are also seeking permission of the Honorable Tribunal to produce additional grounds and proofs at the time of Hearing.


