## PRELIMINARY OBJECTIONS:-

- 1. That the instant Service Appeal is not maintainable in the present form.
- 2. That the appellant is estopped by his own conduct to file the instant appeal.
- 3. That the appellant has not come to the Hon'ble Tribunal with clean hands.
- 4. That the appellant has suppressed material facts from the Hon'ble Tribunal.
- 5. That the instant Service Appeal is not maintainable for nonjoinder/miss-joinder of unnecessary parties.
- 6. That the appeal is badly barred by law & limitation, hence liable to be dismissed without any further proceeding.

#### **ON FACTS:-**

1. That the appellant while posted as incharge Technical Unit at RPO office, Abbottabad was responsible to extend assistance to local Police of Hazara in arrest and detection of criminals involved in different crime but he misused his authority and got involved himself in un-lawful and illegal selling of CDRs for ulterior motive and un-lawful gain. The appellant was found involved in provision of CDRs to irrelevant persons who misused the same to the injuries of others. The appellant also confessed his guilt during the initial enquiry conducted by PSO to Regional Police Officer, Hazara.

- 2. The appellant was properly charge sheeted and proper departmental proceedings were conducted against him. During the enquiry proceedings, he was found guilty and recommended for major punishment. (Copy of charge sheet, reply and inquiry report is enclosed as annexure "A & B ").
- 3. Correct.
- 4. The appellant preferred departmental appeal in which the appellant was heard and appellate authority ordered to conduct de-novo enquiry. During de-novo enquiry, he was again found guilty.

#### **GROUNDS:-**

- A. Correct to the extent of involvement in selling of CDRs, hence this fact was thoroughly probed during all the inquiries and found proved.
- B. Correct. The appellant confessed his guilt.
- C. Correct to the extent of offering bribe of Rs 50,000/- to enquiry officer for extending favour during enquiry proceedings.
- D. Incorrect. The allegations levelled against appellant were proved during enquiry and all the codal formalities were fulfilled.
- E. Incorrect. The appellant was guilty, therefore, deliberately avoided the enquiry proceedings. Final showcause notice was issued to the appellant to which reply was submitted and thus the impugned order has been passed after fulfilling all codal formalities. (Copy of final show cause notice and reply is attached as Annexure "C").
- F. Incorrect. Besides confessional statement, all the facts and circumstances have proved the allegations levelled against him.
- G. Incorrect. During discreet enquiry, it has been proved that CDR provided to irrelevant person have been misused.

- H. That the appellant was found in illegal bargain of CDRs to irrelevant people and for this purpose, he attended his office on holiday but later on he misstates the fact that his email ID was locked.
- I. The appellant confessed his guilt before the enquiry office during preliminary enquiry.
- J. The appellant was found guilty in both the enquiries.
- K. The instant service appeal is badly time barred.

## PRAYER.

In view of above, it is most humbly prayed that the instant service appeal does not hold any legal force which may graciously be dismissed with cost.

d) On 04 Feb, 2022 at about 18:15 hours you went to the house of Enquiry Officer and offered him an illegal gratification/ bribe of Rs. 50,000/-.

All this shows your ill-will in the performance of official duties. Your this ignoble act is a sever violation, a professional dishonesty, malafide intention and gross misconduct in term of police E&D Rules-1975, hence this charge sheet.

#### BRIEF OF ALLEGATIONS:

A departmental enquiry was received against Constable Hafeez ur Rehman No.13 of Technical Unit vide District Police Officer, Abbottabad Endst: No.38/PA dated 11-02-2022 with the allegation that "The foul and avaricious play which he deceitfully did had come into the notice of Senior Officer that he while posted as Incharge Technical Unit at Regional Police Office Abbottabad for the sole aim to extend assistance to Hazara Police in detection of high profile criminul cases ...4d also to toe die-hard criminals. He misused the official system and betrayingly started illicit and unlawful business of selling CDRs to vested interests in lieu of heavy bargaining. The standing precedence according is quoted as under:-

- 01. Reportedly one CDR which was provided to irrelevant person who mis-used it, came into the notice of Worthy Regional Police Officer, Hazara Region, PSO was directed to probe into the matter as to whether who and how the CDR was procured.
- 02. During initial enquiry he denied the spirit of allegations and took plea that due to gazette holiday on 25<sup>th</sup> December 2021 he did not attended office on that day. Subsequently, during discreet probe it was proved that he remained present in his office on 25<sup>th</sup> December, 2021 for 03 hours. He also pretended that once your email ID was hacked few years ago which he changed.
- 03. On 2<sup>nd</sup> February 2022 he were called by PSO to RPO where he verbally confe sed that he requested for the provision of CDR and sold out the same to one of his contact person. He absented himself from 3<sup>rd</sup> February 2022 till date.
- 04. On 04 Feb, 2022 at about 18:15 hours he went to the house of enquiry officer and offered him an illegal gratification/bribe of Rs.50,000/-.

All this shows his ill-will in the performance of official duties. His this ignoble act is a sever violation, a professional dishonesty, malafide intention and gross misconduct in term of Police E&D Rules-1975, hence this charge sheet.

## PROCEEDINGS:

During course of enquiry, delinquent official was summoned, his statement was recorded and cross examined. Details of his previous service record was also obtained. Moreover, other relevant statements related to the allegations leveled has been recorded.

All the necessary proceeding papers are enclosed with the enquiry file.

## FINDINGS:

So far as the allegation of providing illegal CDR to an irrelevant person who misused it is concerned, in this regard the delinquent official has confessed that he has issued the CDR, but he did not know that for what purpose the said person was obtaining it. For enquiring the matter the Regional Police Officer Hazara Region Abbottabad has initiated preliminary enquiry and Mr. Khabeer Khan PSO to RPO Hazara was appointed as enquiry officer to dig out the real facts. Who in his enquiry report

, the delinquent official guilty and recommended him for proper departmental enquiry. Upon in enquiry committee was constituted upon the order of DPO Abbottabad vide his office order No. 376-78/GB, dated: 16-02-2022.

- 1. During the course of enquiry the enquiry committee has approached the/ Technical branch of Region office Abbottabad vide this office letters No. 690/PA & 691/PA, dated: 23-02-2022 respectively. Who in response informed that thousands of CDRs are being issued from this office, so it is impossible for them to provide the desired information without providing the specific numbers / record. However, the delinquent official is verbally confessing that he has issued the relevant CDR to his colleague police friend in Jehlum.
- 2. Although for protecting himself he tried to use tactics of holiday, but when he feels that in the presence of CCTV footage and other evidence it is impossible for him to defend himself he confessed that on the day of occurrence he attended the office as well as has obtained the CDR.
- 3. As for as the allegation of illegal gratification / bribe of Rs. 50 thousands is concerned, he admits that due to his personal relations with the PSO he has visited his house but on his return he omit an amount of Rs: 50000/- at his house. But prima-facie it is not possible to do so without any purpose.

Keeping in view of above facts & circumstances the act of the delinquent official is against the norms of law, Undisciplined and accountable. Similarly, the enquiry committee has also obtained the written statement of Mr. Khabeer Khan PSO to RPO Hazara, who has conducted the preliminary enquiry against the defaulter constable. During the course of enquiry ample opportunity was granted to the delinquent official for cross questioning upon the enquiry officer of his preliminary enquiry, but he denied to do so. He confessed his guilt as a mistake / repentance. From the perusal of enquiry it has been proved that despite of a secure custodian of very sensitive office he badly demolished the decorum of police department as well as played an act of dishonesty and defames the senior most office of the Region. Therefore, he is recommended for Major punishment, so that the other officers / officials of the department will be greatly influenced and in future no one can dare to do such dishonesty, mismanagement and trust. It is also recommended that a responsible senior Police official may please be appointed as Incharge Technical wing to avoid such practice in future.

- d) On 04 Feb, 2022 at about 18:15 hours you went to the house of Enquiry Officer and offered him an illegal gratification/ bribe of Rs. 50,000/-.
- All this shows your ill-will in the performance of official duties. Your this ignoble act is a sever violation, a professional dishonesty, malafide intention and gross misconduct in term of police E&D Rules-1975.

This office order will dispose of the departmental enquiry against onstable Hafeez No. 113 the then Technical Branch RPO Office. The foul and avaricious play which he deceitfully did had come into the notice of Senior Officer as well as undersigned that he while posted as Incharge Technical Unit at Regional Police Office Abbottabad for the sole aim to extend assistance to Hazara Police in detection of high profile criminal cases and also to toe die-hard criminals. He misused the official system and betrayingly started illicit and unlawful business of selling CDRs to vested interests in lieu of heavy bargaining. The standing precedence accordingly is quoted as under:-.

- a) Reportedly one CDR which was provided to irrelevant person who mis-used it, came into the notice of Worthy Regional Police Officer Hazara Region, PSO was directed to probe into the matter as to whether who and how the CDR was procured.
- b) During initial enquiry he denied the spirit of allegations and took plea that due to gazetted holiday on 25th December 2021 he did not attended office on that day. Subsequently, during discreet probe it was proved that he remained present in his office on 25th December, 2021 for 03 hours. He also pretended that once his email ID was hacked few years ago which he changed.
- c) On 2nd February 2022 he was called by PSO to RPO where he verbally confessed that he requested for the provision of CDR and sold out the same to one of his contact person. He absented himself from 3rd February 2022 till date.
- d) On 04 Feb, 2022 at about 18:15 hours he went to the house of Enquiry Officer and offered him an illegal gratification/ bribe of Rs. 50,000/-.

All this shows his ill-will in the performance of official duties. His this ignoble act is a sever violation, a professional dishonesty, malafide intention and gross misconduct in term of police E&D Rules-1975.

He was issued with Charge Sheet along with statement of allegations. Enquiry Committee comprising of Addl: SP Abbottabad and SP, Investigation Abbottabad was appointed. The committee conducted proper departmental enquiry against the delinquent official and recorded statements of all concerned. After conducting proper departmental enquiry, the Enquiry Committee submitted its findings wherein allegations have been proved against delinquent official. He was issued Final Show Cause. He was summoned to appear in Orderly Room on 06-04-2022. He was given a patient hearing but he had nothing plausible to state in his defence.

Therefore, in exercise of the powers vested in the undersigned Police Disciplinary Rules-1975 (Amended 2014), I, Zahoor Babar Afridi, PSP, District Police Officer, Abbottabad as a competent authority, am constrained to award him the major punishment of **Dismissal from service** with immediate effect.



## **ORDER**

Alextan

This order will dispose of departmental appeal under Rule 11-A of Khyber Pakhtunkhwa Police Rules, 1975 submitted by Ex. Constable Hafeez ur Rehman No.113 of District Abbottabad against the order of punishment i.e. *dismissal from service* awarded by DPO Abbottabad vide OB No.79 dated 07.04.2022.

Brief facts leading to the punishment are that the appellant while posted as Incharge Technical Unit at Regional Police Office, Abbottabad deceitfully misused the official CDR system and started illicit and unlawful business of selling CDRs for vested interests.

The appellant was issued charge sheet along with summary of allegations and a committee comprising Add. SP and SP Investigation Abbottabad was constituted to conduct departmental enquiry. The committee in its findings held the appellant responsible of misconduct and recommended him for major punishment for his dishonest act. Consequently, DPO Abbottabad awarded him major punishment of dismissal from service. Hence, the appellant submitted this present appeal.

After receiving his appeal, comments of DPO Abbottabad were sought and examined/perused. The undersigned called the appellant in OR and heard him in person. The examined/perused. The undersigned called the appellant in OR and heard him in person. The failed to advance any justification and pleaded elemency. The undersigned again provided him opportunity to defend himself against the allegations, provisionally reinstated him in service for purpose of *denovo* enquiry and directed SP Investigation, Manshera to carry out the enquiry proceedings. However, the appellant neither appeared before the enquiry officer nor produced any evidence in his defense. The enquiry officer in his findings held the appellant responsible of gross misconduct. He was called in orderly room on 14-09-2022, however he failed to appear in person (DD Report No. 20 dated 13-09-2022 is part of record)

Foregoing in view the disciplinary action taken against the appellant seems reasonable and the appeal is liable to be dismissed. Hence, in exercise of the powers conferred upon the null function of Khyber Pakhtunkhwa Police Rules, 1975 the instant appeal is hereby *filed/rejected* while order of dismissal from service of DPO Abbottabad is upheld with

immediate effect. (nr.)
