REPLY ON BEHALF OF ANSWERING
RESPONDENTS NO. 4, 5 & 6 TO THE APPEAL
FILED BY THE APPELLANT.

Respectfully Sheweth:

Preliminary Objection:

- i. That the Appellant is not entitled to the relief claimed for in the appeal in hand, because the appellant was Ex-FATA / Federal Government Employee and the Replying Respondents 4, 5 & 6 were on District Cadre.
- ii. That the Appeal is not maintainable against the Answering Respondents 4, 5 & 6, because the Respondents evaluated/ promoted by the Respondents Department in a transparent lawful manner.
- iii. That the appellant joined the parental department on absorption being employee of Ex-FATA while the Replying Respondents No. 4, 5 & 6 are serving in parental department since their appointment.

- iv. **That** the appellant has got no locus standi and cause of action to file the instant appeal.
- v. **That** the Appellant has willfully concealed the actual facts from this Hon'ble Tribunal and filed the instant appeal just to indulge into the matter of Replying Respondents 4, 5 & 6 in unnecessary litigation.
- vi. **That** the appellant neither objected nor filed any objection petition within the prescribed law and manner.
- vii. **That** the appellant is estopped by his own conduct to file the instant appeal.
- viii. **That** the Replying Respondents 4, 5 & 6 serving on BPS-17 as Superintendents and have rightly been promoted by the competent authority after due process of law and rules of policy. (Copy of the Promotion Order (BPS-17) is **Ann-A**).
- ix. **That** the appellant has been inducted as the Junior Clerk in the Ex-FATA/Federal Government Employee Cadre till merger 2017.
- x. **That** the Appeal is badly time barred and liable to be dismissed with special cost under Order VII Rule 11 of CPC.
- xi. **That** the appellant is not an aggrieved person within the meaning of Article 212 of the Constitution 1973.

REPLY TO FACTS:

1. **Para-1** of the appeal is related to the Respondents No. 1, 2 & 3.

2. **Para-2** of the appeal is correct to the extent of promotion of the appellant by the Respondents /Department.
3. **Para-3** of the appeal is correct to the extent of promotion of Respondents 4, 5 & 6, because the appellant cadre is Ex-FATA/ Federal Government Employee while the Replying Respondents 4, 5 & 6 are being in their parental department of District Cadre Employees and have rightly been promoted by the competent authority in lawful manner as per their due rights.
4. **Para-4** of the appeal is incorrect as narrated, hence denied. Being Employee of the Parental District Department, The District Coordination Officer (DCO), Hangu being the competent authority on the recommendations of the District Nazim promoted the Replying Respondents 4, 5 & 6 under the Business Rules 2001, but the appellant was serving in Ex-FATA being Employee of the Federal Government has been abortion. (Copies of Promotion Orders from Junior Clerk to Senior Clerk are **Ann-B, C & C/1**).
5. **Para-5** of the Appeal is correct to the extent of submission of Departmental Appeal to the Respondent No. 1 on dated 11.10.2021.
6. **Para-6** of the Appeal is incorrect as narrated, hence denied. In reply it is submitted, that being Employee of the Federal Government neither agitated nor objected on

the notification of promotion of the Replying Respondents dated 27.09.2005, 10.12.2019 and after merger on the tentative seniority list dated 31.05.2021 that even a notification has also been issued in this regard by the Department to file objection on the above seniority list with a period of one month but now the appellant for consummation / covering of the lapsed time took shelter of a letter dated 11.01.2022 to cover the lacuna of time barred, which has not been filed on the name of the appellant. (Copies of the Notification dated 08.08.2019 and promotion Orders dated 10.12.2019 are **Ann-D & E**).

7. **Para-7** of the appeal is incorrect, hence denied. The appellant did not come under the parameters of an aggrieved person.

REPLY TO GROUNDS:-

A. **Ground-A** of the appeal is incorrect, misleading, hence denied. It is respectfully submitted that the Respondents 4, 5 & 6 have been promoted after adopted a proper procedure by the Departmental Promotion Committee and now the Replying Respondents 4, 5 & 6 are serving in BPS-17 as a Superintendents and as such no vested right of the appellant has been infringed.

B. **Ground-B** of the appeal is incorrect, hence denied. The appellant is estopped/precluded by his own conduct to file the instant appeal, hence the equity precludes and

creates bar on such relief thereto: in certain circumstances.

- C. **Ground-C** of the appeal is wrong and incorrect, hence denied. In reply it is submitted, that no malafide could be found on the part of the department and the appeal is frivolous, vexatious and time barred.
- D. **Ground-D** of the appeal is incorrect, hence denied. The appellant has come to the court with swilled hands and dragged the Replying Respondents 4, 5 & 6 into unnecessary litigation unnecessary litigation without their failure or any fault on their part.
- E. **Ground-E** of the appeal is incorrect, misleading, hence denied. The appeal suffers from gross concealment and misstatement of facts and is impudent in law and facts and untenable in its present form.
- F. **Ground-F** of the appeal is incorrect, hence denied. In the year 2001/2005 being parental District Cadre Employee rightly been promoted in accordance with law by the competent authority (DCO), while the appellant was serving as a Federal Employee in Ex-FATA. The appellant has been absorbed, therefore, neither been entitled for any relief nor any discrimination or violation has been committed by the competent authority by following the law, rules and policy. (Copies of SOR-V dated 30th July 2003 & SOR-I dated 16 February 2004 are **Ann-F & G**).

G. In reply to Ground-G it is respectfully submitted that the Replying Respondents 4, 5 & 6 also seeking permission to advance other additional grounds and proof at the time of arguments.

It is , therefore, most humbly prayed that on the above submission the appeal of the appellant may kindly be dismissed with cost.


