Respondents submit as under: -

PRELIMINARY OBJECTIONS: -

- 1. That the instant Service Appeal is not maintainable in the present form.
- 2. That the appellant is estopped by his own conduct to file the instant appeal.
- 3. That the appellant has not come to the Hon'ble Tribunal with clean hands.
- 4. That the appellant has suppressed material facts from the Hon'ble Tribunal.
- 5. That the instant Service Appeal is not maintainable for non-joinder/ miss-joinder of unnecessary parties.
- 6. That the appeal is badly barred by law & limitation, hence liable to be dismissed without any further proceeding.

ON FACTS:-

- 1. That the appellant while posted in ACE involved himself in murder case vide FIR No. 708 dated 17.07.2021 u/s 302 PPC Police station Havelian. Initially, the murder case was registered against unknown accused and after 1-1/2 months' complainant charged the appellant alongwith other co-accused for the commission of murder of his son through statement recorded u/s 164 Cr.P.C. He was properly arrested and thereafter, granted bail by the court of ASJ- Havelian for not being directly charged.
- 2. That the appellant after involvement in criminal case repatriated to his parent district Abbottabad where he absented himself from duty without any leave or permission.
- 3. That the appellant was charged by the complainant for the commission of murder of his son. The trial of the case has been commenced. However, he was not declared innocent during the course of investigation.



- 4. The appellant was proceeded against departmentally for involvement in murder case due to which he was dismissed from service. He preferred departmental appeal which was also rejected by the appellate authority.
- 5. Correct.
- 6. The appellant was in knowledge of all the proceedings which he deliberately avoided and did not applied for any order.
- 7. That appellant was properly charge sheeted and all the proceedings were conducted according to law. Despite service, he failed to join the proceedings due to which exparte proceedings were initiated. (Copies of enquiry file enclosed as Annexure "A").
- 8. Correct. The order of appellate authority was according to law. The instant appeal is not maintainable on the following grounds:-

GROUNDS:-

- A. Incorrect, the impugned orders are legal and according to law. Hence, tenable in the eye of law.
- B. Incorrect. A proper enquiry was conducted but appellant deliberately failed to join the proceedings. However, he was presently heard by the appellate authority while deciding his departmental appeal.
- C. Incorrect. He was treated according to law.
- D. Incorrect. The appellate authority acted according to law while deciding departmental appeal.
- E. Correct to the extent of period of service. However, his punishment record is as follow: -

His this illegal act earned bad name for entire police department as well as in eyes of general public which is tantamount to gross misconduct on his part being of member of discipline force.

PROCEEDINGS OF ENQUIRY.

For the purpose of scrutinizing your conduct with reference to the above allegation undersigned appointed as Enquiry officer and called the delinquent official as well as Oll Muhammad Hayat IO of the case FIR No. 708 dated 17-07-2021 U/S 302 PPC PS Havelian summon him also peruse the case file and recorded his statement in which he stated that on 17-07-2021 complainant Safdar Zaman s/o Mir Afzal r/o Gujjal reported as-PS Havelian for the murder his son Tahir Mehmood by unknown accused on the report of complainant the above case was registered and he carried out further investigation in the case arrested many suspect but was no success on 05-09-2021 complainant recorded his statement undersection 164 Crpc in the court of civil judge Havelian in which he charged Saqib s/o Pervaiz Constable Muhammad Irfan s/o Muhammad Zaman for the offence accused Saqib was arrested and interrogated during interrogation he admitted his crime and stated that he killed Tahir Mehmood s/o Safdar Zaman with the corporation/coordination of Muhammad Irfan (Constable) who arrange his pre arrest bail by the court of Session Judge Abbottabad on 09-09-2021 in which date of hearing is fix for 27-09-2021 but he did not appear before the court on due date and decamped him some where many raid for his arrest were conducted but in vain after completion of all the legal formality challan under section 512 Crpc was sent to the court against him on 23-10-2021. His statement is enclosed.

Your this illegal act earned bad name for entire police department as well as in the eye of general public, which is tantamount to gross misconduct on your part being a member of discipline force.

He was issued Charge Sheet along with statement of allegations and Mr. Sajjad Khan SDPO Havelian was appointed as Enquiry Officer but he did not bother to submit his written reply in response to charge sheet Enquiry Officer called him to join in Enquiry proceedings but he failed to appear in Enquiry proceeding. He conducted departmental enquiry against the delinquent official and recorded statements of all concerned. After conducting departmental enquiry, the Enquiry Officer submitted his findings, wherein allegations have been proved against him by taking Ex party action against him. Consequently, he was served with Final Show Cause Notice, in response to which he did not submit his written explanation. He was summoned to appear in Orderly Room on 26-01-2022 but he again failed to appear in OR.

Therefore, in exercise of the powers vested in the undersigned Police Disciplinary Rules-1975 (Amended 2014), I, Zahoor Babar, Afridi (PSP) District Police Officer, Abbottabad as a competent authority, am constrained to award him major punishment of Dismissal from service. with immediate effect.
