PRELIMINARY OBJECTION:-

RESPECTFULLY SHEWETH:-

- a) The appeal is not based on facts and appellant has got no cause of action or locus standi.
- b) That appeal is not maintainable in the present form.
- c) The appeal is bad for non-joinder of necessary and mis-joinder unnecessary parties.
- d) The appellant is estopped by his own conduct to file the appeal.
- e) The appeal is barred by the law and limitation.
- f) The appellant has not come to the Honorable Tribunal with clean hands.
- g) The appellant is still living abroad (England). Hence his appeal is not maintainable as he is not interest in the job which he deliberately left.

FACTS:-

- 1) Pertains to record.
- 2) Incorrect. The appellant was proceeded against departmentally with the allegation that vide DD No. 23 dated 27.05.2015 Police Lines it has been reported that he was granted following Ex. Pakistan Leaves.
 - 1st grant of Ex-Pakistan leave = 1 Year
 - 2nd grant of Ex-Pakistan leave = 2 years

His leave was expired on 27.05.2015 but he did not make his arrival and deliberately absented himself from duty. (Copy of DD No. 23 dated 27.05.2015 police Lines Mansehra is attached as annexure A).

- 3) Pertains to record.
- 4) Incorrect. No application was received by the appellant for extension of two years leave. The appellant was properly charge sheeted and enquiry was entrusted to DSP Headquarters. During the enquiry proceedings the appellant did not reply to the charge sheet nor did appear before the enquiry officer. Therefore, ex Parte proceedings were initiated against the appellant. Final Show Cause Notice was issued to appellant but he failed to reply the same and competent authority awarded him major punishment of dismissal from service Vide OB No. 62 dated 12.04.2016. (Copy of charge sheet, enquiry finding report & dismissal order are attached as annexure B, C & D).
- 5) The appeal was badly time barred due to which rejected by the respondent No. 02 vide memo No. 824/PA dated 15.09.2022 (Copy of rejection order is attached as annexure E).
- 6) Pertains to record.
- 7) The appellant has been living in England since long and wanted to get financial benefits which he is not entitled under any law.

GROUNDS:-

- **A.** Incorrect. All proceedings against him were conducted in accordance with law and he was dismissed after due process of law.
- **B.** Incorrect. The appellant was properly charge sheeted and statement of allegation was issued to appellant. Copy of charge sheet is already attached in above Para.
- C. Incorrect. Final Show Cause Notice was issued to appellant but he did not reply. Copy of Final Show Cause Notice is already attached in above Para.
- **D.** Incorrect. A proper departmental enquiry was conducted against the appellant but he did not join the enquiry proceedings. Therefore, enquiry proceedings was conducted expartee.
- **E.** Incorrect. The punishment awarded to appellant is genuine and inacordance with law and rules.
- **F.** Incorrect. No application has been received to competent authority for extension of two years leave.

G. Incorrect. The order was legal and according to law. Before passing any order, all the legal formalities were fulfilled. The appeal is not maintainable.

PRAYER:

In view of the above mentioned facts, the appeal in hand may kindly be dismissed being devoid of any legal force and badly time barred case.




