APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER DATED 08.05.2023 WHEREBY THE ORDER DATED 15.04.2023 HAS BEEN WITHDRAWN IN UTTER VIOLATION OF TRANSFER POSTING POLICY AND AGAINST THE APPELLAT ORDER DATED 03.07.2023 WHEREBY THE DEPARTMENTAL APPEAL OF APPELLANT HAS BEEN REJECTED WITH OUT ANY RESON.

PRAYER:

That on acceptance of this appeal the impugned withdrawn order dated 08.05.2023 and appellate order dated 03.07.2023 may very kindly be set aside and the respondents may kindly be directed to retain the appellant at GGPS Shahoor Bala till completion of his normal tenure. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

Brief facts giving rise to the present writ petition are as under:

- 1- That appellant is the law abiding citizen of Pakistan and was initially appointed as Adhoc PST vide order dated 10-09-2022 in GGPS Shawoor Bala. Copies of the CNIC and appointment order are attached as annexure **A&B.**

- 2- That in pursuance to the mentioned order the appellant was posted as PST (BPS-12), and assumed the charge. Copy of the arrival report is attached as annexure**C.**
- 3- That astonishingly vide corrigendum dated 17.10.2022, the appellant was transferred from the GGPS Shahwoor Bala to GGPS Sundrai. Copy of the Corrigendum is attached as annexure**D.**
- 4- That it is pertinent to mention here that vide notification dated 14.12.2022 the appellant was regularized in GGPS Sundrai. Copy of the notification dated 14.12.2022 is attached as annexure**E.**
- 5- That vide order dated 15.04.2023 the appellant was restored/adjusted again in her previous station i.e. GGPS Shahoor Bala in her own pay and scale and on 15.04.2023 the appellant assumed the charge at GGPS shawoor bala. Copy of the office order dated 15.04.2023 and charge report are attached as annexure **F&G.**
- 6- That surprisingly once again vide impugned order dated 08.05.2023, the order dated 15.04.2023 was withdrawn and the appellant was transferred from the GGPS Shahnoor to GGPS Sundrai. Copy of the office order dated 08.05.2023 is attached as annexure**H.**
- 7- That appellant feeling aggrieved from the frequent transfer orders and from the impugned order dated 08-05-2023 preferred departmental appeal on 17-05-2023 before the appellate authority. Copy of the Departmental appeal is attached as annexure**I.**
- 8- That by not deciding the departmental appeal the appellant approached Peshawar High Court in writ petition No. 371-M/2023 and during the pendency the appellate order dated 03.07.2023 was issued whereby the departmental appeal of the appellant was regretted with no good reasons. Copy of the appellate order dated 03.07.2023 is attached as annexure**J.**
- 9- That the appellant having no other remedy but to file the instant appeal on the following grounds amongst the others.


GROUND:

- A-** That the impugned order dated 08-05-2023 and appellate order dated 03.07.2023 are against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be set aside.
- B-** That the appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.

- C-** That the impugned order dated 08-05-2023 and appellate order dated 03.07.2023, have been issued by the respondent No.3 in arbitrary and mala fide manner, hence not tenable and liable to be set aside.
- D-** That the impugned order dated 08-05-2023 and appellate order dated 03.07.2023 is based on discrimination, favoritism and nepotism, hence not tenable in the eye of law.
- E-** That the impugned order dated 08-05-2023 and appellate order dated 03.07.2023 have neither been in the best interest of public service nor in exigencies of service, hence not tenable and liable to be set aside.
- F-** That the impugned order dated 08-05-2023, is violative of Clause-I, IV and XIII of the transfer/posting policy of the Government of Khyber Pakhtunkhwa. Copy of the transfer/posting policy is attached as annexure **K.**
- G-** That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of appellant may be accepted as prayed for.

Their services shall be governed by the Khyber Pakhtunkhwa Civil Servant Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructor and Doctors) Regularity Act, 2011, and such rules and regulation as may be issued from time to time by Government.
2. Their services will be considered regular and they shall be eligible for pension/deduction of GP Fund in term of Khyber Pakhtunkhwa Civil Servant Act, 1973, as amended in 2013, however, the teachers appointed on or after 07/06/2022 shall be dealt with Section (2)(2) of the Khyber Pakhtunkhwa (Amendment) Act, 2022

3. Their services are liable to termination on one month notice from either side. In case of resignation without notice, their one month pay/allowances shall be forfeited to the Government.
4. They shall possess the same qualification and experience required for the subject post on regular basis as specified in Section (3)(a) of the Act.
5. Their regularization shall not affect the service promotion quota of all service cadres as specified in Section (3) (c) of the Act.
6. They shall be entitled for seniority and pay from the date of initial appointment on Adhoc/Contract basis as specified in Section (3) (d) of the Act.
7. They shall perform duty for at least three years from the date of taking over charge where they were appointed/posted initially.
8. The regularization shall not be in favor of those teachers who have not taken over charge, remained absent from duty and resigned from service.
9. The Teacher, Regularized through this notification, shall be confirmed after successful completion of In-service mandatory training as specified in their Service Rules notified vide notification No SO(PE)4-5/SSRC/Meeting/2012/Teaching Cadre/2017 dated 07/03/2018 within two consecutive attempts otherwise the appointment orders of the candidates failed to qualify induction program within two consecutive attempts shall be considered as withdrawn/cancelled from the date of declaration of result of the second attempt made in the induction program.
10. The Sub Divisional Education Officers Female are directed to Check/ Verify the documents/ extension of the regularized teachers once again with the criteria mentioned for regularization if teachers do not meet the criteria their order will consider ceased.





POSTING / TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT.

- i) All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- iv) The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
- v) { }
- vi) While making postings/transfer from settled areas to FATA and vice-versa, specific approval of Governor, NWFP needs to be obtained

While making postings/transfers of officers/officials up to BS-17, from settled areas to FATA and vice-versa approval of the Chief Secretary NWFP needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor NWFP shall be obtained.
- vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for atleast eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.
- vii) Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and DPOs/Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thaana) of his area/residence is situated.
- viii) No posting/transfers of the officer's/officials on detailment basis shall be made.
- ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.
- x) All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.

Para-1(v) regarding months of March and July for posting/transfer and authorities for relaxation of ban deleted vide letter No: SOR-VI (E&AD) 1-4/2008/Vol-VI, dated 3-6-2008. Consequently authorities competent under the NWFP Government Rules of Business, 1985, District Government Rules of Business 2001, Posting/Transfer Policy and other rules for the time being in force, allowed to make posting/transfer subject to observance of the policy and rules. Added vide Urdu circular letter No. SOR-VI(E&AD)1-4/2003, dated 21-09-2004.

xi) Officers/officials except DCOs and DPOs/SPs who are due to retire within one year may be posted on their option on posts in the Districts of their domicile and be allowed to serve there till the retirement

DCOs and DPOs who are due to retire in the near future may also be posted in the District of their domicile subject to the condition that such posting would be against non-administrative posts of equivalent scales;

xii) In terms of Rule-17(1) and (2) read with Schedule-III of the NWFP Government Rules of Business 1985, transfer of officers shown in column 1 of the following table shall be made by the authorities shown against each officer in column 2 thereof.

1.	Officers of the all Pakistan Unified Group i.e. DMG, PSP including Provincial Police Officers in BPS-18 and above.	Chief Secretary in consultation with Establishment Department and Department concerned with the approval of the Chief Minister.

xiii) While considering posting/transfer proposals all the concerned authorities shall keep in mind the following:

a) To ensure the posting of proper persons on proper posts, the Performance Evaluation Report/annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned officers/officials be considered.

b) Tenure on present post shall also be taken into consideration and the posting/transfers shall be in the best public interest.

- xiv) Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.
- Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.
 - Serious and grave personal (humanitarian) grounds.

2. To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule - IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under:-

S. No.	Officers	Authority
1.	Posting of District Coordination Officer and Executive District Officer in a District.	Provincial Government.
2.	Posting of District Police Officer.	Provincial Government
3.	Other Officers in BPS-17 and above posted in the District.	Provincial Government
4.	Official in BPS-16 and below	Executive District Officer in consultation with District Coordination Officer.

3. As per Rule 25(2) of the Rules mentioned above the District Coordination Department shall consult the Government if it is proposed to:

- Transfer the holder of a tenure post before the completion of his tenure or extend the period of his tenure.
- Require an officer to hold charge of more than one post for a period exceeding two months.

4. I am further directed to request that the above noted policy may be strictly observed /implemented.

All concerned are requested to ensure that tenures of the concerned officers/officials are invariably mentioned in summaries submitted to the Competent Authorities for Posting/Transfer.

It has been decided by the Provincial Government that posting/transfer orders of all the officers up to BS-19 except Heads of Attached Departments irrespective of grades will be notified by the concerned Administrative Departments with prior approval of the Competent Authority obtained on the Summary. The Notifications/orders should be issued as per specimen given below for guidance.

All posting/transfer orders of BS-20 and above and Heads of Attached Departments (HAD) shall be issued by the Establishment Department and the Administrative Departments shall send approved Summaries to E&A Department for issuance of Notifications.
