



That the appellant joined the Education Department as PTC in the year 1987 in District Swabi and subsequently transferred to District Nowshera on 17.04.1998. It is also worth to mention here that at the time of first appointment of the appellant as PTC the requisite qualifications were matriculation with PTC. All the dates are recorded in the Departmental Appeal, the copy of which is already as Annexure-D.

That in the year 2012, promotion channel were provided for primary school teachers from BPS-12 to BPS-15. According to the Notification primary school teachers in BPS-12 are to be promoted to BPS-14 as SPST by promotion on the basis of seniority cum fitness amongst the PTC teachers with at-least 5 years service as such and similarly the post of primary school head teacher BPS-15 is to be filled in by promotion on the basis of seniority cum fitness from amongst the senior primary school teacher with at-least 10 years service and having qualification for primary school teacher. Copy of Notification is attached as Annexure-A.

That the appellant was promoted as senior primary school teacher (BPS-14) vide order dated 23.5.2015. In the said promotion order in Column-2, the seniority list number of appellant was recorded as 96 and was posted as senior primary school teacher in Government Girls Primary School (GGPS) Risalpur being senior most. Copy of Promotion Notification is attached as Annexure-B.

That on the same vary date many other teachers including junior colleagues of the appellant were promoted to BPS-15 as primary school head teacher (PSHT) and ignored the appellant totally. Even at the seniority list No.96 some other teachers namely Shakeela Naz was shown which was the serial no in the seniority list of the appellant as mentioned in the promotion order of BPS-14. Copy of Order is attached as Annexure-C.

That the appellant forthwith filed Departmental Appeal to the Respondents No.1 and 2 and her case

was placed before the appellate committee. The appellate committee rejected the appeal of the appellant on 26.08.2015 for the reasons that the appellant was promoted on 23.5.2015 and she is on probation for one year. The decision of the appellate committee was communicated to the appellant on 15.09.2015 on her application, hence the presentappeal on the following grounds amongst the others. Copies of Appeal, Application and decision of the Appellate Committee are attached as Annexure-D, E, F and G.

## **GROUNDS:**

- A) That the order dated 26.08.2015 communicated to the appellant on 15.09.2015 are against the law, facts, norms of justice and material on record, therefore, liable to be set aside.
- B) That the appellant has been deprived from due right of promotion as Primary School Head Teacher on an arbitrary manner which is not permissible in the eyes of law.
- C) That there is no conditions of probation in the notification of 2012 wherein the primary school teachers are categorized into BPS-12, BPS-14 and BPS-15. Moreover, the appellant been has discriminated because the respondent No.3 issued the promotion order of BPS-14 of more than BOO: teachers on 28.02.2013 and the same teachers were promoted to BPS-15 as PSHT on 2.3.2013 (just alter 2 days), therefore, the stance taken in the rejection of appellate committee is not sustainable in the eyes of law and melanin with discrimination. Promotion Orders are attached as Annexure-H and I.
- D) That even from the date 23.5.2015 whereby the junior colleagues of the appellant were promoted to BPS-15 is evident because in the promotion order to BPS-14 it is clearly mentioned that the seniority to lower post of PTC will be remained intact whereas the junior colleagues from serial No.96 to 296 have been promoted to BPS-15 by ignoring the appellant and her seniority position are incorrect as 96 and

promotion order to BPS-14 (Annexure-B) as per that order the seniority of the appellant is to be remained intact.

E) That the appellant has not been treated to law and rules and her right of seniority as well as promotion are affected an arbitrary and flimsy manner.

#### Preliminary Objections

- 1. That the Appellant has no cause of action/locus standi to file the instant appeal.
- 2. That this honorable service tribunal has got no jurisdiction to entertain the present appeal.
- 3. That the present Appeal is bad for mis-joinder and non joinder of necessary parties.
- 4. That the instant appeal is badly time barred.
- 5. That the appellant has concealed material facts from this honorable service tribunal.
- 6. That the appellant is estopped by his own conduct, by deed and by law to file the instant appeal.
- 7. That the instant appeal is not maintainable in its present form.

#### Factual Objection

- 1 This Para is mostly Pertains to the appellant record. It is correct that at the time of appointment of appellant the requisite qualification was Matriculation with PTC but after issuance of notification dated 13/12/2012, the requisite qualification for the post of PST is now intermediate with PTC Certificate.
- 2 Correct.
- 3 In Correct. Before issuance of promotion notification dated 23/05/2015, others notifications were also issued through which Primary School Teachers BPS-12 were promoted to SPST BPS-14 and PSHT BPS-15 in year 2013. The appellant was superseded at that time as she was not eligible for promotion because she was simple Matriculate and was not covered under the policy/rules. Later on in the year 2015, the appellant promoted her qualification by passing FA examination and got eligibility and was promoted to SPST BPS-14 vide order dated 23/05/2015.

4 Incorrect. The teachers were promoted to PSHT BPS-15 form SPST BPS-14 according to the rules/policy. Since the appellant was superseded in the year 2013 and sum juniors Teacher to the appellant were promoted to SPST BPS-14, therefore, the Junior Teachers becomes Senior as to the appellant.

5 Pertains to the record. However the decision of the appellant committee was communicated to appellant in time.

A. incorrect. The order dated 26/08/2015 is according to the law, rule and policies.

Beincorrect. The appellant is not entitled for promotion to PSHT.

C. Incorrect. There are three categories of the PST and each category has its own seniority

- I. Primary School Teacher BPS-12
- II. Senior Primary School Teacher BPS-14
- III. Primary School Head Teacher BPS-15

The appellant is junior most in the seniority list of SPST BPS-14, therefore, her appeal was rejected.

- D. Incorrect. Since the appellant was superseded from promotion in the year 2013 as she was not eligible, therefore, the appellant lost her seniority.
- E. Incorrect. The appellant was treated according to law and rules. The appellant was promoted after soon she got eligibility.
- F. The Respondents also seek permission to advance other grounds and proofs at the time of hearing.







#### **Preliminary Objections:**

(1-7) All objections raised by the respondents are incorrect and baseless. Rather the respondents are estopped to raise any objection due to their own conduct.

#### FACTS:

- 1 Admitted correct. Hence no comments.
- 2 Admitted correct. Hence no comments.
- 3 It is correct that the appellant has passed Metric exam after the notification of 2012 and superseded in promotion in the year 2013 and did not claim the promotion of 2013, but she claimed that vide 23.5.2015 the appellant was promoted to SPST (BPS-14) and in the said promotion order the seniority list number of the appellant was recorded as 96 and was posted as Senior primary teacher in GGPS Risalpur being senior most, but on the same day many others including junior colleagues of the appellant were promoted to BPS-15 and ignored

they appellant totally. Even at the seniority list No.96 some other teachers namely Shakeela Naz was shown which was the serial no in the seniority list of the appellant ad mentioned in the promotion order of BPS-14.

4 Incorrect. While para of the appeal is correct.

First portion of para 5 of the appeal is admitted correct by the respondents as the service record of the appellant is in the custody of the concerned department while the rest of the para is incorrect as the appellate committee rejected the appeal of the appellant on 26.8.2015 but communicated to the appellant on 15.9.2015 on her application.

#### **GROUNDS:**

- A. Incorrect. The orders dated 26.8.2015 is not according to the law, rule and polices and liable to be set aside.
- B. Incorrect. The appellant is rightly entitled for promotion to the post of PSHT.
- C. Incorrect. While para C of the appeal is correct.
- D. Incorrect. While para D of the appeal is correct.
- E. Incorrect. The appellant was not treated according to law and rules and her right of seniority as well as promotion are affected an arbitrary and flimsy manner.
