

**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED NOTIFICATION DATED 05.04.2022 WHEREBY JUNIORS TO THE APPELLANT I.E. PRIVATE RESPONDENTS NO.5 TO 74 HAS BEEN PROMOTED TO THE POST OF INSTRUCTOR PHYSICAL EDUCATION (BPS-17) AND THE APPELLANT HAS BEEN IGNORED AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STIPULATED PERIOD OF NINETY DAYS.**

**PRAYER:**

**That on acceptance of this service appeal the impugned notification dated 05.04.2022 may very kindly be set aside to the extent of private respondents at Serial No. 5 to 74 and the respondents may further please be directed to consider the appellant for regular promotion to the post of Instructor Physical Education (BPS-17) with all back benefits including seniority. Any other remedy which this August Tribunal deems fit that may also be granted in favor of the appellant.**

**R/SHEWETH:**

**ON FACTS:**

***The appellant submits as under:***

- 1- That the appellant was initially appointed as PET (BPS-9) in the respondent department vide order dated 22.10.1989. Copy of the appointment order is attached as annexure .....**A.**
- 2- That the appellant is a highly qualified in her respective filed of Physical Education and had acquired Diploma/ certificates/ degree of P.E.T in the year 1991, JDPE as well as having/ obtained Master of Physical Education in the year 2018 from a recognized university as well as B. Education. Copies of the educational testimonials are attached as annexure .....**B.**
- 3- That it is pertinent to mention here that during the service the appellant was promoted to the post of Senior Physical Education Teacher (SPET) (BPS-16) vide notification dated 28.02.2013. Copy of the notification dated 28.02.2013 is attached as annexure .....**C.**
- 4- That it is important to mention here that vide notification dated 24.07.2014 the service structure/ rules of the appellant cadre along with other were notified whereby S. No. 1A was inserted by providing channel of promotion of SPET to the post of Director Physical Education and vide notification dated 26.04.2018 the DPE was replaced with Instructor Physical Education (BPS-17). Copies of the notification dated 24.07.2014 and 26.04.2018 are attached as annexure .....**D.**
- 5- That vide letter dated 23.07.2019 files of the appellant along with others were forwarded to the respondent No. 3 for promotion to the post of Instructor Physical Education (BPS-17). Copy of the letters are attached as annexure .....**E**
- 6- That it is pertinent to mention here that vide notification dated 20.10.2020 some of the colleagues of the appellant were promoted to the post of Instructor Physical education. Copy of the notification dated 20.10.2020 is attached as annexure .....**F.**

- 7- That according the seniority list of 2021 as stood on 02.09.2021 the appellant was at serial No. 140 and the private respondents are on serial No. 152, 169, 171 etc. Copy of the seniority list is attached as annexure .....**G.**
- 8- That as the appellant was quite hopeful for her promotion to the post of IPE (BPS-17) but astonishingly vide impugned notification dated 05.04.2022 juniors in term of their appointment to the appellant were promoted to the post of Instructor Physical Education (BPS-17) on regular basis and the appellant being eligible in all respect was ignored. Copy of the notification dated 05.04.2022 and 27.05.2022 are attached as annexure .....**H.**
- 9- That the appellant feeling aggrieved from the impugned notification and having no other remedy preferred a departmental appeal/ representation before the appellate authority but no response has been given within the stipulated period. Copy of the departmental appeal is attached as annexure .....**I.**
- 10- That feeling aggrieved from the inaction of the respondents and having no other remedy the appellant preferred the instant appeal on following grounds inter alia.

**GROUND:**

- A- That by issuing impugned notification dated 05.04.2022 whereby promoting juniors and against the impugned inaction of the official respondents by not promoting the appellant to BPS-17 as per the law and rules are against law, facts, norms of natural justice and material on record hence liable to be set aside/ modified.
  - B- That appellant has not been treated by the respondent department in accordance with law and rules on the subjected noted above and as such respondents violated the Article 4 and 25 of the Constitution of Islamic Republic of Pakistan.
  - C- That the appellant has been discriminated by the respondents while issuing the impugned notification dated 05.04.2022 ignoring the appellant irrespective of the fact that the appellant was senior as well as eligible for the subject promotion.
  - D- That by issuing the impugned notification dated 05.04.2022 and promoting the juniors to the appellant and ignoring the appellant are in violation of section-8 and section- 9 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 and Rule-7 and Rule-17 of the Khyber Pakhtunkhwa (APT) Rules, 1989.
  - E- That according to the Article 38(e) of the constitution of the Islamic Republic of Pakistan, 1973 the state is bound to reduce the disparity in the income of the individuals including the persons in the service of
-

Pakistan, hence keeping in view this command of the constitution the respondents are duty bound to eliminate the mentioned disparity.

F- That the respondents acted in arbitrary and mala fide manner while issuing the impugned seniority.

G- That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

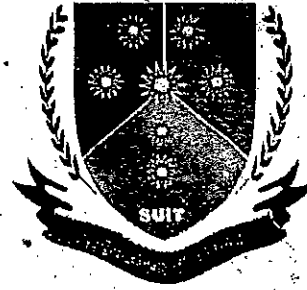



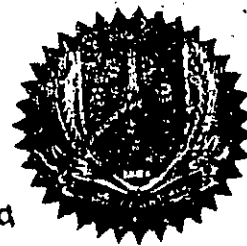

**Subject: DEPARTMENTAL APPEAL AGAINST THE IMPUGNED NOTIFICATION DATED 05.04.2022 WHEREBY JUNIOR TO THE APPELLANT HAS BEEN PROMOTED TO THE POST OF INSTRUCTOR PHYSICAL EDUCATION (BPS-17) AND IGNORING THE APPELLANT WITHOUT ANY GOOD REASON.**

Respected Sir,

- 1- That the appellant is a highly qualified in his respective field of Physical Education and had acquired Diploma/ certificates/ degree of P.E.T in the year 1991, JDPE as well as having/ obtained Master of Physical Education in the year 2018 from a recognized university as well as B. Education.
- 2- That it is pertinent to mention here that during the service the appellant was promoted to the post of Senior Physical Education Teacher (SPET) (BPS-16) vide notification dated 28.02.2013.
- 3- That vide notification dated 24.07.2014 the service structure/ rules of the appellant cadre along with other were notified whereby S. No. 1A was inserted by providing channel of promotion of SPET to the post of Director Physical Education and vide notification dated 26.04.2018 the DPE was replaced with Instructor Physical Education (BPS-17).
- 4- That vide letter dated 23.07.2019 files of the appellant along with others were forwarded for promotion to the post of Instructor Physical Education (BPS-17).
- 5- That vide notification dated 20.10.2020 some of the colleagues of the appellant were promoted to the post of Instructor Physical education.
- 6- That according the seniority list of 2021 as stood on 02.09.2021 the appellant was at serial No. 140 and his junior colleagues so promoted are on serial No. 152, 169, 171 etc.
- 7- That as the appellant was quite hopeful for his promotion to the post of IPE (BPS-17) but astonishingly vide impugned notification dated 05.04.2022 juniors in term of their appointment to the appellant were promoted to the post of Instructor Physical

Education (BPS-17) on regular basis and the appellant being eligible in all respects was ignored.

8- That the appellant feeling aggrieved and having no other remedy preferred this departmental appeal.


**GROUND:**

- A- That by issuing impugned notification dated 05.04.2022 whereby promoting juniors and against the impugned inaction of your good self by not promoting the appellant to BPS-17 as per the law and rules are against law, facts, norms of natural justice and material on record hence liable to be set aside/ modified.
- B- That appellant has not been treated by your esteemed department in accordance with law and rules on the subject noted above and as such violated the Articles 4 and 25 of the Constitution of Islamic Republic of Pakistan.
- C- That the appellant has been discriminated against while issuing the impugned notification dated 05.04.2022 ignoring the appellant, irrespective of the fact that the appellant was senior as well as eligible for the subject promotion.
- D- That by issuing the impugned notification dated 05.04.2022 and promoting the juniors to the appellant and ignoring the appellant are in violation of section-8 and section- 9 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 and Rule-7 and Rule-17 of the Khyber Pakhtunkhwa (APT) Rules, 1989.

It is therefore, most humbly prayed that on acceptance of this departmental appeal the appellant may be promoted to the post IPE (BPS-17) with all back benefits and the impugned notification dated 05.04.2022 to the extent juniors be modified by placing the appellant at his due place of seniority with all back benefits.
