The Respondents No. 1-4 submit as under:

PRELIMINARY OBJECTIONS.

- 1 That the appellant has got no cause of actions / locus standai.
- 2 That the appellant is not an aggrieved person within the meaning of Article 212 of the constitution of 1973.
- 3 That the appellant has concealed material facts from this Honorable Tribunal in the titled matter.
- 4 That the appellant is estopped by his own conduct to file the titled appeal against the Department
- 5 That the appellant is not entitled for the grant of promotion w.e.f 11.02.2019 against the Principal in BS-20 (TC) on proforma basis in the Department
- 6 That the Notification dated 13.06.2012 is legal and even is the result of the service record of the appellant in the Respondent Department.
- 7 That the instant appeal is badly time barred under the relevant law.
- 8 That as per Khyber Pakhtunkhwa Civil Servants Promotion Policy, 2009" read with the relevant provision of APT Rules 1989 that promotion will always be notified with immediate.
- 9 That the Appellant has not come to this Honorable Tribunal with clean hands.



- 10 That the Appeal is not maintainable in the present form being devoid of merits.
- 11 That the appeal in hand is bad for misjoinder & non-Joinder of the necessary parties.
- 12 That the appellant has been treated as per & relevant provision of law & Rules in vouge.

ON FACTS.

- 1. That Para-1 is correct, to the extent of the appellant appointed as SET now SST in BPS-15 in the year 1987 and later on, appointed promoted in BS-18 (TC) in the year 2002 as per his service record in the Department.
- 2. That Para-2 is correct, that as per final seniority list stood on 31-04-2007 regarding the officers of BS-18 (TC), the appellant has been placed & shown at S.No.71 by the Department which is subject to the production of cogent proof & justification lies upon the shoulder of the appellant in support of his plea regarding his seniority at S.No. 71 in the said seniority list attached as Annexure-A.
- 3. That Para-3 is correct, to the extent of the promotion of the appellant in BS-19 (TC) on acting charge basis in view of the recommendation of PSB vide Notification dated 13.03.2007, however, the appellant along with his batch mates were promoted in (BS-19) (TC) on regular basis vide Notification dated 13-06-2012 attached as *Annexure-B & C*.
- 4. That Para-4 is incorrect, on the grounds that the appellant has failed provide & produce attested/verified copy of his regular appointment/promotion order in (BS-19) (TC) to the Respondent Department which he did not produced, hence, his name & other particular were not included in the Tentative Seniority list of pertaining to the officer of BS-19 (TC) in the Respondent Department & has taken an illegal stand in terms of saction-6 (2) of Civil Servants Act 1973 read with Rules-15 (1) of KPK APT Rules 1989, hence, the plea of the appellant is liable to be rejected.
- 5. That Para-5 is correct, to the extent of Notifying the final seniority of BS-19 (TC), wherein, the name of the appellant was not included in view of the explanation made in para 4 of the present reply by the Department, where against, the appellant did not filed a Departmental appeal to the appellate authority, hence, got finality under the rules.
- 6. That Para-6 is correct that the appellant has invoked the constitutional jurisdiction under Article-212 read with Sancttion-4 of KPK STP Act

1974 in service appeal No.761/2018 case tiled Hasanat Gul Vs govt; of KPK & others with the prayer for the inclusion of his name of final seniority list dated 29-11-2017 pertaining to the officer of BS-19 (TC) in the Department which was allowed vide judgment dated 05-07-2021 with the direction to the Department for the award of promotion to the appellant w.e.f. 13-06-2012 with further direction that the Department shall be at liberty to proceed against the appellant in view of the Judgment dated 08-12-2016 of the Honorable High Court in W.P No. 7076/2012 subject to the outcome pending CPLA of the Department in the Supreme Court of Pakistan attached as Annexure-D, with further submission that Muhammad Riaz was promoted to the post of Principal in BS-20 (TC) on the grounds of senior to the appellant vie Notification dated 11-02-2019, whereas, his case was decided on 05-07-2021, with further that the appellant has not made Muhammad Riaz as a Respondent in his Service Appeal No.761/2018 before the Tribunal, copy of the Notification is *Annexure-E*, hence the plea f the appellant is liable to be rejected.

- 7. That Para-7 is correct, that vide Notification dated 24.03.2022 the appellant has got retired from service w.e.f 01.04.2022 against the BS-19 post from the Department, however, he has been promoted in (BS-19) (TC) notional basis w.e.f. 13-06-2012 vide Notification dated 22-07-2022 by the Department which are attached as *Annexure-F & G*
- 8. That Para 8 is incorrect on the grounds that the appellant is not entitled for the grant of promotion in BS-20 (T) w.e.f.11-02-2019 the date on which Muhammad Riaz others were promoted in the said scale, where against, no Departmental appeal has been filed by the appellant till date, hence, got final under the law.
- 9. That Para-9 is incorrect as the appellant is not an aggrieved person within the meaning of Article 212 of the constitution of 1973, hence liable to be dismissed on the following grounds inter alia.

ON GROUNDS.

- A. <u>Incorrect & not admitted</u>, the appellant has been treated as per law and rules by the Department in the titled case, wherein, he could not made out his case for promotion in BS-20 w.e.f. 11-02-2019 in the Respondent Department.
- B. Incorrect & not admitted. the reply to this ground his being given in ground-A of the present reply by the Respondents.
- C. Incorrect & not admitted. the plea of the appellant is illegal & liable to be rejected in view of the above made submission by the Department.

- D. <u>Incorrect & not admitted</u>, as he is not entitled to the post of BS-20 w.e.f 11.02.2019 under the rules in the Department.
- E. <u>Incorrect & not admitted</u>, the act of the Department with regard to non-grant of promotion to the appellant in BS-20 w.e.f. 11-02-2019 is legal & liable to be maintained.
- F. Incorrect & not admitted. as replied above by the Department.
- G. <u>Incorrect & not admitted</u>, the appellant has no valid case of action to file the titled appeal before this Leaned Tribunal. Therefore, the Respondents No. 1-4 also seek leave of this Honorable Tribunal to submit additional record grounds and case law on the date fixed.

AH-UD-DIN, MEMBER:-

Precise facts as alleged by the appellant in the instant service appeal are that he is serving in Education Department and vide Notification dated 13.03.2007, the Provincial Government in consultation with Provincial Selection Board, promoted the appellant alongwith his other colleagues from BPS-18 to BPS-19 on acting charge basis; that vide Notification dated 13.06.2012, certain officers, who were junior to the appellant were promoted on regular basis to BPS-19; that a tentative seniority list of officers of BPS-19 was initially issued by the respondents in the year 2017,



wherein the name of the appellant was missing; that despite raising the Issue before the competent Authority through application, the name of the appellant was not included in the final seniority list issued on 29.11.2017, however the seniority list was not circulated and the same came into the knowledge of the appellant in the month of February 2018, therefore, he filed the department appeal, however the same was not responded within the statutory period of ninety days, hence the instant service appeal.

- 2. Respondents submitted their comments, wherein they denied the averments of the appellant.
- 3. Learned counsel for the appellant has argued that the appellant was promoted to BPS-19 and in view of the prevalent rules, the service of the appellant in BPS-19 was required to be regularized in the year 2010 but it is an irony that the respondents have not even included the name of the appellant in the seniority list of officers of BPS-19, circulated in the year 2017; that the inaction/omission on part of the respondents is based on malafide, which has resulted in grave miscarriage of justice in the shape of deprivation of the appellant from his promotion; that the juniors of the appellant have been promoted on regular basis in BPS-19 in the year 2012, while the appellant has been still kept on probation without any plausible legal reasons. Reliance was placed on 2000 SCMR 645, 2008 PLC (C.S) 551, 2016 SCMR 1784, 2018 PLC (C.S) Note 66, 2017 PLC (C.S) 643, 2011 PLC (C.S) 1527, 2009 PLC (C.S) 178 and 1999 SCMR 880.
 - 4. Conversely, the learned Assistant Advocate General for the respondents has argued that the appellant was promoted on acting charge basis, which cannot create any right of seniority as well as regular promotion in favour of the appellant; that disciplinary action was taken against the appellant on the allegations of committing irregularities in the appointment of PSTs (Male), while serving as DEO (Male) Nowshera and in the de-novo inquiry, inquiry committee has recommended his removal from service; that the appellant filed Writ Petition in the august Peshawar High Court, Peshawar, which was allowed by declaring the de-novo inquiry as illegal, unlawful and of no legal effect, however the judgment of august Peshawar High Court has

been challenged through filing of CPLA in the august Supreme Court of Pakistan, which is still pending adjudication.

5. We have heard the arguments of learned counsel for the appellant as well as learned Assistant Advocate General for the respondents and have perused the record.

A perusal of record would show that the appellant alongwith his other colleagues were promoted from BPS-18 to BPS-19 on acting charge basis, vide Notification dated 13.03.2007, issued by Government of NWFP School and Literacy Department. Vide Notification dated 13.06.2012 certain officers juniors to the appellant were also promoted from BPS-18 to BPS-19 on regular basis, however the appellant was ignored. The copy of minutes of meetings of Provincial Selection Board held on 17.02.2012 and 17.01.2014 are available on record, which would show that the promotion of the appellant to BPS-19 on regular basis was deferred for the sole reason that an inquiry was pending against him. It appears from the record that while posted as District Education Officer Nowshera, disciplinary action was taken against the appellant as well as other officers/officials on the charge of irregularities in the appointments of Teachers in various categories as well as other charges and on the conclusion of the inquiry, the inquiry officer submitted his report alongwith recommendations to the competent Authority, however the competent Authority was not satisfied regarding the punishments proposed for imposition upon the appellant and other officers/officials, therefore, an inquiry committee comprising of two officers was constituted for de-novo inquiry into the matter. The same was challenged by the appellant alongwith others through filing of Writ Petition No. 1376-P/2014 before august Peshawar High Court, Peshawar, which was allowed vide judgment dated 08.12.2016 by declaring the de-novo inquiry as illegal, unlawful, without lawful Authority and of no legal effect. It was, however observed that the competent Authority may proceed on the basis of first inquiry.

The judgment dated 08.12.2016 passed by august Peshawar High Court, Peshawar, has been impugned by the respondents through filing CPLA before the august Supreme Court of Pakistan, however the appellant submitted an affidavit to the effect that neither the order dated 08.12.2016 passed by august Peshawar High Court, Peshawar,

has been suspended nor any status-quo order has been issued by the august Supreme Court of Pakistan. In this scenario, the inquiry against the appellant is still pending and according to the certificate issued by District Education Officer (Male) Nowshera, he is presently performing his duty as Principal BPS-19 in GCMHS Akora Khattak Nowshera. It is settled law that mere pendency of disciplinary proceedings against a civil servant, is no valid ground for not considering such civil servant for promotion. Reliance in this respect is placed on 2000 SCMR 645 and . 2007 PLC (C.S) 716. Mere pendency of inquiry proceedings against the appellant thus could not be considered to be a legal ground for deferring his promotion to BPS-19 on regular basis.

In view of the above discussion, the appeal in hand is allowed and the respondents are directed to issue the promotion order of the appellant to BPS-19 on regular basis with effect from 13.06.2012 and he shall be entitled to all back benefits. The promotion of the appellant shall, however not debar the Authority from continuing with the disciplinary proceedings against the appellant in light of the judgment dated 08.12.2016 passed by worthy Peshawar High Court, Peshawar, in Writ Petition No. 1376-P/2014, subject to outcome of the CPLA pending adjudication in the august Supreme Court of Pakistan. Parties are left to bear their own costs. File be consigned to the record room.
