



4. That it is pertinent to note that when on the first & last occasion, i.e., 11-10-2022, fresh notices were issued to the applicants for submission of comments/reply, no mention has been made in the respective order sheets whether the notices issued were infact received

been made in the respective order sheets whether the notices issued were infact received by the applicants or not. For fair assistance the applicants tracked the status of the notice/summons issued by this Worthy Tribunal through post office receipts bearing tracking no. RGL 105288803 & RGL 105288804 and which confirms the contention of the applicants that no notice/summons were ever received by them or any staff of KP Environmental Protection Tribunal.

- 5. That on 17-11-2022, 19-12-2022, 05-04-2023, 24-05-2023 and 07-06-2023 respective learned Additional Advocate Generals (AAGs) undertook before the Worthy Tribunal to contact the applicants for submission of reply/comments, however, there is no mention in the respective order sheets recorded by this Worthy Tribunal whether the respective AAG had made a contact with the applicants about the pendency of the said appeal as the order sheets are silent about any communication to the applicants.

(Copy of the attested order sheets is attached herewith as Annexure "B")

- 6. That from the order sheets recorded by this Tribunal in the subject appeal it is apparent that notices/summons were not received by the applicants. In essence, the service was incomplete and not according to the law.
- 7. That it is stated with great dismay and which is also beyond the comprehension of the applicants that despite the fact that the respective learned AAGs has undertaken, which is obvious from the order sheets recorded by this Worthy Tribunal, to contact the applicants, however, neither any copy of the appeal was provided or handed over to the applicants by the respective learned AAGs nor any date of hearing for attendance/submission of reply/comment was intimated to the applicants which is a serious lapse of their undertaking as well as breach of their official duty for reasons better known to them.
- 8. That the subject appeal pertains to a heinous crime committed within the premises of Tribunal/Tribunal and therefore for a fair and just conclusion of the subject appeal it is crucial that the ex-parte proceedings as well as the right for submission of reply/comments of the applicants/petitioners which has been struck off vide order dated 05-07-2023 recorded by this Worthy Tribunal is set aside and the position of the

9. That the applicants did not intentionally avoid their respective appearance/attendance as well as submission of reply/comments before this Worthy Tribunal and rather it is glaringly obvious in light of the order sheets recorded by this Worthy Tribunal that the problem lies somewhere else.
10. That Superior Tribunals have always held that matters should be decided on merits and not on technicalities.
11. That the applicants have been condemned unheard and if they are not able to appear and defend themselves through submission of reply/comments, it is submitted with respect that a grave injustice is likely to be committed.
12. That this application is well within time and it is in the light of the communication made by the AAG on 05-07-2023 that the applicants approached this Worthy Tribunal and obtained copy of the appeal/case record so as to submit the instant application and therefore there is no legal bar in hearing this application and deciding the same in favour of the applicants in view of the facts and record already available on judicial file and also annexed with this application.

**Prayer:**

It is, therefore, respectfully prayed that on acceptance of the instant application the ex-parte proceeding(s) may kindly be set aside and the applicants may kindly be allowed to defend their case and to file reply/para wise comments.
