

The Appellant humbly submits as under:-

1. That Appellant, born 03.03.1980, is a *bona fide* resident of the Province Khyber Pakhtunkhwa. Appellant is holding Diploma of Associate Engineer in Civil from the respective Khyber Pakhtunkhwa Board of Technical Education, Peshawar in the year 2002.

2. That Department of Public Health Engineering in Daily Aaj Peshawar on 22.04.2010 advertised post of <u>Sub Engineers (BPS-11)</u> on ad hoc basis for a period of one year or till the arrival of candidates recommended by the <u>Provincial Public Service Commission</u> whichever come first.

3. That Appellant in response to the aforesaid advertisement having the aforesaid qualification applied for the post. After going through all the due process, finally the Appellant on the recommendation of the Departmental Selection Committee *vide* letter No. 8/06/E-4/PHE dated 23.02.2011 was appointed as Sub Engineer "purely on contract basis in BPS-11" with the terms and conditions that "for all intents and purposes, be Civil Servant" to "be governed by the NWFP Civil Servant Act, 1973 and all the laws applicable to the Civil Servants and Rules made there under". Besides "He will also be entitled to annual increment as per existence policy" and most importantly the appointment letter provided that "He shall, initially, be on probation for the period of two years extendable up to three years".

4. That Appellant in pursuance of the aforesaid letter of appointment joined the service and performed his duties with all due care and diligence as and where he was posted. It is worth to mention that from the date of appointment till his impugned termination his performance was satisfactory in all respect as evident from the service book of the Appellant; the extract of which is annexed herewith.

- 5. That it is worth to mention that as per condition 5 of his appointment letter, his probation period of two years was expired on 23.02.2013. Having being satisfied his probation period was not extended and by operation of departmental practice, the Appellant has become a permanent Civil Servant with all intents of law and procedure.
- 6. That most importantly during the period one year as was stipulated in the advertisement; the candidate recommended by the commission were not arrived.
- 7. That <u>after having more than two and half years of service</u>, out of the blue *vide* Office Order No. 11/E-9/PHE dated 01.07.2013 while working under the Chief Engineer FATA was terminated by the Chief Engineer (South) on the ground that "Since Public Service Commission has furnished names of Selected persons for the post of Sub Engineers on the basis of requisition sent by Secretary PHE Department dated 10.02.2010, the Following contract Sub Engineers are hereby terminated with immediate effect". (Annexed as Annexure-I)
- 8. That against the impugned order, the Appellant on 03.07.2013 submitted departmental appeal to the Respondent-2 under section 22 of Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 3 of KP Civil Servant (Appeal Rules, 1976) against the impugned orders.

9. That it is worth to bring on record that through a common WP No. 2146-P/2013 on 24.06.2013, the Appellant challenged the order of Termination before the Honourable Peshawar High Court, Peshawar. In the said WP the Respondent filed Parawise comments and Appellant filed rejoinder, However, finally the honourable High Court *vide* order dated 11.09.2014 for reasons mention thereon refused to interfere.

10. That here it is worth to mention that against Order dated 26.02.2014 of the Honourable Peshawar High Court, Peshawar in W.P. No. 615/2014 filed by similarly placed terminated employee of the PHE preferred C.P. No. 551/2014 before the august Supreme Court of Pakistan. The Petition was heard by the Bench headed by the Honourable Chief Justice and it was disposed of as under:

"Tassaduq Hussain Jillani, CJ:- Petitioner are civil servants and they challenged the order terminating their service in a Constitution petition which stands dismissed vide the impugned order mainly on the ground that the said petition was not maintainable in view of Article 212 of the Constitution read with Section 4 of the Service Tribunal Act, 1973. The only ground being taken by the learned High Court to invoke Article 199 of the Constitution is that the competent authority in the department had passed the order of termination of petitioners' service pursuant to a judgment of this Court and the learned Service Tribunal may be diffident to decide the case independently and in accordance with law.

(5)

2. We are afraid, the apprehension of the petitioners is misconceived. In the event of filing the appeal, the Service Tribunal shall decide the appeal as mandate in law. Disposed of in terms noted above".

- 11. That as so far departmental appeal filed by the Appellant on 03.07.2013 and the competent authority has not proceeded with the appeal, hence, this Appeal.
- 12. That the Appellant, seeking protection u/s 5 and 14 of the Limitation Act, 1908 and other enabling laws and Rules prefers this Appeal against the impugned Order dated 01.07.2013, *inter alia*, on the following:

Grounds:

- I. That impugned order is erred both in law and facts.
- II. That the impugned Order of Termination of the Respondent-3 (Chief Engineer South) is *void ab initio* for being *coram non judice* as the Appellant at the time of termination was working under the administrative control of the Chief Engineer (FATA).



- III. That impugned *ex parte* order is not only against the principle of natural justice *audi alteram partem* but virtually the Appellant has been denied the right of fair trial as protected under Article 10A of the Constitution, 1973 as one of the fundamental rights of the citizens of the Pakistan. Hence, on this score alone the impugned order is liable to be set aside.
- IV. That the impugned order is hit by **Article 25** of the Constitution for being **treated discriminatory** as during the last 5 years or so about 250 appointments have been made in the department but no such action has been taken against them.
- V. That the appointment of Appellant was made by competent authority after due process of law on the recommendation of **Departmental Selection**Committee, the Appellant besides, within age limit, had the prescribe qualifications, thus, in such circumstances the Respondent-3 has no legal justification to treat the valid appointment of Appellant as illegal.
- VI. That WITHOUT PREJUDICE though post was advertised for ad hoc appointment, however, later on the terms of the advertisement were impliedly revised as Appellant on 23.02.2011 was appointed on "contract basis" and "for all intents and purposes, be Civil Servant"
- VII. That similarly term that "for period of one year or till arrival of the candidates recommended by the Provincial Public Service Commission which ever come first" had become *void* when the Respondent or Public Service Commission failed to recommend candidate within the precribed period of one year.

VIII. That it is pertinent to mention that by notification No. SO(O&N)E&AD/8-16/2000 dated 05.11.2001, the three departments namely Public Health Engineering, Physical Planning & Housing and Communication and Works Department were merged into Works and Services Department as mentioned in order dated 05.11.2001 and meanwhile the Khyber Pakhtunkhwa Local Government Ordinance, 2001 was also promulgated and under section 14 thereof the administrative and financial authority for management of the offices of the government specified in Part-A of the first schedule was decentralized to district government. Similarly the posts in BPS-01 to 15 in the Works and Services Department were also declared as district cadre posts and outside the scope and purview of Service Commission vide notification No. SO(Estt:)W&SI13-1177 dated 22.03.2005 as referred in letter dated 08.04.2006 by the Establishment Department to W & S Department.

IX. That when the posts in BPS 1 to 15 in W & S Department were declared District Cadre Posts including the posts of Appellants then a letter was written to Secretary Khyber Pakhtunkhwa Public Service Commission, Peshawar on 02.05.2007 therein requested for withdrawal the requisition for filling in the vacant posts of Sub Engineers (BPS-11) in the W &S Department and done accordingly. In such circumstances the plea of Respondent-3 regarding non fulfilling the requirements of recommendation of Public Service Commission, Khyber Pakhtunkhwa in the case of Appellant is



unjustified, unreasonable, *mala fide* and without lawful authority and not sustainable under the law and rules.

- X. That WITHOUT PREJUDICE there was no cause for termination as admitted before the Honourable Peshawar High Court, Peshawar, there was still post vacant at the time of termination and even aftermath too as evdent from the comments filed b the Respondent before the Honourable High Court.
- XI. That WITHOUT PREJUDICE in similar circumstances the Governments and the Superior Court regularized the services of contract / ad hoc employee in this respect attention is invited to the "Khyber Pakhtunkhwa Civil Servants (Amendment) Act, 2013", the Finance Division letter No. SOSR-III/FD/12-1/2005 dated 27.02.2013 and the FATA Secretariat Order No. FS/100-35(Vol-9)/1066-78 dated 17.01.2014 where may such employees have been regularized.

XII. That the Appellant has not been treated in accordance with law and the impugned order has been passed in violation of fundamental rights as guaranteed under chapter 1 of part II of the Constitution, 1973.



- XIII. That in view of clause 5 of the appointment order of the Appellant, his appointment was on probation for a period of two years extendable up to three years which the completed satisfactorily has Appellant becoming confirmed employee of the Respondent Department. At the time of passing of impugned order, the Appellant has rendered more than two and half years service to the department efficiently, satisfactorily and without any complaint. Therefore the Respondent-3 has not acted in accordance with law and rules and unlawfully passed the impugned order without observing codal formalities as required in the case of a confirmed employee. Therefore the impugned order thereby Appellant was terminated have no legal sanctity being without lawful authority.
- XIV. That clause 2 of appointment order of Appellant provided that he will be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and all the laws applicable to the Civil Servants and Rules made there under and similarly in the impugned show cause notice mentioned that action would be taken under the Efficiency and Disciplinary Rules, 2011 but the Respondent-3 has not followed any law in passing the impugned order which is arbitrary, unjust and unfair and not warranted, liable to be set aside.
- XV. That in the impugned order, Respondent-3 used the word of "termination" which neither applicable in the case of Appellant being confirmed employee of the department nor prescribed in the E&D Rules, 2011 therefore the impugned order is ambiguous, vague and illegal not Sustainable under the law and rules.

- XVI. That the impugned order has been passed at the back of Appellant. Neither any regular enquiry has been conducted nor was a fair opportunity provided to him to defend his case, therefore, the impugned order is illegal, without lawful authority being violative of principle of natural justice.
- XVII. That the Appellant was continuously serving the department having more than two and half years service at his credit without any complaint which accrued vested rights in his favour which could not be taken away or withdrawn by the authority under the principle of *locus poenitentiae*.
- XVIII. That in case of any defect in the appointment of Appellant is existed for which only the respondent authority is responsible and not the Appellant, therefore, the action of the Respondent-3 is not warranted under the law and rules and the impugned order is illegal and of no legal effect.
- XIX. That Appellant is permanent and confirmed employee of the department and performing his respective duties efficiently since his date of appointment during which he was provided all the benefits and privileges attached with his post including annual increments. Now the Appellant has crossed the upper age limit, supporting a family with his children who are getting education in various schools, thus, in such circumstances, the Respondent-3 has no legal justification to hold the appointment of Appellant as illegal. Therefore, the act and action of the Respondent-3 is tainted with mala fide intention, unlawful and not operative against the vested rights of Appellant.

XX. That it is humbly submitted that in view of the order dated 28.04.2014 of august Supreme Court of Pakistan in CP No. 551/2014, this honourable Tribunal instead of earlier order dated 15.01.2014 of the august Supreme Court in CP No. 2026/2013 and CP No. 2029/2013, is under obligation to "decide the appeal as mandated in law" as ordained by the later order dated 28.02.2014 of the Bench headed by the Honourable Chief Justice of

XXI. That Appellant craves to take / raise any other ground with permission of this Honourable Tribunal which is necessary for just decision of the Appeal in hand.

Prayer: Considering the above submissions, it is, therefore, most respectfully prayed that by way of acceptance of this Appeal, this honourable Court may please set aside the impugned order of the termination and reinstate the Appellant with all back benefits.

Or any other relief deemed appropriate by this Honourable Tribunal under the circumstances may please also be granted.



As there has been 44-Nos posts of Sub-Engineers lying vacant in the department, whereas, the public service commission has made recommendation of only 18-candidates for appointment as Sub-Engineers.
- 3. Moreover, the Govt. of Khyber Pakhtunkhwa vide Finance Department circular letter (Annexure-III) has regularized all the Civil Servants appointed to a service or post on or after 01st July 2001. In response to the said circular letter the respective audit offices have started deduction of G.P Fund from our paybills at prescribed rates regularly.
- In view of the above, it is very humbly prayed that the above unlawful/impugned order of Chief Engineer (South) PHE Department may very kindly be set-aside/withdrawn for which we shall be highly obliged.

- 2. That Service Book of the petitioner was maintained and every year his pay was increased by allowing him annual increments, CP fund was deducted and was allowed other monetary benefits, meaning thereby, that he was a regular employee of the department. (Copy as annex "B")
- 3. That on 17/01/2013, the Govt. of KPK, issued an Act wherein servants appointed to a service or post on or after 1st July 2001, shall be deemed to have been appointed on regular basis. (Copy as annex "C")

Competent Authority, the Appellants were appointed against various posts in the Cell, initially on contract basis for a period of one year, extendable subject to satisfactory performance in the Cell. On 6.10.2008, through an Office Order the Appellants were granted extension in their contracts for the next one year. In the year 2009, the Appellants' contract was again extended for another term of one year. On 26.7.2010, the Contractual term of the Appellants was further extended for one more year, in view of the Policy of the Government of KPK, Establishment and Administration Department (Regulation Wing). On 12.2.2011, the Cell was converted to the regular side of the budget and the Finance Department, Govt. of KPK agreed to create the existing posts on regular side. However, the Project Manager of the Cell, vide order dated 30.5.2011, ordered the termination of services of the Appellants with effect from 30.6.2011.

The Appellants invoked the constitutional jurisdiction of the learned Peshawar High Court, Peshawar, by fiting Writ Petition No.196/2011 against the order of their termination, mainly on the ground that many other employees working in different projects of the KPK have been regularized through different judgments of the Peshawar High Court and this Court. The learned Peshawar High Court dismissed the Writ Petition of the Appellants holding as under: -

> While coming to the case of the petitioners, it would, reflect that no doubt, they were contract employees and were also in the field on the above said cut of date but they wereproject employees, thus, were not entitled for regularization. of their services as explained above. Pakhtunkhwa Apriculture, Live Nock and Councious Department through its Secretary and others vs. Abraid Din and another (Civil Appeal No.687/2014 decided on 24,5,2014), by distinguishing the cases of Government of NWFP vs. Abdullah Khan (2011 SCMR 989) and Government of NWFP (now KPK) vs. Kalcem Shah (2011 SCMR 1004) has categorically held so. The concluding para of the said judgment would require reproduction, which reads as under:

"In view of the clear statutory provisions the respondents cannot seek regularization as they were admittedly project employees and thus have been expressly excluded from purview of the Regularization Act. The appeal is therefore allowed, the impugned judgment is set aside and writ petition filed by the respondents stands dismissed."

7. In view of the above, the petitioners cannot seek regularization being project employees, which have been expressly excluded from purview of the Regularization Act.

Thus, the instant Writ Petition being devoid of merit is hereby dismissed.

The Appellants filed Civil Petition for leave to Appeal.

No.1090 of 2015 in which leave was granted by this Court on 01.07.2015.

Hence this Appeal.

S. We have heard the learned Counsel for the Appellants and the learned Additional Advocate General, KPK. The only distinction between the case of the present Appellants and the case of the Respondents in Civil Appeals No.134-P of 2013 etc. is that the project in which the present Appellants were appointed was taken over by the KPK Government in the year 2011 whereas most of the projects in which the aforesaid Respondents were appointed, were regularized before the cut-off date provided in North West Frontier Province (now KPK) Employees (Regularization of Services)

Act, 2009: The present Appellants were appointed in the year 2007 on contract basis in the project and after completion of all the requisite codal formalities, the period of their contract appointments was extended from

Government. It appears that the Appellants were not allowed to continue after the change of hands of the project. Instead, the Government by cherry picking, had appointed different persons in place of the Appellants. The ease of the present Appellants is covered by the principles had down by this Court in the case of Civil Appeals No.134-P of 2013 etc. (Government of KPK through Secretary, Agriculture vs. Adnanullah and others), as the Appellants, were discriminated against and were also similarly placed project employees.

We, for the aforesaid reasons, allow this Appeal and set aside the impugned judgment. The Appellants shall be reinstated in service from the date of their termination and are also held entitled to the back benefits for the period they have worked with the project or the KPK Government. The service of the Appellants for the intervening period i.e. from the date of their termination till the date of their reinstatement shall be computed towards their pensionary benefits.

- 1. That the appellant has got not locus standi to file the instant appeal.
- 2. That no discrimination / injustice has been done to the appellant.
- 3. That the instant appeal is bad in the eye of law.
- 4. That the appellants has not come to the Tribunal with clean hands...
- 5. That re-view petition is pending before The Supreme Court of Pakistan, Islamabad.
- 6. That the appeal is bad for non-joinder &mis-joinder of unnecessary parties.

On Facts.

- 1. Incorrect. That the appellant was initially appointed on project post as Chowkidar in BPS-01 on contract basis till completion of project life i.e. 30/06/2014 under the ADP Scheme Titled" Provision for Population Welfare Program in Khyber Pakhtunkhwa (2011-14)". It is also pertinent to mention that during the period under reference, there was no other such project in / under in Population Welfare Department with nomenclature of posts as Chowkidar in BPS-01. Therefore name of the project was not mentioned in the offer of appointment.
- 2. Incorrect. As explained in para-1 above.
- Incorrect. The project in question was completed on 30/06/2014, the project posts were abolished and the employees were terminated. According to project policy of Govt. of Khyber Pakhtunkhwa on completion of scheme, the employees were to be terminated which is reproduced as under: "On completion of the projects the services of the project employees shall stand terminated. However, they shall be re-appointed on need basis, if the project is extended over any new phase of phases. In case the project posts are converted into regular budgetary posts, the posts shall be filled in according to the rules, prescribed for the post through Public Service Commission or The Departmental Selection Committee, as the case may be: Ex-Project employees shall have no right of adjustment against the regular posts. However, if eligible, they may also apply and compete for the post with other candidates. However keeping in view requirement of the Department, 560 posts were created on current side for applying to which the project employees had experience marks which were to be awarded to them:
- 4. Correct to the extent that after completion of the project the appellant along with other incumbents were terminated from their services as explained in para-3 above.

- 5. Incorrect. Verbatim based on distortion of facts. The actual position of the case is that after completion of the project the incumbents were terminated from their posts according to the project policy and no appointments made against these project posts. Therefore the appellant along with other filed a writ petition before the Honorable Peshawar High Court, Peshawar.
- 6. Correct to the extent that the Honorable Court allowed the subject writ petition on 26/06/2014 in the terms that the petitioners shall remain on the post subject to the fate of C.P No.344-P/2012 as identical proposition of facts and law is involved therein. And the services of the employees neither regularized by the Court no by the competent forum.

Correct to the extent that the CPLA No.496-P/2014 was dismissed but the Department is of the view that this case was not discussed in the Supreme Court of Pakistan as the case was clubbed with the case of Social Welfare Department, Water Management Department, Live Stock etc. in the case of Social Welfare Department, Water Management Department, Live Stock etc. the employees were continuously for the last 10 to 20 years while in the case of Population Welfare Department their services period during the project life was 3 months to 2 years & 2 months.

- 10. Correct. But a re-view petition No.312-P/2016 has been filed by this Department against the judgment dated:24/02/2016 of the larger bench of Supreme Court of Pakistan on the grounds that this case was not argued as it was clubbed with the cases of other Department having longer period of services. Which is still pending before the Supreme Court of Pakistan.
- 11. Correct to the extent that the appellant alongwith 560 incumbents of the project were reinstated against the sanctioned regular posts, with immediate effect, subject to the fate of re-view petition pending in the August Supreme Court of Pakistan. During the period under reference they have neither reported for nor did perform their duties.
- 12. Correct to the extent that a re-view petition is pending before the Apex Court and appropriate action will be taken in light of the decision of the Supreme Court of Pakistan
- 13. No comments.

On Grounds.

- A. Incorrect. The appellant along with other incumbents reinstated against the sanctioned regular posts, with immediate effect, subject to the fate of re-view petition pending the August Supreme Court of Pakistan.
- B. Correct to the extent that the employees entitled for the period they have worked with the project but in the instant case they have not worked with the project after 30/06/2014 till the implementation of the judgment. Anyhow the Department will wait till decision of re-view petition pending in the Supreme Court of Pakistan.
- C. As explained in para-7 of the grounds above.
- D. Incorrect. The Department is bound to act as per Law, Rules & Regulation.
- E. Incorrect. After the judgment dated:26/06/2014 of PHC, Peshawar this Department filed Civil Petition No.496/2014 in the Apex Court of Pakistan. Which was decided by the larger bench of Supreme Court of Pakistan where dismissed all the civil petitions filed by the Govt: of Khyber Pakhtunkhwa on 24/02/2016 and now the Govt. of Khyber Pakhtunkhwa filed a re-view petitions in the Apex Court of Pakistan against the decision referred above. Which is still-pending. The appellant alongwith other incumbents reinstated against the sanctioned regular posts, with immediate effect, subject to the fate of re-view petition pending in the August Supreme Court of Pakistan.



- F. Incorrect. Verbatim based on distortion of facts. As explained in Ground-E above.
- G. Incorrect. They have worked against the project post and the services of the employees neither regularized by the court nor by the competent forum hence nullifies the truthfulness of their statement.
- H. Incorrect. The appellant along with other incumbents have taken all the benefits for the period, they worked in the project as per project policy.
- I. The respondents may also be allowed to raise further grounds at the time of arguments.

Keeping in view the above, it is prayed that the instant appeal may kindly be dismissed in the Interest of merit as a re-view petition is still pending before the Supreme Court of Pakistan.

Para wise comments of Respondents No. 1, 2 and 3 are as under:

Preliminary Objections:-

- 1. That the appellant has got no cause of action.
- 2. That the appellant has been estopped by his own conduct to bring the instant appeal.
- 3. That the present appeal is not maintainable in its present form.
- 4. That the appellant has got no locus standi.
- 5. That the appellant has not come to the Tribunal with clean hands.
- 6. That the appeal is bad for non-joinder of necessary and mis-joinder of un-necessary parties.
- 7. That the appeal is barred by Law & limitation.
- 8. That this honourable Service Tribunal has got no jurisdiction to entertain the present appeal.

FACTS:-

Needs no comments it pertains to the domicile and educational qualification of appellant.

2.

Correct to the extent that appellant was appointed on contract basis while advertisement published on 22.4.2010 in "Daily Mashriq" (Annexure-I) it has clearly been mentioned that appointment of Sub Engineers will be made on adhoc basis for a period of one year or till the arrival of the selectees of Public Service Commission whichever is earlier. The petitioner was illegally appointed by the then Chief Engineer PHED on contract basis however in the appointment order in clause-12 it has clearly been mentioned that his services shall be terminated on arrival of candidates, recommended by the Public Service Commission. According to the appointment order the services of appellant were terminated when Public Service Commission made recommendation of the suitable persons. The petitioner was illegally appointed recommendations of the Public Service Commission as the appointment of Sub Engineer comes within the purview of Public Service Commission vide ESTA Code (Annexure-II), Public Service Commission Ordinance (Annexure-III) Recruitment Policy (Annexure-IV) and as per advice of Establishment Department dated 17.3.2014 (Annexure-V). Therefore the then Chief Engineer was not competent to appoint the appellant. This was the reason that the name of the appellant was never included in the seniority list of Sub Engineer and the same was never challenged by the appellant. (Copy of Seniority list as Annexure-VI). Furthermore, the Honorable Peshawar High Court in the writ Petition No.271-P of 2013 dated 2.10.2013 and honourable Supreme Court of Pakistan in Civil Petition No. 2026 & 2029 2013 dated 15.1.2014 declared the appointment of similar person as illegal and also directed action against such persons and the dealing hands vide judgment passed in similar cases. Copy of the judgments is enclosed as Annexure-VII & VIII.

Correct to the extent that appellant was appointed on contract basis and as explained in reply to Para 2 of the facts of appeal that it was provided in clear terms that the services of appellant will be terminated on receipt of candidates selected by the Public Service Commission. The appellant is responsible for not appearing in test and interview conducted by Public Service Commission for the post of Sub Engineer in 2011 and 2012 advertised on 7.4.2011 (Annexure-IX) Furthermore, the Honorable Supreme Court of Pakistan issued direction to the

department in connected cases that action shall be taken against the illegal appointments made in the department. In addition to action taken against the persons appointed illegally, also action was taken against those who made the illegal appointments Annexure-X.

Correct to the extent that appellant joined duty on contract basis. Furthermore, the appointment of Sub-Engineer BPS-11 falls within the purview of Public Service Commission and respondents have got no power of making direct appointment on regular basis against such posts according to ESTA Code, Public Service Commission Ordinance, Recruitment Policy, as per advice of Establishment Department and Local Govt Ordinance 2001 Part-C, Para 23 & 24 (Annexure-XI). The Honorable Supreme Court of Pakistan issued directions to the department that action shall be taken against such illegal appointment made in the department.

Incorrect, the Honorable Supreme Court of Pakistan has declared the appointment so made as illegal and also directed action against such persons and the dealing hands.

Correct to the extent that the appellants served the department more than the stipulated period of one year on contract basis. However, later on it came to light that the appointment of appellant and other was totally illegal, and the Honorable Supreme Court of Pakistan took adverse notice of such appointments and directed the respondents of taking action against concerned employees.

Correct to the extent that the services of appellant and others were terminated on receipt of candidates recommended by the Public Service Commission. Furthermore, the impugned action was taken in compliance of directions of the Honorable Supreme Court of Pakistan mentioned above.

Incorrect, there was no weight age in the departmental appeal of appellant.

Correct to the extent that the Writ Petition No.2146-P/2013, filed by appellant was dismissed in limine by the Honorable High Court (Annexure-XII)

Correct to the extent that the Civil Petition filed against the order of Honorable Court mentioned above was disposed of by the Honorable Supreme Court of Pakistan that the appellant shall approach proper forum.

Incorrect, there was no force in the departmental appeal of appellant.

Incorrect the appeal of appellant is badly time barred as the impugned order was 12. passed on 01.07.2013 and the service appeal was filed on 10.11.2014. Furthermore, ignorance of law is no excuse. The appeal of appellant is also not maintainable on the ground advanced in the appeal.

GROUNDS:

Incorrect, the impugned order is just, legal and have been passed in accordance I. with law and rules while following the directions of the Honorable Supreme Court of Pakistan.

Incorrect, the impugned order was passed by the appointing/competent authority.

III. Incorrect, appellant was appointed on contract basis by unlawful authority without recommendation of Public Service Commission. Later on it came to light that the appointment order was made illegally. Therefore, the illegal appointment order creates no right in favour of appellant.

> Incorrect, appellant has never been discriminated and the respondents have terminated all those who were appointed illegally against the posts falling in the jurisdiction of Public Service Commission in compliance with the directions of Honorable Supreme Court of Pakistan.

> Incorrect, the appointment of the appellant was illegally made against the post falling within the jurisdiction of Public Service Commission. Therefore, the impugned order was passed in accordance with law and rules.

Incorrect, the entire proceedings of appointment of appellant and others were against the rules and merit policy as made without the recommendation of the Public Service Commission as per ESTA Code, Public Service Commission Ordinance, Recruitment Policy and advice of Establishment Department. Furthermore, the Honorable Supreme Court of Pakistan directed action against the persons appointed through backdoors. Further if appellant was eligible he should have apply for the same through Public Service Commission.

Incorrect, as explained above the very appointments of appellant and others was found against the rules and merit policy. Furthermore, the Honorable Supreme Court of Pakistan took adverse notice of such illegal appointments and directed the respondents for action against such employees.

VIII.

Incorrect, If the post in PBS-1 to 15 were district cadre post then the Chief Engineer being a Provincial Head of PHE Department, had wrongly exercised his powers to make recruitment of appellant against district cadre post while recruitment of district cadre fall in the purview of District Coordination Officer(DCO) under the local Govt Ordinance 2001. But the posts of appellant and others were falling within the jurisdiction of Public Service Commission as per ESTA Code, Public Service Commission Ordinance, Recruitment Policy, and Local Govt Ordinance 2001 Part-C, Para 23 & 24 and the Honorable Supreme Court of Pakistan declared all such appointment orders void abinitio and issued directions to the respondents for taking action against the illegally appointed persons and dealing hands.

IX.

Incorrect, this Para of the ground is mere repetition of Para VIII of the ground of appeal.

X.

Incorrect, the appointment order of the appellant and others were found illegal therefore, the services of appellant and others were terminated.

XI.

Incorrect, the case of appellant was not identical to those whose services were regularized.

XII.

Incorrect, appellant was treated in accordance with law and rules.

XIII.

Incorrect, the appointment order of appellant was found illegal void ab-initio and according to law and rules void and illegal order creates no right of appellant.

XIV

Incorrect, the appointment order of appellant was found illegal void ab-initio and according to law and rules void and illegal order create no right of appellant.

XV.

Incorrect, the appointment of the appellant being illegal was terminated.

XVI.

Incorrect, the appellant was appointed illegally, and the Honorable Supreme Court of Pakistan also directed the respondent for taking action against the persons appointed illegally.

XVII.

Incorrect, order once passed does not become irrevocable and past and closed transaction if the order is illegal. No perpetual right can be gained on the basis of illegal order. Therefore, principle of locus poenitentiae is not invoked.

XVIII.

Incorrect, action has been taken against those who made the illegal appointments.

XIX.

Incorrect, appellant was appointed illegally which confer no right on appellant.

XX.

Incorrect, the impugned order was passed in compliance with directions of the Honorable Supreme Court of Pakistan passed in CP No.2026 & 2029. It is well settled principle of law that directions of the Honorable Supreme Court of Pakistan are binding irrespective of the fact that anyone was party to the litigation or not.

XXI.

The respondents also seek permission of the Honorable Tribunal of raising other grounds during hearing of the case.

It is therefore, requested that the appeal of the appellant may be dismissed with

The age relaxation in respect of posts other than posts mentioned above may be confined to 5 years only. The Competent Authority may allow relaxation upto 2 years whereas the S&GAD

*The age limit in respect of Govt. Servants who have completed at least four years service in the Government, on the closing day for submission of applications for the posts, shall be automatically relaxed by 10 years or a number of years an officer/official has actually served.

All the proposals for the grant of relaxation in upper age shall continue to be accompanied

- Full justification in support of the proposal; and (ii)
- A certificate to the effect that no eligible candidate within the prescribed age limits are/were available.
- An over age candidate shall be entitled to only one age concession whichever is beneficial to


- The Regional/Zonal quota if not filled will be carried forward till suitable candidates are available from the Region/Zone concerned. No. "Substitute" recruitment shall be made. Existing backlog, if any, in respect of any zone will not be carried forward and the Commission shall take a fresh start in respect of the posts under its purview. However, this condition will not be applicable in respect of posts which have already been advertised by the NWFP Public Service Commission.
- (g) The vacancies in all the Departments shall be advertised in leading newspapers on Similars. The advertisement in electronic media should be to the extent of drawing attention of all concerned to the relevant newspapers in which the vacancies are advertised.
- (h) Initial Recruitment to all the vacant posts shall be made on regular known periodic intervals in February and August each year after proper advertisement through electronic and national/regional media. After advertisement, a minimum period of 30 days should be allowed for receipt of applications. A waiting list of the eligible candidates shall be maintained for a

- 2% quota for disabled persons already fixed earlier shall stand and should be enforced strictly. However, 2% quota has also been fixed for female candidates in all the services which are filled up through initial recruitment. The Commission shall revise the Requisition Form for all such posts for specifying the women's quota in the available vacancies and the Administrative Department shall indicate the quota for women in the Requisition Form accordingly. The 2% quota shall be over and above the selection of women, if any, under general quota of merit etc. This quota shall, however, be restricted to those Departments where no separate female
- (k) For initial appointment to posts in BPS-17 and below in the Autonomous Bodies/ Corporations, the zonal allocation formula applicable for Provincial Services may be adopted. The method of recruitment shall also conform to sub-para (c) above.
- (1) The Provincial Government have already agreed that recruitment to the post of PTC in Education Department in various districts shall be made on constituency-wise basis. For this purpose, the existing districts have been divided into various zones. Each zone shall correspond to the area of constituency of the Provincial Assembly. However, recruitment to the posts shall, in each case, be 50% on merit in open competition on district basis and 50% on constituency basis.

W.P. 663-P of 2013 entitled "Muhammad Nisar Khan Vo. Govt." as common question of law and fact is involved in both these petitions.

According to the petitioners, they obtained Diploma of Associate Engineer in the year, 1995 in different technologis and since then are working in various Government Organizations/Projects. However, on 2.1.2011 they were appointed as Sub-Engineers in the respondent/department on ad-hor basis after due process. They were still in service when the respondents re-appointed them wide office order dated 8.1.4012. Prior to the appointment of petitioners, and Provincial Government promulgated Act No.XVI of 2009 vide which services of all

adhec/contract employees of the Province were regularized, however, the same benefit was not extended to the petitioners. Moreover, services some six_ Sub-Engineers have been regularized after appointment of the petitioners. The petitioners preferred application/appeal to the competent authority as well as to the Human Rights Cell of this court. In this respect, a letter dated 21.12.2013 was addressed to Human Rights Cell by the respondents, wherein, it was stated that Sub-Engineers. namely, Sher Hayet and Musetan Almiad, who were 38 and 39 years old, respectively and were debarred from future employment in any institution of the Provincial/Federal Government the reasons beyond their Nevertheless, handsome share of posts of Sub-Engineers were lying in the department and as a gesture of good will, the petitioners can be accommodated on regular basis. According to the petitioners, they waited for some time but did not receive any fruitful result from the respondents whereas their tenure is going to expire, hence necessitated the filing of instant constitutional politions.

Learned counsel for petitioners contends that the respondents have acted malafidely, by regularizing the services of other employees similarly placed, who were appointed after the politioners but the same benefit has been.

OFLE 2014

demed to the petitioners, thus, the treatment meted out to them is discriminatory, which is not tenable in law. He was of the view that the petitioners and their families will stand in long line of jobless people and would face hardship, if not regularized. He maintained that the act of respondents is in violation of judgments of superior courts rendered in various cases. Further contended that the petitioners have become for appointment in any institution of the Provincial/Federal Government, which fact is beyond their control and if not regularized will spoil their future. Also contended that there are vacant posts available against which the petitioners can be accommodated. According to the learned counsel, the impugned act of respondents is in violation of Article 25 (2) of the Constitution, therefore, they be directed to regularize the services of the petitioners like other similarly placed employees.

Learned AAG controverted the arguments from other side and straight away referred to the advertisement dated 23° April 2010 against which the petitioners were appointed as Sub-Engineers, wherem, it was clearly mentioned that the term of appointment would be on adhoc basis for one year or till the arrival of the recommendees of the Public Service Commission or whichever is earlier. He was of the view that as the period of one year has elapsed.

whichever is earlier. The positioners amongst others also participated in the test/interview. However, after duc process, they were appointed on 3rd January, 2010. On 28.2.2012, the petitioners were re-appointed as Sub-Engineers as a stop-gap arrangement.

Act No XVI of 2009 and can be pressed into service in case of those adhoc employees, who were holding the posts on 31st December, 2008 or till the commencement of the Act, which is not the case in hand, therefore, the plea taken is of no help to them. Moreover, the learned AAG produced a copy of the letter dated 1.7 2013 showing that those employees, who were retained by the respondent/department have also been terminated after the arrival of candidates from Public Service Commission.

Keeping in view the above discussion, we are of the considered opinion that the petitioners have failed to make out a case for interference in the constitutional jurisdiction of this court, hence this petition being without any legal embstance is hereby discussed.

THE NORTH-WEST FRONTIER PROVINCE DISTRICT GOVERNMENT RULES OF BUSINESS, 2001.

PART A GENERAL

- 1. Short title and commencement.— (1) These rules may be called the North-West Frontier Province District Governments Rules of Business, 2001.
 - (2) It shall come into force at once
- 2. Definitions.--- (1) In these rules, unless the context other-wise requires,-
 - 1. "body corporate" means a body having perpetual succession and a common seal, with power to sue and be sued:
 - 2. "budget" means an official statement of income and expenditure for a financial year;
 - 3. "business" includes all work done by a local government:
 - 4. "component" means the offices mentioned in column 2 of Schedule I to the Ordinance;

- 4. Organization of Offices.—— (1) The Organization of various offices shall be the same as provided in the Ordinance or, where the Ordinance has not so provided, as determined by Government.
- (2) The Executive District Officer shall, by means of standing orders, distribute the work of the office among the officers subordinate to him.
- (3) The cases enumerated in Schedule II shall be submitted to the Zilla Nazim before issuance of orders:
- (4) Reports on any of the matters specified in Schedule III shall be submitted to the Zilla Nazini for his information;
- 5. Secretariat of District Government.—(1) There shall be a secretariat of the District Government headed by the District Coordination Officer and comprising of the decentralized departments or groups of departments as shown in the First Schedule to the Ordinance.
- (2) Each decentralized group of departments shall be headed by an Executive District Officer appointed or nominated by the Government for the purpose.
- (3) Each Executive Officer shall be responsible to Zilla Nazim through the District Coordination Officer and shall channelize his correspondence through him.
- 6. Deputation of civil servants and power of District Coordination Officers.—

 (1) The civil servants posted in the dencetralized departments shall continue to be civil servants for all intents and purposes of the relevant civil servants laws and the rules framed thereunder with the modification that-
- (a) all civil servants in BPS-16 to BPS-20 shall be appointed for Government or the Federal Government as the case may be, and posted for decentralized Departments from time to time.



(b) the District Coordination Officer shall have the powers of the appointing authority in respect the officers/officials in BPS-1 to BPS-15:

Provided that no vacancies are to be filled in by way of direct recruitment or transfers and the officers/officials of the surplus pool are to be absorbed/adjusted against the vacancies:

Provided further that even after the said period ban on recruitment shall continue till it is lifted by Government in the Finance Department.

 - (2) All orders shall be passed in writing, where a verbal order is given, it should be reduced to writing at the earliest opportunity by the officer receiving it.

(3) If any doubt or dispute arises as to the Department to which a case properly pertains, the matter shall be referred to the District Coordination Officer for decision.

- (4) Detailed instructions for the disposal of business in the District administration shall be issued by the District Coordination Officer.
- (5) If any order happens to contravene a law, rule or policy, it shall be the duty of the next below officer to point out this to the authority passing the order.
 - (6) While submitting a case for the orders of the Zilla Nazim, it shall be the duty of the Executive District Officer/District Coordination Officer to suggest a definite line of action.
 - 8. Office administration and record.— The manual of instructions for Provincial Civil Secretariat issued by the Chief Secretary of Government from time to time shall, mutates mutandis, be applicable to the secretariat of the District Government and the District Coordination Officer shall have the powers to issue instructions in addition there to and not in derogator of the instructions already issued.
 - 9. Official language.-- (1) The official language of the District Government for official correspondence with the Provincial Government and Federal department shall be English and efforts shall be made to conduct the correspondence with the people representative and public in general in Urdu.
 - (2) All notices affecting the citizens shall be published at least in two Urdu dailies having vide circulation in the local area.
 - 10. Zilla Nazim.—(1) A Zilla Nazim shall assume the charge of his office from the date on which he takes upon himself the oath of such office.

(2) Government shall notify the dates of assumption of the offices of the Zilla Nazim in the Official Gazette.

- 11. District Coordination Department. (1) An officer appointed as District Coordination Officer shall on assuming charges, as such, exercise such powers and perform such functions and duties as are mentioned in section 28.
 - District Police Officer .- (1) The District Police Officer shall keep the Zilla Nazim generally informed of all matters affecting public tranquillity. He shall, in particular, submit report through the Zilla Nazim, to Provincial Government of all cases likely to have major political repercussions.
 - The District Superintendent of Police shall Coordinate with the Zilla Nazim for the maintenance of law and order in the district and shall comply with all of his orders.

PART-B

DEPARTMENTAL PROCEDURE

- 13. Enforcement and interpretation of rules.--- (1) The Executive District Officer shall be responsible for the careful observance of these rules in his Department/Component of offices assigned to him and if any doubt or dispute arises as to the interpretation of these rules, it shall be referred to Government through District Coordination Officer, whose decision shall be final. The District Coordination Officer shall obtain the orders of the Zilla Nazim, where necessary.
 - Instructions ancillary to these rules shall, wherever considered necessary, be issued by the District Coordination Officer:

Public Service Commission.— The advice of the Public Service Commission shall ordinarily be accepted by the District Government(s) in all matters where it is obligatory to consult the Commission under any rules or regulations for the time being in force. If it is proposed not to accept the advice of the Commission, it shall be submitted to the Chairman, Local Government Commission, who may give an opportunity to the Public Service Commission of further justifying its recommendation before a final decision is taken.
- Selection Board,— (1) District Government may constitute one or more Selection Boards and specify the appointments and promotions to posts, other than those to be made on the advice of the Public Service Commission, to be made on the advice of such Selection Boards, under the District Service Rules, when framed.

- 31. Channels of communication.--- (1) Correspondence with the Provincial Government shall be conducted directly by the Departments in respect of arbitrats allocated to them, and it shall ordinarily by addressed to the clead of the Attached Department concerned.
- (2) All correspondence between District Governments and the Secretary of the Provincial Government Departments shall be conducted through the Heads of the Attached Department concerned.
- (3) All inter District correspondence shall be conducted by the Executive District Officer of the Departments through the District Coordination Officer.

He alleged that after promulgation of the Khyber Pakhtunkhwa Civil Servants (Amendment) Act, 2013 his services require to be automatically regularized, which has not been done, thus, the treatment meted out to him is against the spirit of the said Act.

4. Comments were asked from respondent No.1, which have been received, wherein, it is stated that the petitioner was appointed as Sub-Engineer on adhoc basis for a period of one year or till the arrival of



recommendees of the Public Service Commission whichever is earlier. It is further stated that the Act relied upon by the petitioner is not applicable to contract employees.

Sub-Engineer on adhoc basis (BPS-11) for a period of one year or till the arrival of the recommendees of Public Service Commission whichever is earlier. The said terms and conditions were mentioned in the offer of appointment issued to the petitioner. Moreover, the petitioner is taking shelter behind the Act of 2013, however, the same is not applicable in the matter of contract employees. Moreover, the impugned action was taken by the respondents after arrival of recommendees of the Public Service Commission.

6. This court while dealing with similar plea raised by the petitioners in W.P.271-P of 2013 with interim relief has declined to interfere in the impugned action of respondents vide judgment dated 2.10.2013. The said view was affirmed by the august Supreme Court

while deciding Civil Petitions bearing No.2026 & 2029 of 2013 vide order dated 15.1.2014.

7. Thus, in the circumstances particularly the judgment of this court as well as the order of apex court in similar situation, we are firm in our view that the respondents have no committed no illegality while taking the impugned action of dispensing with the services of the petitioner, hence no case for issuance of a writ is made out.

Resultantly, instant petition being devoid of legal merits is dismissed in limine.

Respectfully Sheweth,

The Appellant humbly submits as under:

Preliminary Objections:

- 1. Misconceived, frivolous, thus, denied. The Appellant has been dismissed from service without any lawful cause and authority.
- Denied. Instead it is the Respondents who have estopped by their own conduct as the Appellant has been appointed and kept remained in service for almost three years.
- 3. Denied. Appeal is in proper form, thus, has been admitted for full hearing.

- 4. Denied for being misconceived. The Appellant locus standi infatal.
- 5. Frivolous, thus, denied. As the allegations in the Show Cause Notice with all due respect pointing towards the short comings of the Respondents.
- 6. Misconceived, thus, denied. All necessary parties have been arrayed as necessary party.
- 7. The Appeal is in accordance with law and within time, hence, the objection is not maintainable.
- 8. Misconceived, thus, denied. Under the law and the orders of the Honourable High Court and apex Supreme Court of Pakistan per se suggest that no Court or Forum other than this honourable Service Tribunal is to entertain this Appeal.

On the Facts:

- Para-1. Having offered no comments by the Respondents; though need not any <u>re-joinder</u>, however, it is re iterated that the qualifications and credentials of the Appellant have been admitted by the Respondents which depicts that Appellant is highly skilled and qualified.
- Para-2. Admitted to the extent that Appellant was appointed against duly advertised post to be appointed within a period of one year or till the arrival of selectees of Public Service Commission whichever is earlier. Within the stipulated period of one year none of the selectee was arrived. Thus, beyond that stipulated period of Appellant job was continued for about 2^{1/2} years. Thus, by all implications otherwise duly qualified the condition arrival of selectees of Public Service Commission has

opped by

become void. The Respondent Department is estopped by its own conduct/omission to do away with the services of the Appellant who is now been regularized after completion of probation period. Now the condition of the agreement regarding one year employment stand automatically revoked after regularization of the services of the appellant by the Department.

The comments drafted as highly misconceived. In fact the Respondents; concealed the facts narrated from Para-2 where in the Appellant without any resistance has gone through all the due process and procedure through which Appellant has been asked for by the Department; that include advertisement, test & interview, the recommendation of the DSC and terms and conditions of appointments, the period of employments and satisfactory service performance, the length of service of almost 3 years. It may also be noted that on the post of Appellant no selectee has been appointed as yet. The seniority list attached with the Parawise comments is invalid and distorted as well as hardly relevant but substantiate the fact that the Appellant were being discriminated. As regards inclusion of the name of the appellant in the seniority list. The same list is updated by the department from time to time as and when convenient to them. The names of the newly appointed incumbents however are included in list after completion of their probation period. As stated earlier that Peshawar High Court or Supreme Court of Pakistan has never declared the appointment of the Appellant as illegal, as he was appointed after fulfilling all the codal formalities such advertisement, test & interview, selection by Departmental Selection Committee etc.

Para-3. The Respondents already admitted the fact that the Appellant was appointed on Contract basis; the rest of the para is highly misconceived, thus, denied. The Appellant was not required to appear in test & interview conducted by the PSC for the post of Sub-Engineer in 2012 as the appellate was appointed on contract by the Competent Authority against the properly advertised posts after test & interview conducted by Departmental Selection Committee and he had completed his probation period of 2 years and had become a regular employee of the department as per departmental practice. Where an appointment is made on properly advertised post after test and interview, how illegality can be attributed to such an appointment?

Para-4. Incorrect. Para-4 of the reply of the Respondents is self-contradictory—on one hand the respondents are admitting the status of the Appellant as a contract employee on the other hand they are pleading that the Chief Engineer has no authority to make appointments on regular basis. As the appointment of the appellate was not made on regular basis but on Contract basis but after Appellant's service of about 3 years with completion of his probation period the appellate became a regular employee of the department. As stated earlier that the Supreme Court of Pakistan has never issued any direction with regard to the termination of the Appellant.

Para-5. As stated in the earlier Para that the Honourable Supreme Court of Pakistan has never issued any direction with regard to the termination of the Appellant.



- Para-6. As the Appellant was appointed after observing all the codal formalities i.e. Advertisement, test, and interview etc. How such an appointment can be termed as an illegal appointment?
- **Para-7.** As stated in Para-2 & 3 above.
- Para-8 Not correct the Appeal lodged by the Appellant was having proper weightage which has been admitted by the honourable Service Tribunal for regular hearing.
- Para-9 Denied for being misconceived.
- Para-10. Denied for being misconceived.
- Para-11. As per Para-8
- Para-12. Incorrect and highly misconceived. It is an established practice of the Honourable Tribunal; that the honourable Service Tribunal generally condones the limitation period for the Appellant who approach the wrong forums in Service Cases.

Grounds:

- I. Incorrect. The Order of termination passed by the Respondent-3 is illegal and unlawful. As the required legal formalities such as Show Cause Notice, Charge Sheet, Formation of Enquiry etc., have not been fulfilled which is a clear violation of Civil Servant Act, 1973. The Supreme Court of Pakistan has never directed the respondents to terminate to the Appellant.
- II. The department has admitted that the Chief Engineer as Competent Authority. Since the

6

appointment of the Appellant as Sub Engineer was issued by the same authority then how it can be taken as illegal appointment. The department has adopted double standard policy in the case of the appellant and respondents are estopped by their own conduct.

- III. Misconceived, thus, denied. The appellant was appointed as Sub Engineer by the Chief Engineer (who according to the Respondents Ground-II of the reply is a Competent Authority) after due process through Departmental Selection Committee and has completed his probation period and his termination was illegal and there was no formality of enquiry and charge sheet as required under the rules were fulfilled.
- IV. The Respondent failed to defy the fact that the way of the appointment of the Appellant was infact a standard practice of the Department and there are still more than 250 employees working in the Department who have been appointed in the same manner and "standard practice" through which the Appellant was appointed, thus, the Appellant has been proceeded in insolation, therefore, the impugned Order of termination of the Appellant is not only hit by Article 25 of the Constitution but principle of Estopple is also attached.

Copy of the list/Detail of 80 Employees appointed in 2009 by the same procedure and is still working at Annexure-II

Note: Further it is worth to add that 30 Employees appointed in 2013 with many others from time to time through the same procedure and are still working.

- V. As per Ground-III.
- VI. As already discussed above.
- VII. Already replied above.
- VIII. Incorrect. The department was devolved in the Year 2001 i.e. after promulgation of Local Government Ordinance but since the District Governments were not so strengthened to handle the matters of appointments and to keep their service record of seniority for the purpose of their promotion transfer and posting. Therefore the Chief Engineer South in the capacity of Head of the Department to run affairs of the Department in smooth manner made appointments in the better public interest. Also the Supreme Court of Pakistan has never ordered for the termination of the Appellant.
- IX. No Comments.
- X. Incorrect. The appellant was appointed as Sub-Engineer on Contract basis by the Competent Authority after observing all the codal formalities. He has completed about 2-1/2 years' service and completed his probation period satisfactorily, thus, he had become a regular employee of the department and his termination without proper enquiry and fulfillment of formalities such Show Cause, charge sheet and opportunity of personal

hearing etc. is illegal unlawful and based on mala fide.

- XI. **Incorrect.** After continue service of about 2^{1/2} Years and completion of probation period the civil servant became a regular employee of the department.
- XII. Incorrect. As no law or rules were applied in the process of termination of the Appellant and no enquiry has been conducted. No Show Cause Notice, charge sheet or opportunity of personal hearing has been provided. Hence the order is illegal and unlawful.
- XIII. Since the appointment order of the Appellant as Sub Engineer was issued by the Competent Authority after observing all the codal formalities i.e. advertisement, test & interview etc. by Departmental Selection Committee, hence, cannot be termed as illegal as the same shall not be challenged by any quarter.
- XIV. It is just a duplication of Para-XIII above. Hence, need no reply.
- XV. The appointment order was issued by the Competent Authority and was legal. In fact the termination of the appellant was illegal as it was issued without any enquiry or charge sheet and personal hearing etc. which are the pre requisite in disputing cases against the employees.

- XVI. The Appellant was legally appointed by the Competent Authority and the honourable Supreme Court of Pakistan has never directed the respected Department to terminate the Appellant.
- XVII. Not correct. As the Appellant was appointed after observing all the codal requirements and due process of law, hence, the appointment order of the Appellant cannot and shall not be termed as illegal. After his appointment the Appellant had completed his probation period and had become a regular employee of the department. An employee cannot be terminated without Show Cause Notice, Charge Sheet and giving opportunity of personal hearing etc. as no one shall be condemned unheard.
- XVIII. Incorrect. No action has been taken against any officer and official of the department because the Department observed all codal formalities and rightly appointed the Appellant as per Law and Rules.
- XIX. As per Ground-XVIII of the rejoinder.
- XX. Admitted with reverence up to the extent that Orders of the august Court are binding on the Litigants irrespective of the fact that anyone was party to the litigation or not. But vehemently denied the rest of the para as the appointment of the Appellant was legal and he was appointed after observing all the codal formalities i.e. advertisement, test & interview etc. by the Departmental Selection Committee.

XXI. Needs no rejoinder.

Prayer: Considering the above submissions, it is, therefore, most respectfully prayed that by way of acceptance of this Appeal, this honourable Court may please set aside the impugned Order of the termination and reinstate the Appellant with all back benefits.

Or any other relief deemed appropriate by this Honourable Tribunal under the circumstances may please also be granted.
