APPEAL U/S 4 OF SERVICE TRIBUNAL ACT, 1974
AGAINST OFFICE NOTIFICATION DATED 19-04-2023
OF R. NO. 01, WHEREBY APPELLANT WAS DROPPED
FROM PROMOTION TO THE RANK OF OFFICIATING
INSPECTOR B-16 FOR NO LEGAL REASON:

Respectfully Sheweth;

- 1. That appellant was initially appointed as Constable on 21-02-1982 and on satisfactory performances of his official duties he was promoted to the rank of Head Constable. The said process of promotion was in-vouge when he was further promoted to the rank of ASI in the year 2006, followed by subsequent promotion to the rank of Sub-Inspector in the year 2014.
- That further promotion to the rank of Officiating Inspector was required in the department and then on 07-01-2023, R. No. 01 wrote letter to all Heads of the Police Department, CCPO and Regional Police Officers in KP to remit ACRs up to the year 2021 to Secret Branch CPO within 10 days of those Sub-Inspectors who are on List "F". Matter be considered on top priority followed by subsequent letter dated 21-02-2023 and 10-04-2023 of the same nature. (Copies as annex "A")

- That on 18-04-2023, seniority list of Sub-Inspectors on list "F" of KP Police was issued wherein name of appellant was figured at S. No. 16 by showing his name on list "F" with effect from 03-12-2020. (Copy as annex "B")
- 4. That appellant had submitted ACRs for the period concerned with the Record Keeper of R. No. 02 for remission of the same to R. No. 01 for the purpose well within time.
- 5. That DPC held Meeting for the purpose and almost all 154 incumbents were promoted to the rank of Officiating Inspectors B-16 vide Notification dated 19-04-2023 by R. No. 01. (Copy as annex "C")
- 6. That on 07-06-2023, appellant submitted after receipt of the impugned Notification on 10-05-2023, appellant submitted representation before R. No. 01 for promotion to the rank of Officiating Inspector which was processed in the office concerned for necessary action. (Copy as annex "D")
- 7. That appellant submitted application to the authority on 07-06-2023 for explaining the position of the case by dropping his name from promotion and met with R. No. 02 who fully explained the position of none remitting of his documents to the quarter concerned. (Copy as annex "E")
- 8. That on 23-06-2023, R. No. 02 wrote letter to R. No. 01 that appellant has submitted the required documents well before the Record Keeper of R. No. 02 but he was not remitted the same to the concerned quarter, so enquiry was initiated against the defaulter with further request that appellant is entitled for promotion as Officiating Inspector with effect from 19-04-2023 being at the verge of retirement for his no fault. (Copy as annex "F")
- 9. That on 04-07-2023, his request for promotion to the rank of Officiating Inspector was not honored. (Copy as annex "G")

Hence this appeals, inter alia, on the following grounds:

GROUNDS:

That admittedly appellant was in the range of promotion and was fully fit and suitable for the purpose, having neat and clean service record at his credit.

b. That appellant had submitted the documents well before the Clerk concerned but it was not known as to why he remitted documents of others to the office of R. No. 01, leaving aside the documents of appellant.

c. That in letter dated 23-06-2023, R. No. 02 has clarified the position of appellant before R. No. 01 that his ACRs were not remitted to the quarter concerned by the Record Keeper and departmental proceedings were initiated against him as appellant was left from promotion due to fault of clerk concerned, otherwise appellant was entitled for promotion to the said post since 19-04-2023, being one at the verge of retirement.

d. That order of rejection is not based on legal footing as it was incumbent upon the authority to direct the concerned quarter to issue order of promotion of appellant to the said post.

e. That the impugned order as per available record is not per the mandate of law rather based on malafide.

It is, therefore, most humbly prayed that on acceptance of the appeal order dated 04-07-2023 of R. No. 01 be set aside and appellant be promoted to the rank of Officiating Inspector B-16 since 19-04-2023 with all consequential relief as he will be retired at the end of the year.
